Regular Meeting ----- February 13, 1992

The meeting was called to order by the Chairman, ATTENDANCE  
D. L. Taylor at 7:00 A.M. at the District office. Other  
Board members present were Bobbie Domenick, Gary Wilson,  
John Groo and Karl Tangren.

Special Service District members present were D.L.  
Taylor, George White, Dan Holyoak and Gary Wilson.

Others present were Gary Holyoak, Dale Pierson and  
Marsha Modine.

After calling for additions or corrections to the MINUTES  
minutes of the meeting of January 23, 1992, the Chair  
declared the minutes approved as circulated to the Board.

Marsha handed out Gary Holyoak's letter regarding GARY HOLYOAK  
his overuse of 1991 Irrigation Water. After discussion and IRRIGATION  
Gary's explanation, George moved that the Board waive Gary's WATER OVERUSE  
1991 irrigation overuse fee. Dan seconded. MOTION CARRIED.  
Bobbie Domenick moved that Dale read the shared meters once  
a month during the irrigation season. Gary seconded. MO-  
TION CARRIED.

The Board reviewed the Irrigation Sales report. IRRIGATION  
They questioned those users moving water to properties other WATER SALES  
than that for which it was purchased. It was suggested that REPORT  
if this becomes a problem, the Board would have to set  
policy concerning movement of water.

D. L. brought up the proposed policy which would PROPOSED  
allow the trading of Moab Irrigation Co. shares to the Dis- POLICY FOR  
trict for irrigation water. D. L. suggested we either write M.I.C. STOCK  
the Div of Water Rights again or ask for an appointment - TRADE  
since they have failed to answer our letter. Dale said that  
Larry Anderson with Div of Water Resources feels that we did  
the project based upon the ability to create more water and  
that there is a discrepancy between Div of Water Rights and  
Div of Water Resources figures which needs to be cleared up.  
All our figures have been based upon the figures that we got  
from the Div of Water Resources. D.L. suggested writing  
Larry a letter and reminding him of the letter to Div of  
Water Rights (we sent him a copy). Dan asked why we  
couldn't store water for Moab Irrigation Co. shareholders in  
the reservoir. This was discussed and the decision was made  
to wait until the Div of Water Rights answers our letter con-  
cerning existing water rights. Dale was asked to write to  
Larry Anderson asking for his opinion. The question is  
whether the water that we divert in the winter is part of  
the total AF diversion right. We do not pay Bob Byrnes for


our winter water diversion <sup>our percentage of\*</sup> his wages are based on water M.I.C. STOCK  
diverted from 3/15 to 11/1. The acre foot amount is never TRADE POLICY -  
identified in the decree. (Cont.)


Bobbie moved checks be approved. George seconded. CHECK APPROVAL  
MOTION CARRIED.

The meeting adjourned at 8:12 a.m.
