

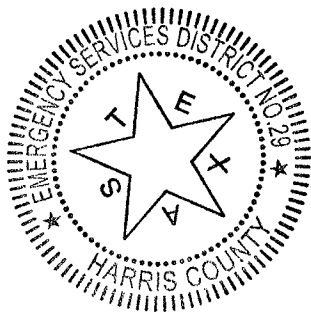
**MEETING NOTICE**

The District will consider and act upon the following matters:

1. Call meeting to order.
2. To receive public comment.
3. To receive a report from Brad Dill of BD Realty and take any action related thereto.
4. Review, discuss and take action with respect to any MMG pay applications or change orders approved by ALJ Lindsey.
5. To receive a report from Martinez Architects and take any action related thereto.
6. To review, discuss and take action on selection of contractor for Station 12 construction.
7. To review, discuss and take action on selection of a lender to finance the Station 12 construction.
8. To approve the Minutes of prior meeting(s).
9. To receive a report from the District Bookkeeper and to review and take action on the Treasurer's Report.
10. To review, discuss and take action to pay and/or ratify District bills and authorize fund transfers required for operations.
11. To review and discuss progress in move of District financial accounts to Icon Bank and take any necessary action related thereto.
12. To review, discuss and take action regarding investing the District's funds into an Investment Pool as permitted by the Texas Public Funds Investment Act.
13. To review and take action on 2018 appraisal valuations and commencement of adoption of 2018 tax rate, including review of 2018 effective tax rate calculations, and scheduling any necessary public hearings to adopt District 2018 tax rate.
14. To review, discuss and take action on the proposed District 2019 budget.
15. To review, discuss and take action to propose the District's 2018 tax rate.
16. To review and take action on amendments to the District's 2018 budget.
17. Review, discuss and take action regarding entering into an agreement with Global Traffic Technologies, LLC for the provision, installation and acquisition of traffic preemption equipment.
18. Review, discuss and take action regarding a proposal from Fountainhead MUD for the installation of a generator at the MUD's water tower which houses the Comm 8 Tactical Radio.
19. To receive, discuss and take action on the Fire Operations Report.

20. To review, discuss and take action on submittals by the Department of thirty (30) day advance request(s) for purchase of items necessary for District operations.
21. To review and take action on approval of expenses related to upcoming training classes, course materials, equipment and related expenditures to be incurred by the District.
22. Administrative Reports and Committee updates.
  - a) To review and take action on any report(s) from the District committees concerning and take action as necessary.
  - b) To review, discuss and take action on any proposed Policy, Procedures and Operating Guidelines that require modification.
