RULES

1. Eligibility

The participating business must meet at least one of the following requirements:

- Be an active member of the **Cooperativa de Ahorro y Crédito Rafael Carrión, Jr.**
- Non-member participants must be active employees of **Popular or Evertec**.

2. Department of Health Certificate

All businesses must present a **valid Certificate issued by the Puerto Rico Department of Health**.

- The certificate must be valid and visibly displayed throughout the duration of the event.
- Failure to present this document will result in disqualification of the participating business.
- The **Cooperativa de Ahorro y Crédito Rafael Carrión, Jr.** reserves the right to verify this certification before or during **Coop Fest**.

3. Valid Merchant Registration

All participating businesses must have a **valid Merchant Registration**, in accordance with the provisions of the **Puerto Rico Department of Treasury**.

- This document must be submitted as part of the registration process.
- Failure to comply with this requirement will prevent participation in **Coop Fest**.

4. Donation of Raffle Gift

Since **no participation fee will be charged**, each participating business must commit to donating **at least one gift** to be raffled among **Coop Fest** attendees.

- The gift must be representative of the business or of reasonable value.
- To enhance the perception of **Coop Fest** and the participating business, it is suggested that the gift be one of the following options:
 - A **signature product** of the business.
 - A **gift certificate** with a reasonable expiration date.
 - A **promotional package** representative of the brand.

- Participants must strictly comply with the schedules established for setup, operation, and breakdown during the event.
- At no time may the business remain unattended during event hours.

8. Deadline for Submission of Documents

All required documents must be submitted **on or before Friday, January 16, 2026, at 5:00 p.m.**

- Documents submitted after the deadline will not be accepted.

The rules may be modified by the Education Committee of the **Cooperativa de Ahorro y Crédito Rafael Carrión, Jr.**, according to the needs and dynamics of the event.
