





### COVID-19 Cases & Vaccination Report

As of April 30, 2021, there have been 8,253 confirmed cases of COVID-19 in Lenawee County. We currently have 743 active confirmed cases of COVID-19 in Lenawee County; 14 of those cases are hospitalized. There have been 145 confirmed and 5 probable COVID deaths reported to date in Lenawee County.

Vaccination clinics continue at the Merchant's Building at the Lenawee County Fairgrounds, and through other providers throughout Lenawee. For a full list of providers, <u>click</u> <u>here</u>. Thus far, 32.9% of Lenawee County residents 16 years of age or older have been completely vaccinated against COVID-19.
