ORDINANCE

AN ORDINANCE REQUIRING PERSONS TO OBTAIN PERMITS FROM THE TOWN BEFORE MOVING HOUSES AND MOBILE HOMES UPON THE STREETS AND HIGHWAYS LOCATED IN THE TOWN; ESTABLISHING CONDITIONS FOR THE ISSUANCE OF SUCH PERMITS; AND ESTABLISHING RULES FOR THE EXERCISE OF SUCH PERMITS.

BE IT ORDAINED by the Mayor and Board of Aldermen of the Town of Sorrento, State of Louisiana:

SECTION 1. PERMIT REQUIRED

THAT no person may move a house or mobile home upon any non-state maintained street or highway located in the Town of Sorrento, hereafter referred to as the "Town", without first obtaining a permit from the Town. Permits shall be issued only to moving contractors duly licensed by the State of Louisiana.

SECTION 2. CONDITIONS FOR ISSUANCE OF PERMIT

THAT no permit shall be issued until the following conditions are satisfied:

- a) A fee of \$25.00 has been paid;
- b) The mover has submitted to the Town a liability bond or certificate of insurance in the minimum sum of \$10,000.00 which would cover damages caused to the Town or to any other person whose property is damaged in the course of moving such house or mobile home:
- c) The mover has obtained all special permits that state law requires him to obtain and has furnished to the Town copies of such permits along with copies of any bond that mover has furnished in connection with such special permits to protect the state and its political subdivisions from liability and damage resulting from the use of such permits;
- d) The applicant has acknowledged the following:
 - 1) That he has received a copy of this ordinance;
 - 2) That he has made a preliminary determination that the house or mobile home can be maintained on the roadways while being moved and can be moved in compliance with all local and state traffic laws and regulations;
 - 3) That he assumes responsibility for any damages, whether to the Town or any other person, arising out of the exercise of such permit:
 - 4) That he releases the Town and its agents and employees from any and all liability for loss or damage which it may incur arising out of the exercise of this permit and, further, that he shall indemnify and hold harmless the Town and its agents and employees from any claim against the Town for damage arising out of the exercise of this permit.

e) The applicant has designated the date and an estimate of the time of day the move will take place; the route to be taken and the address to and from which the house or mobile home is being moved; and a description of the property being moved.

SECTION 3. DURATION OF PERMIT

That a permit shall be good for one day only as specified in the permit.

SECTION 4. POLICE NOTIFICATION

THAT no person may exercise his privilege under a permit until he has notified the Sorrento Police Department and a police officer of the Town is available and present to monitor the movement of the house or mobile home while traveling the streets and highways in the Town.

SECTION 5. COMPLIANCE WITH TRAFFIC LAWS

THAT the operator of any vehicle carrying or moving a house or mobile home on any street or highway in the Town must maintain the vehicle on the roadway and must not allow it to go upon the shoulder, through a roadside ditch, or the like, and such operator must at all times comply with all local and state traffic laws and ordinances.

SECTION 6. PENALTIES FOR VIOLATION

THAT a person violating this ordinance shall be subject to a fine not to exceed \$175.00 or imprisonment not to exceed thirty (30) days or both. A subsequent violation shall be punished by a fine of not more than \$500.00 or by imprisonment for not more than ninety (90) days, or both.

SECTION 7. EFFECTIVE DATE OF ORDINANCE

That this ordinance become effective on the fifteenth day after the meeting in which the ordinance was adopted.

BE IT FURTHER ORDAINED by the Mayor and Board of Aldermen of the Town of Sorrento, Louisiana, that the provisions of this ordinance shall become and made a part of the code of ordinances of the Town of Sorrento, Louisiana, and the sections of this ordinance may be re-numbered to accomplish this intention.
