



# Rescue Inc. 2019 Subaru Crosstrek Raffle

## Rules & Regulations

Purchase tickets for \$20 per ticket from Rescue Inc. and you'll be entered in a drawing to win a 2019 Subaru Crosstrek. Entries into Rescue Inc.'s raffle are \$20 each, for every 5 tickets bought you get one free (six tickets for every \$100 spent at one time). A maximum of 3500 tickets will be sold. Odds of winning are based on the number of raffle ticket entries purchased, if Rescue Inc sells all 3500 tickets, the odds of winning are 1 in 3500. Void where prohibited. Sweepstakes begins at 12:01 am on May 22, 2019 and ends on October 17, 2019 at time of drawing or when all tickets are sold. Online entry deadline is October 17, 2019 at noon. All times referenced for this raffle are eastern daylight savings time.

### HOW TO ENTER:

There are three ways to enter.

- 1) Purchase tickets in person from any Rescue Inc. volunteer, at any location where Rescue Inc. volunteers are selling tickets, or from one of several retail locations in the Brattleboro and West Townshend region where tickets are available.
- 2) Call Rescue Inc. at 802-257-7679. Provide your entry information (name, zip code, telephone, email) over the phone along with credit card information to charge the entry fee. If you reach a voice mailbox, leave your name and contact information and someone will contact you to complete the purchase.
- 3) Go to [www.rescueinc.org](http://www.rescueinc.org) to the Rescue Raffle page and complete the online entry form online and pay entry fee with your credit card. In accordance with Applicable Law, Rescue Inc. will not mail raffle tickets to ticket holders. Ticket numbers will be sent by email and hard copies of official tickets are available upon request.

**ELIGIBILITY:** Open only to persons who are 18 years of age or older as of May 22, 2019. Tickets will be distributed and ticket numbers will be assigned in the order that payment is received. All raffle ticket sales are final. Current management staff of Rescue Inc. and Rescue Inc. Board of Trustee members are ineligible, but their immediate family members ARE eligible. Rescue Inc. is not responsible for late, lost, damaged, incomplete, misdirected, illegible or mutilated entries. Winner must show proof of a valid driver's license in order to claim the prize. Winner must be able to meet with Brattleboro Subaru in person to claim prize. Rescue Inc. reserves the right to revoke any prize or remove an entry if the entrant does not meet any or all of the eligibility requirements, or if the entry or winning tickets has been damaged or altered. All federal, state, and local laws and regulations apply. The raffle is void where prohibited or restricted by law.

**SELECTION AND NOTIFICATION OF WINNERS:** Winners will be selected in a random drawing on Thursday Oct 17, 2019 that will take place at The Marina Restaurant, Brattleboro VT and results will thereafter be posted on Rescue Inc.'s website. Once submitted, entries become the sole property of Rescue Inc. and will not be returned. Winner will be notified by phone and/or email. If potential winner cannot be reached after 10 days from first notification attempt, or if an entrant is found to be ineligible, or prize notification is returned as undeliverable, such prize will be forfeited and an alternate winner selected by random drawing. Rescue Inc. is not responsible for problems occurring within the postal system or the internet that may affect winner's receipt of the winning notice.

**GRAND PRIZE:** 2019 Subaru Crosstrek, 5 door hatchback, color Ice Silver Metallic, approx. value \$25,000

Upon verification of the winner, Rescue Inc. will notify Brattleboro Subaru of Brattleboro VT, to finalize the transfer of the vehicle to the winner. The terms of the car dealership's and manufacturer's automobile transfer documentation will govern issues of liability relating to the prize after acceptance of the automobile by the winner. Winner is solely responsible for any and all state or local license, title, registration, fees associated with the vehicle, as well as insurance (proof of which must be shown prior to delivery), and pickup or delivery costs at the dealership.
