

The Men's Saturday Golf group continues to grow with the following additions, Terry Buckley and Bob Evans from the Fairways, Ron Tlougan from the Eagle Ridge condos, Larry Cushing and Terry Lauder from the Pines and Dale Livingston. We will continue to have gold and white flight golfers with some individual play, but will emphasize team play while alternating between several games and combining flights. Safety And Security Tip

Flying This Holiday Season?

Are you flying this holiday season? If so, have you considered that your airline ticket could be used by thieves to steal your identity? Unfortunately, the paper boarding passes of old contain a lot of personal information such as your name, address, flight information, credit card number, and more. Some of this information is evident and some is secreted in the bar code found on your ticket.

So, how do you protect your information from falling into the wrong hands? You can start by following these

very simple safety tips:

Use a paperless boarding pass. The best practice is to switch from the paper boarding pass to paperless. This way, TSA and the ticket agent can scan the ticket via your smartphone and you can delete the pass once you have reached your destination.

Shred, Shred. Do not toss your boarding pass in the trash or leave it on the plane once you are done flying. Instead use a crosscut shredder to properly dispose of the pass, along with any other documents you no longer need that contain your personal information. Some hotels provide shredders in their business office, but be sure it is a "crosscut" before using.

Privacy is good. Taking a trip is exciting, but not everything

needs to be posted on social media. Refrain from announcing your travel plans to the whole world if you want to avoid letting thieves know your home is vacant. Wait to share your travel pictures once you return home.





News From South Trail Fire And Rescue

your own life.

What would you do if a major disaster left you, your family and your neighbors on your own to take care of yourselves for an extended period of time?

What if someone was trapped or injured by the disaster, what then? The natural reaction for most people in a disaster is to help others. According to sociologist Dr. Lee Clarke, the true first responders in a disaster are family members, neighbors, or even a stranger on the street. CERT (Community Emergency Response Team) training prepares you to help your family and your community in case of a disaster, without endangering

The first CERT, formed in Los Angeles in 1985, was modeled after teams of volunteers in Japan who were trained to assist in their neighborhoods after earthquakes. Southwest Florida is unlikely to experience a major earthquake; however, we can experience natural and manmade disasters such as hurricanes, wildfires, floods, tornadoes, hazardous materials incidents, or acts of terrorism. CERT programs have been established throughout the United States, Florida, and Lee County. South Trail Fire and Rescue's CERT program has trained over 150 people since 2003. CERT teams are established in neighborhoods throughout the South Trail Fire District, and include the Legends, Olde Hickory, Jamaica Bay, Seven Lakes, Pine Manor, Gateway, and Page Park neighborhoods.

The next South Trail CERT training is scheduled for Jan. 31 through Feb. 2, 8:30 a.m. to 4:30 p.m. each day. Participants will be trained on disaster preparedness, fire safety, disaster medical operations, light search and rescue, team organization, disaster psychology, and terrorism. During the final session, the class will exercise their new knowledge and skills in a mock disaster drill.

CERT volunteers have many opportunities to give back to their community. After Hurricanes Charley and Wilma, South Trail CERT volunteers assessed the needs of residents in their neighborhoods, helped establish a neighborhood relief center, and educated their neighbors on the safe use of generators. CERT volunteers also help with public education programs and projects throughout the year, such as the annual South Trail smoke alarm giveaway.

The CERT training class is free of charge to district residents, but space is limited. The training will be held at the South Trail Fire Station 62, 13500 Sophomore Lane. For more information or to enroll, call 936-5281 or go to www. southtrailfire.org.

Catch The Action

January Fishing

January will bring us some of the coldest days of the year on the water in Southwest Florida. Just how cold determines how and where to fish. This month the primary inshore targets are sea trout, sheepsheads, redfish and pompano. If you enjoy watching wildlife it's a great time, seems like everywhere you look something is happening.

Over cooler days we will look to target protected areas like canals, creeks, and deep water on the leeward side of islands as fish seek shelter, it's also a good way to comfortably fish a chilly north wind. Often fish may be found ganged up in a deep hole or along a shoreline. The coldest of days will yield some of the best sheepheads fishing of the year; they thrive and aggressively feed during adverse conditions. If the weather is mild for several days the fish may be more widespread out on the shallower flats,



bars, and structures.

Shrimp are the top baits over the winter months. Shrimp are user-friendly, readily available, and everything eats them. If it's cold think slow and low, meaning fish the bait at or near the bottom, either stationary or with a slow retrieve. One of the best ways to cover bottom and catch fish on a cold day is with a live shrimp/jig head combination. Take a live shrimp, bite or pinch off the tail and thread the shrimp tail first on a small jig head just like you would a soft plastic shrimp or shad tail. Now you have the best of both worlds, live bait that you can cover ground with, like an artificial. This combination will entice everything from big snook to pompano.

With milder weather the same combination also works but likely the fish are spread out over shallower depths so a change of technique is often necessary. Look for fish holding in areas that is a short distance from the deeper protected areas, they often hold in areas where they can quickly get back to shelter when the next front arrives. Fish these areas with shrimp, rigged the same method described above with a little quicker retrieve, or suspended under a popping or rattling cork. Sometimes if you are looking for trout, redfish, or maybe pompano it's all about covering as much area as possible, scented soft baits like Gulp shrimp are another great option.

On the good days with calm seas, making a short run to nearshore reefs is a good option for action and a variety of fish. There are a number of artificial reefs well within sight of land and the numbers or locations are available to the public. You never know from day to day what a reef may hold but chances are good at hooking sheepheads, snapper, mackerel, grouper, grunts, sharks, and possibly tripletail or cobia, plus many other species.

No doubt there will be some cold days, but also plenty of sunny warm days. Like the weather fishing can change quickly this month, to be successful you need to monitor the conditions and adapt your fishing strategy accordingly. Good luck!

We encourage proceeding with last month's recommendation for the Violations Review Board to issue a letter with the appropriate fine if necessary. Violation Notices were issued on July 25, August 24, September 19, and October 17. Most of the items have been done with the exception of several disheveled gardens, lack of borders and no mulch. This has been unsightly for the neighborhood.

Surface Water Management Committee: Christine Leslie

I spoke to Lee County on Nov. 16, 2016 regarding the eight pipes we have asked them to clean. They indicated it would be about a month which is about what I have factored based on previous projects. This should happen prior to Christmas.

The County also confirmed that the pipe on Aeries Way is a 34 by 53 elliptical pipe that is 232 feet which is about what the golf course had on their proposal. However, based on further conversations with a few industry experts on our drainage situation, they said it would NOT be recommended to clear the sediment from the drainage system until all the lakes and retention ponds have been dredged and set back to the proper elevations.

Removing the sediment from the drainage system before setting the lakes and retention ponds to their proper elevation would cause the sediment to fill in the Aeries pipe over the next 1 or 2 rainy seasons.

Based on this information, I am trying to get the drainage plan from the golf course

that they submitted to SWFL Water Management. I sent a follow up message to the golf course to find this out and will reach out to SWFL Water Management, if I do not hear back from them. I am specifically interested in the following.

- 1. Which lakes and retention ponds are not at proper elevations and will be dredged out? The area by Twin Eagle and Bald Eagle is completely bermed up?
 - 2. Which lake-to-lake pipes are blocked and will be vectored out?
- 3. What is the drainage plan for the fairways that are looking to be built up?

Florida and the color fades over time.

Lee County Yard Waste Regulations

- Do not place out for pickup more than 24 hours early
- Yard waste must be containerized (50 pounds or less), or securely tied into bundles not heavier than 50 pounds and no longer than 6 feet in length.
- Up to 50 pounds of unbundled palm fronds may be placed at the curb. Any excess palm fronds must be tied into bundles, each weighing 50 pounds or less.
 - When using plastic bags, make sure that the contents can be easily identified by the refuse truck driver (leave a twig or small branch sticking out).
- Call 239-337-0800 for a cost estimate for large-scale yard waste disposal projects when containerizing or bundling is difficult.
