ORDINANCE NO. <u>16-9</u> VILLAGE OF STRASBURG, SHELBY COUNTY, ILLINOIS

AN ORDINANCE PROHIBITING THE KEEPING OF CERTAIN ANIMALS WITHIN THE CORPORATE LIMITS OF THE VILLAGE OF STRASBURG, SHELBY COUNTY, ILLINOIS.

WHEREAS, the Village of Strasburg has determined that keeping of sheep, goats, cattle, swine, ponies, horses, chickens, ducks, turkeys, geese, rabbits, or other livestock, within the corporate limits of the Village of Strasburg, Shelby County, Illinois constitutes a public nuisance and is an immediate danger to the public health and safety of the inhabitants of the Village of Strasburg, Shelby County, Illinois; and,

WHEREAS, the Village of Strasburg is authorized, pursuant to 65 ILCS 5/11-1-1 and 65 ILCS 5/11-5-6 and 65 ILCS 5/11-20-9, to enact the instant Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF STRASBURG, SHELBY COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. TITLE: This ordinance shall be known and may be cited as the Village of Strasburg Farm Animal Ordinance.

- **SECTION 2. DEFINITIONS:** For the purpose of this ordinance, whenever the following words or terms are used herein they shall be the meaning ascribed to them in this section.
- (A) <u>Person</u>: Any individual, partnership, co-partnership, firm, company, corporation, association, joint stock company, trust, estate, political subdivision, state agency, or other legal entity, or their legal representative, agent or assigns.
- SECTION 3. PROHIBITION OF FARM ANIMALS: That no person, firm or corporation shall keep any sheep, goats, cattle, swine, ponies, horses, chickens, ducks, turkeys, geese, rabbits, or other livestock in any pen, lot, building, or otherwise, within the corporate limits of the Village of Strasburg, Shelby County, Illinois, except as herein provided.
- SECTION 4. RUNNING AT LARGE: That no person, firm or corporation shall permit any sheep, goats, cattle, swine, ponies, horses, chickens, ducks, turkeys, geese, rabbits, or other livestock to run at large in the Village of Strasburg, Shelby County, Illinois.

SECTION 5. EXCEPTIONS:

- (A) Nothing in this Ordinance shall be construed to prevent the presence of any sheep, goats, cattle, swine, ponies, horses, chickens, ducks, turkeys, geese, rabbits, or other livestock within the corporate limits of the Village of Strasburg, Shelby County, Illinois while such animals are being transported or being shown at a fair, or livestock exposition lawfully conducted within the corporate limits of the Village of Strasburg, and this Ordinance shall not be construed to apply to any such animals when such animals are being used as a means of conveyance or transportation or for the purpose of plowing, cultivating or tilling any lot or parcel of ground located within the corporate limits of the Village of Strasburg, Shelby County, Illinois.
- (B) This Ordinance shall not apply to areas of the Village that are zoned agricultural in nature nor shall this Ordinance apply to livestock brought in to the Village for the purpose of slaughter within 48 hours.
- (C) Nothing in this Ordinance shall be construed as an Ex post facto prohibition.
- (D) Nothing in this Ordinance shall be construed to prohibit the presence of rabbits, chickens, or other poultry for the purpose of raising the same as a 4-H project, or a pet, to a maximum of six (6) animals total.
- (E) Nothing in this Ordinance shall prohibit the raising of chickens (maximum of 6 head) for the purpose of raising the same for the personal consumption of eggs.
- SECTION 6. PENALTY: Any person violating or aiding or abetting the violation of any provision of this ordinance is guilty of a petty offense and shall be fined not less than ONE HUNDRED DOLLARS (\$100.00), nor more than FIVE HUNDRED DOLLARS (\$500.00) for each offense; and a separate offense shall be deemed committed on each day during or on which violation occurs or continues. Violators shall be liable for any and all attorney fees incurred by the Village of Strasburg, Illinois, relating to the enforcement of this Ordinance due to a violation on their part.
- SECTION 7. SEVERABILITY: If any section, subsection, sentence, clause, phrase or portion of the ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed to be a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions hereof.
- **SECTION 8. REPEAL**: All ordinances or portions of ordinances in conflict with the provisions of this ordinance are hereby repealed.
- **SECTION 9. COURT COSTS:** The Village is entitled to recover court costs from any non-prevailing party for any and all actions brought to enforce any fine or penalty or contesting any fine or penalty brought pursuant to this Ordinance.

SECTION 10. PUBLICATION: For the reasons appearing in this ordinance, this ordinance is declared to be necessary and urgent for the immediate preservation of the public peace, health and safety, and shall therefore take effect and be in full force from and after its passage and approval as provided by law.
