### From the Secretary's Desk

It already seems like the year is flying by in a blur. The South Atlantic Conference and Spring Booster meeting have come and gone and now it is time for Spring District Meetings.

#### **State Convention Delegates**

At your spring district meetings you will be electing delegates to represent your district at the State Convention. Inside this issue is a form to nominate yourself or someone else to be a delegate from your district. This form is for State Convention Delegates Only. These need to be in to the District Secretary at least 10 days prior to your district meeting. The contact information for each District Secretary and meeting dates are in this bulletin. Life events happen that sometimes prevent you from attending a meeting, as well as being scheduled to work on your route the day of the meeting and knowing that you cannot make the meeting. Mailing in your nomination gives you the opportunity to make sure your name is on the ballot for consideration. You should receive a confirmation postcard from your district secretary and if you don't you need to contact them to make sure your nomination was received. Nominations will also be accepted from the floor at the meeting.

#### **Member Restrictions**

In the GARLCA Constitution Article III Section 2. Restrictions OR NRLCA Constitution Article III Section 3. Inasmuch as it is an unfair labor practice under the Labor Management Relations Act (LMRA) for any employer (including persons acting in that capacity) to dominate or interfere with the administration of any labor organization, it follows that employers, while they may be members, may not be candidates for office or serve as officers.

Members are prohibited from participation in the Association while serving in managerial or supervisory positions, such as Officer-in-Charge (OIC), Acting Supervisor (204-B) or Postmaster Relief (PMR) or acting in any capacity normally performed by a manager. Members who accept managerial positions shall be deemed to have resigned from all

elected and appointed positions within the Association and shall be prohibited from holding any elected or appointed union positions for a period of one year from the last day served in that capacity.

Article III, Section 3 of the National Constitution is clear that members serving or acting in a managerial or supervisory position are prohibited from participation in the Association while serving in these positions. Pay Code reports are checked for codes other than rural duties.

#### **Closed Meetings**

The following constitutes the NRLCA Board policy on closed meetings.

- If a Union meeting is going to be closed, for members only, the meeting(s) announcement should state it is a members only meeting and will be closed.
- When a Union meeting is closed, there should be someone at the door checking membership and they should offer any non-member wishing to attend to join the Union at the door.
- When a Union meeting is closed, for Union members only, no one but Union members should be in attendance, thus all nonmember spouses, friends of rural carriers (managers) should be asked to leave when the closed meeting begins.
- ◆ If the Union has invited non-Union speakers that are considered "benefits" (i.e. Insurance (both RCBP and NGIC), National Office personnel (Legislative, OWCP, Insurance, Membership) of being a member to a closed meeting these invitees do not violate the closed meeting rule.
- When a Union meeting is closed for any special called meeting (i.e. mail count training, etc.) no one but Union members may attend. If a manager (Rural Analyst, Postmaster, Supervisor, etc.) is invited to attend the meeting, then the meeting cannot be closed and is open for any nonmember to attend.
- When a Union meeting is closed, a member of the NRLCA who is acting in a man-

agement capacity as defined in the above referenced Constitution article or Article IX, Section 10 are prohibited from participating or attending in the meeting. The NRLCA defines acting in a management capacity as currently serving in a managerial position. If the member is intermittently working as a manager (204-B) but worked in that capacity on the day of the meeting he/she cannot attend the meeting that evening. However if he/she worked as a rural carrier that day they can attend and participate, but cannot hold any Union position. If the member has had a Form 50 cut showing them as being compensated as if in a managerial position then he/she cannot participate or attend.

#### **National Delegate**

The National Delegate nomination form is in the February through May issue of the <u>National Rural Letter Carrier Magazine</u>. Nomination forms must be completed in full as specified in the instructions. Do not send in with address labels stuck to the form, for the person making the nomination or for the nominee, or "same" written for nominee on a self nomination. Unsigned and not completely filled out forms will be returned. If received not completed as stated in the National Magazine they will be returned.

The nominations must be in by **May 20, 2015.** Mail early so as not to miss the deadline. Due to the changes in processing and the closing of facilities some of the nominations already received have taken from 2-6 days to reach me from only 50 miles away. Mail early to be sure your nomination arrives in a timely manner.

Membership for Georgia on March 1st was: 4,843.

In Georgia each District organization has at least two meetings each year- a business meeting in the spring, when officers and convention delegates are elected and another meeting is held in the fall. One or more State Officers attend these meetings and gladly discuss matters or problems of interest to all There is also a District Representative in attendance. This is where the Constitutions and Resolutions are born. The Association year runs from July 1 through June 30. Statewide meetings are held in the spring and fall, and an annual State Convention is usually held the end of June or the first of July. At these conventions, state officers are elected and mail-in ballots for delegates to the National Convention are counted. Georgia sends approximately 50 delegates to the National Convention each August. The National Convention is held in a different state each year.

You owe it to yourself to become more involved and to affiliate with the only organization authorized as your "exclusive bargaining agent." If you not a member, we invite you to join today!

### **Retirement** — Your Contribution

Spring is almost here. We all know what a busy time of the year it will be. We'll be thinking of planting flowers, our gardens, attending spring business meetings and planning summer vacations. We need to add at least one other item to plan for. Retirement, regardless if you are under the CSRS or FERS retirement system, it is never too soon.

I want to address one portion of retirement that you don't want to overlook; that is contributing to the Thrift Savings Plan (TSP). All employees can contribute with one major difference. CSRS employees can not receive the matching funds from the USPS. Our employer will match up to 5% of your pay, but you only

get the full amount if you contribute at least 5% of your salary each pay period too. Remember, your contributions to the TSP are pretax and deducted from your pay before you see it. How easy is that? You don't need to make a conscious effort to build for your retirement. You cannot afford to miss out on thousands of dollars in free money over time. If you are not saving at least 5% of your salary each pay period, I strongly encourage you to do so. You get to choose from a variety of funds within the TSP. These funds range from very conservative to more aggressive, depending on your level of risk taking (what you're comfortable with). Additionally you can choose to make ROTH contri-

butions rather than the traditional contributions. Remember, with a ROTH contribution your taxes are taken out up front, rather than when you withdraw funds from your TSP account.

### **House Resolution 12**

In my last article, I mentioned HR12. The intentions of this resolution by the House of Representatives, is to express to the United States Postal Service that all measures possible should be taken to maintain and continue six-day mail delivery and service to the American People.

As of this date, there are 84 Democrat and 16 Republican co-sponsors to the resolution. Republican Sam Graves from Missouri is the original author of the resolution.

The resolution has been referred to the House Committee on Oversight and Government Reform. The resolution can not be sent to the President until it becomes a Bill.

The House of Representatives and the Senate will be in recess much of March, April, and May. The House will be in recess March  $9^{th}$  - 13th, March  $30^{th}$  - April  $10^{th}$ , May  $4^{th}$  -  $11^{th}$  and May 22 -  $29^{th}$ . The Senate will be in recess March  $30^{th}$  - April  $10^{th}$  and May  $25^{th}$  -  $29^{th}$ .

During these recesses our Representatives and Senators will be visiting their districts and states. If you hear of one of their meetings, this

would be a great time to meet them and discuss our thoughts and concerns.

As reported in my last article, the Senate Homeland Security and Governmental Affairs Committee will be overseeing postal legislation and issues. Chairman Ron Johnson (R-WI) at this time has decided to keep these issues at the full committee instead of delegating the issues to a sub-committee.

In December, we reported that a group of senators issued a letter to then Postmaster General Donahoe urging the United Postal Service to postpone their plan to close 82 more processing and distribution plants and to consolidate more routes.

However the United States Postal Service and it's management did not respond to the letter. As of January 10th, 2015 the USPS began to implement their plans to consolidate and close these plants. Even in one of his speeches before retiring Postmaster General

Donahoe stated this was still needed and stood by his belief that 5 Day Delivery was still an item

to look at in postal reform.

The plant in Athens is still on schedule to be closed in April. This closing as well as the other closings will have an impact on the communities they serve as well as the employees and their families.

I hope you were able to attend the Spring Booster Meeting at High Falls State Park and we were able to fellowship and gain more information from our National union leaders and state officers. Hope to see you at the upcoming District Meetings,
