



CORONA VIRUS



One of the Association's primary concerns is the health and safety of all Riverwalk owners and residents, and staff. For the duration of the Coronavirus (COVID19) pandemic we ask that all non-essential in-person visits to our office be curtailed. Instead, when possible please communicate by phone or email. Also consider making payments directly from your bank or by ACH rather than handing checks over or dropping them off at the onsite office.

Please limit interactions with our maintenance staff especially during this time. This also applies to our Internet Tech service technician.

Effective as of March 16th, 2020, Riverwalk will be suspending the loaning or borrowing of sport court equipment and HOA owned ladders, tools, and other property. This policy change will be in effect for the duration of the Coronavirus.

The onsite office will remain open regular hours 8:30 to 5:30 Mon, Tues, Thurs, and Friday and 8:30 to 6pm Wednesdays. Phone: 561-747-6209

Tennis Court Revision. Green privacy netting will be going up soon and a covered chilled water fountain will be put in.

Palm and Hardwood Tree Trimming: All palms and hardwoods in Riverwalk were trimmed in March 2020. If you have a specific issue with an Association tree please write or call the office.

Riverwalk Perimeter Fencing: New wood border fencing will be installed from the playground over to the area next to building 6262. This will complete replacement of all old and worn fence areas along the south perimeter of Riverwalk property.

Building Painting: 2020 Painting Project is scheduled to begin in May.



Did You Know?



COMMERCIAL VEHICLES NOT ALLOWED

Vehicles marked with visible phone numbers, website addresses, logos, or other business-related information, including wraps that cover the windows or side panels, are not allowed to park overnight in the community. All markings must be covered or removed.

Commercial vehicles such as step-vans, vans with the rear seats removed, box trucks, ones marked as taxis or transport services, trucks or vans with ladder racks, modified reinforced flatbeds, and other similar vehicles are not allowed overnight.

Storing a commercial vehicle on the property may result in violation notices and fines.

Pets Need to Be Registered With the Office



Any pets not listed on a resident's initial application paperwork need to be registered with the office. This helps to protect the Association and avoid having a potentially dangerous unknown animal roaming the community. Pit Bulls, Rottweilers, Chow Chows, Doberman Pinschers, Great Danes, Boxers, German Shepherds and Alaskan Malamutes are banned breeds. Some residents have claimed these breeds as "service dogs" to by-pass our rules. Proper documentation is required for any pet classified as a "service dog" or "emotional support" dog.



Please report to the office any loose dogs or dogs not being picked up after. Also do the same if you notice any sprinkler heads missing or water leaks, large trash piles, or abandoned vehicles. You will most likely be asked to take and submit photos. In the unlikely event of suspicious persons, animal attacks, or dangerous potentially illegal activity please let the office know and if appropriate call the police or 911. The office staff and personnel do what they can but cannot be everywhere and are typically not here on evenings or weekends. We will address all situations appropriately and information reported will be kept strictly confidential.
