ORDINANCE NO. 83-17

AN ORDINANCE PROVIDING FOR THE ANNUAL TAX LEVY FOR THE
FISCAL YEAR COMMENCING ON MAY 1, 1983 AND ENDING ON APRIL 30, 1984

WHEREAS, the President and Board of Trustees of the Village of Chapin, Morgan County, Illinois, did, on the 1st day of June A. D., 1983, pass and adopt the Appropriation Ordinance for said Village for the fiscal year commencing on the 1st day of May, 1983, and ending on April 30, 1984; that said Ordinance appropriated the total sum of Four Hundred Sixty Nine Thousand Five Hundred Twenty Dollars (\$469,520) for corporate purposes and that said Ordinance was duly published on the 6th day of June, A. D., 1983.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chapin, Morgan County, Illinois:

SECTION 1: That there be and hereby is levied upon all the taxable property within the corporate limits of the Village of Chapin, Morgan County, Illinois, subject to taxation for the year 1983, the total sum of \$65,700 for the following specific purposes mentioned in said Appropriation Ordinance in the respective sums as follows, to-wit:




