Search Firm Proposals - Action Item

The Board Attorney Claudia Castro summarized the remaining proposals, noting that HYA and BWP offered comprehensive services at approximately \$18,000. HYA's proposal included a base fee of \$12,000 with additional advertising and background check charges, while BWP's fee was all-inclusive. Additionally, BWP recently conducted a treasurer search for a nearby township, making it more familiar with regional treasurer candidates and potentially expediting the hiring process.

Several Trustees raised concerns about time constraints, noting that the deadline to appoint a new treasurer is July 1, 2025. Some members expressed interest in pausing the search and instead pursuing an interim solution with Paul Belisario of Proviso Township, who had offered to serve in an interim or transitional capacity. Board Attorney Claudia Castro advised that an interim agreement would still need to comply with statutory requirements, ensuring a treasurer was in place by July 1, 2025. It was agreed that President Kirksey would reach out to Proviso Township.
