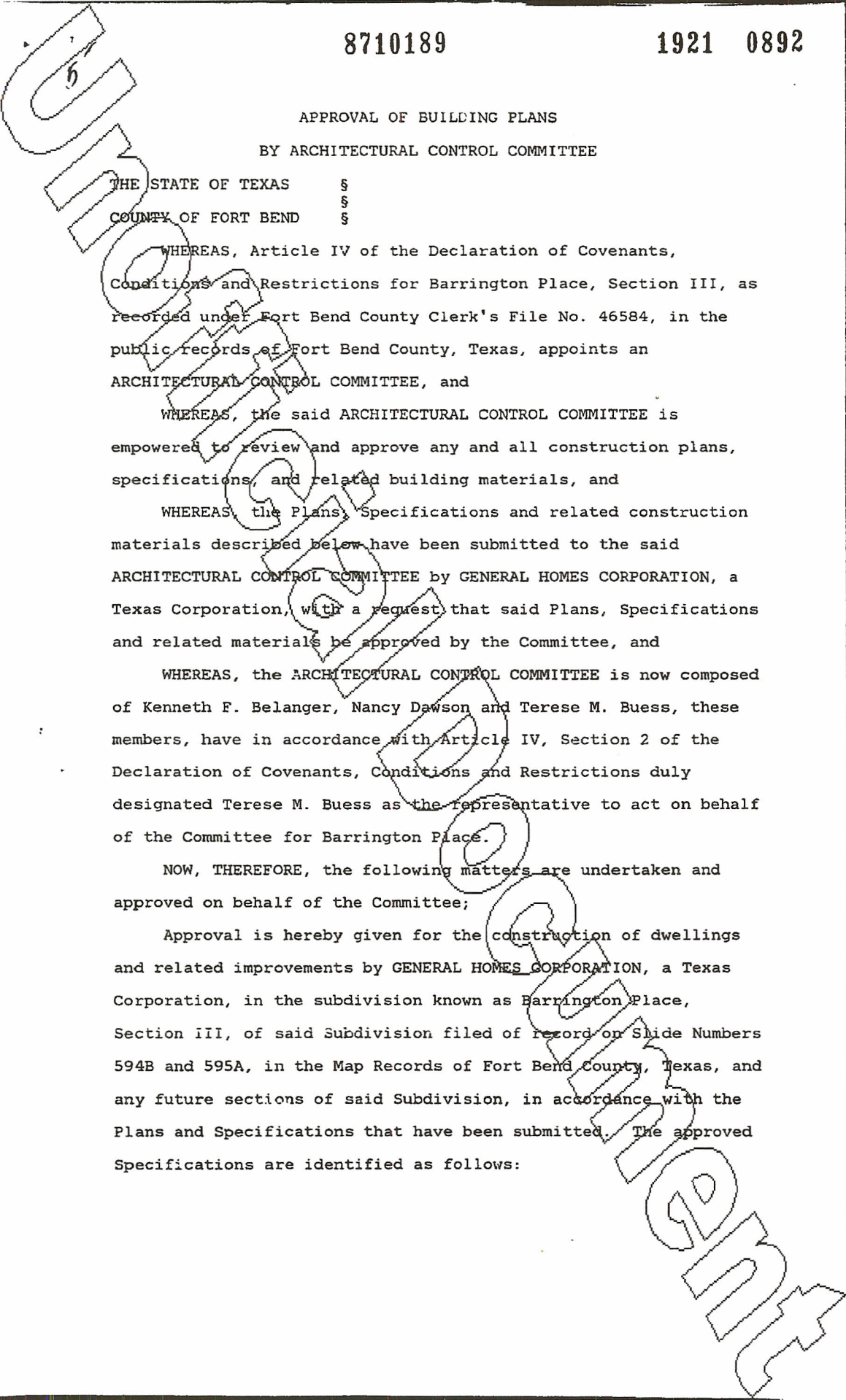
WHEREAS, the said ARCHITECTURAL CONTROL COMMITTEE is empowered to review and approve any and all construction plans, specifications, and related building materials, and
