## **More Important News**

## Message From Warren County

This is an important safety message from the Warren County Health Department regarding COVID-19. We encourage the citizens of Warren County to practice the following steps to minimize your exposure and to help slow the spread of the COVID-19 virus in our county: Stay home as much as possible. Avoid social gatherings of 10 or more. Avoid any nonessential travel. Practice social distancing of 6 feet or more when at the grocery store. If you are sick, stay home and contact your healthcare provider. If you are in need of resources please call the Warren County Health Department at 636-456-7474.

## For Persons With Covid-19 Under Home Isolation:

Persons with COVID-19 who have symptoms and were directed to care for themselves at home may discontinue home isolation under the following conditions: At least 3 days (72 hours) have passed since recovery defined as resolution of fever without the use of fever-reducing medications and improvement in respiratory symptoms (e.g., cough, shortness of breath);and, At least 7 days have passed since symptoms first appeared. This recommendation will prevent most, but may not prevent all instances of secondary spread. The risk of transmission after recovery, is likely very substantially less than that during illness.

## Activity of the Board of Trustees




