

ALL REGISTRATION ENDS ON FEBRUARY 14, 2025

Coaches will choose teams beginning on February 18, 2025. Anyone who is interested in coaching baseball or softball is urged to attend. A head coach must be 21 years of age or older and the assistant coach must be 18 years of age or older and must have a background check.

Your child's coach should be in contact with you on or before February 25, 2025. Please give the coaches a chance to contact you before you attempt to contact them.

If you have not heard from your child's coach on or before March 1, 2025 please contact Tommy Catoe at 843-680-2289.



I will support coaches and officials working with my child, in order to encourage a positive and enjoyable experience for all.

I will demand a sports environment for my child that is free of drugs, tobacco and alcohol, and will refrain from their use at all youth sports events.

I will remember that the game is for youth - not for adults.

I will do my very best to make youth sports fun for my child.

I will ask my child to treat other players, coaches, fans and officials with respect regardless of race, sex, creed or ability.

I promise to help my child enjoy the youth sports experience by doing whatever I can, such as being a respectable fan, assisting with the coaching or providing transportation.

I will require that my child's coach be trained in the responsibilities of being a youth sport coach and that the coach upholds the Coaches' Code of Ethics
