NUMBER OF POSITIONS AVAILABLE: One (1)

<u>DUTIES</u>: Under the direction of the Director or Deputy Director in the Division of Highway Traffic Safety (HTS), Department of Law and Public Safety, will serve as a high-level policy and planning professional, helping to develop a comprehensive highway safety plan for the state, and provide assistance and advice to local officials to advance projects. The position will also assist in coordinating community outreach programs with program staff and managing HTS strategic planning while monitoring the progress of highway safety projects. Additionally, will participate in developing instructional and educational materials to enhance and improve highway safety projects and programs, perform other special functions, initiate and monitor new projects as delegated by the Director or Deputy Director, and represent the Division in higher-level planning activities and committees within OAG and externally and to assist and improve highway safety grants and program delivery; performs other related duties as required.

REQUIREMENTS

EDUCATION: Graduation from an accredited college or university with a Bachelor's degree.

<u>NOTE</u>: Applicants who do not possess the required education may substitute additional experience as indicated below on a year- for-year basis with thirty (30) semester hour credits being equal to one (1) year of experience.

EXPERIENCE: Three (3) years of experience in the development, implementation, or evaluation of programs and instructional proposals and program presentations, budgeting preparation, planning, and administrative initiatives is required.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey.

PREFERENCE: Preference will be given to applicants with strategic planning experience, policy planning, and development experience.

Failure to do so may result in disqualification of your education towards eligibility.
