Booth Guidelines

The overall appearance and presentation of your booth is critical to the overall feeling of the show and to your retail success. We want to ensure that everyone has the best possible experience. Booth spaces are determined on a first come first serve basis. Application date will determine booth placement.

A detailed description of products/items to be sold is required with the application before the application can be approved:

- Booth space is limited to a single 12' x 12' booth (including all wires, stakes, poles, etc.) with a good roof that can withstand wind, rain and other inclement weather. Come prepared for all types of weather. You must secure your booth in case of windy conditions.
- Your booth must be open during the entire festival. You cannot vacate early.
- Your booth must be neat, attractive and well-maintained. Signage with visible prices are preferred.
- You are responsible for setting up, maintaining, and removing your own booth, your merchandise and your trash.
- You must provide your own table, tents, etc.....
- Vendors must check in between 6am and 7am no vehicles will be allowed on the premises after 7am. All vehicles must be off the premises by 7:30am and Vendors must be set up by 8am.
- Each applicant will receive a confirmation letter upon receipt of their application and a map and directions will be mailed out prior to the event.
- Vendor fees are non-refundable.
- Absolutely no vehicles may be left on event grounds overnight
- Vendor application forms must be received by February 1st to be in the show programs
- Electricity is limited and will be given to food vendors first.

Liability Release, Waiver Assumption of Risk and Indemnity

Warning: Under Arizona Law, **an equine activity sponsor or equine professional** is not liable for any injury to or the death of a participant in equine activities resulting from the **inherent risks** of equine activities, pursuant to A.R.A. s 12-553.

Silver Lining Riding operates on an active stable with multiple owners boarding, breeding, training, and teaching horseback and driving lessons and there are no areas which are completely free from animal activities or for persons who are not participants. While there is a spectator area, there is still an inherent risk in being in close proximity to horses and farm animals.

On behalf of myself, my personal representatives, heirs, next-of-kin, and spouse. I HEAREBY:

- Understand and acknowledge that Silver Lining operates at Little Kentucky Stables, which is an active stable with a variety of animals housed throughout the premises, that I must exercise care and caution while on the premises, including responsibility for any minors in my care.
- This includes not interacting with any farm animal without the express permission of a Silver Lining Riding staff member.
- Assume the risk of injury, which I or minors in my care may sustain, arising from approaching, handling, or riding a horse in connection with Silver Lining Riding activities.

I understand and acknowledge that horses are unpredictable and even the most docile animal can and may step on, bite, push off balance, stumble, throw, or otherwise injure any spectator or participant when they are in close proximity.

I further voluntarily agree and warrant to hold harmless Silver Lining Riding and all employees, volunteers, Board of Directors, and associated parties from any liability whatsoever, including, but not limited to: any incident caused by or related to Silver Lining's negligence, relating to injuries known or unknown, or otherwise not herein disclosed: including but not limited to: injuries, death, or property damage from: mounting, riding, dismounting, walking, grooming, feeding, use of horse barn, pastures, stalls, or arena in any capacity; falling off the horse; or my failure to understand Silver Lining's directions related to my riding or otherwise use and control, or lack thereof, horses or equipment.

I will exercise safety precautions for my own protection and any minors accompanying me on the property, and I agree to abide by the policies and procedures of Silver Lining Riding, as such policies may be amended from time to time. I also agree to exercise proper care and conduct at all times including supervising and taking responsibility for any accompanying minors while on or near any horse.

I indemnify, and save and hold harmless Silver Lining Riding, its officers, instructors, volunteers, participants or employees, and they shall not be held liable for any claims, demands, injuries, or damages, arising out of or in connection with my participation or attendance at any Silver Lining Riding event.

I ride and/or participate at my own risk and agree to take all necessary precautions to prevent any and all accidents. These precautions include, but are not limited to, the wearing of protective headgear.

I hereby release, discharge and promise not to sue Silver Lining Riding, its officers, instructors, volunteers, participants, employees, agents where lessons, horse shows or other Silver Lining Riding events occur, from all liability for property damage and personal injury to me.

This agreement shall apply to any horse being used for Silver Lining Riding event or any person or equipment affiliated with said event.

Furthermore, I assume full responsibility and liability for the conduct and safety of any minors I bring onto the property where Silver Lining Riding events are conducted.

I have read and understand all of the above and waive any claim which may arise against Silver Lining Riding, its officers, instructors, volunteers, participants, employees, agents or owners of the property where Silver Lining Riding events are conducted.

This agreement is effective upon signing and continues so long as I participate in Silver Lining Riding events.

I agree to pay all costs and attorneys' fees arising from any suit, legal proceedings or threatened proceedings that are or may be brought by me contrary to the terms of this Agreement.
