

Bloomfield Police Department

Monthly Report for February 2018

This is the monthly report for the Month of February 2018 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Sunday, February 4th at approximately 6:06pm officers responded to a vehicle versus tree crash on Lange Road just south of Hwy B. At the conclusion of the investigation a 63-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the driver was issued a traffic citation for unreasonable and imprudent speed.

On Monday, February 5th at approximately 7:27am officers responded to a vehicle versus school bus personal injury crash on Hwy H at the Hwy 120 intersection. A male juvenile was transported to an area hospital for minor injuries sustained during the crash. A 17-year-old male driver was issued traffic citations for driving too fast for conditions and vehicle operator failure to wear a seatbelt.

On Tuesday, February 6th at approximately 3:48pm officers responded to the public beach at the intersection of N. Lakeshore Drive and Orchid Drive to assist a Department of Natural Resources Warden. At the conclusion of the assist a 20-year-old male subject was issued a non-traffic citation for the possession of drug paraphernalia.

On Saturday, February 10th at approximately 6:40am officers responded to a vehicle in the ditch on Hwy H in the area of Schaitel Road. At the conclusion of the investigation a 25-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the driver was issued traffic citations for driving too fast for conditions, failure to notify DMV of address/name change and a non-traffic citation for resisting/obstructing a police officer.

On Sunday, February 11th at approximately 5:47pm officers responded to the Southern Stop Bar on Hwy U for a disturbance between a male and female. At the conclusion of the investigation a 42-year-old male was arrested and confined in the Walworth County Jail. Charges of disorderly conduct and bail jumping (misdemeanor) have been forwarded to the Walworth County District Attorney's office.

On Tuesday, February 13th at approximately 3:35pm officers executed a traffic stop on Bloomfield Road near Breavers Lane for a speeding violation. At the conclusion of the traffic stop a 20-year-old male was issued traffic citations for speeding, operating after suspension, display unauthorized registration, operator fail to wear seatbelt and operating without insurance.

On Monday, February 19th at approximately 6:48am officers responded to a report of a hit & run crash in the 500 block of Hwy H. At the conclusion of the investigation a 43-year-old male was issued traffic citations for hit & run, failure to notify police of a crash, unreasonable and imprudent speed and operating a motor vehicle without insurance.

On Thursday, February 22nd at approximately 5:47pm officers executed a traffic stop on Nippersink Road in the area of Powers Lake Road for operating after suspension offense. At the conclusion of the traffic stop a 35-year-old female was issued a traffic citation for operating after suspension.

On Sunday, February 25th at approximately 10:36am officers executed a traffic stop on Hwy 50 for a speeding violation. At the conclusion of the traffic stop a 32-year-old female was issued traffic citations for a speeding violation and operating after suspension.

During the month of February 2018 officers from the Bloomfield Police Department affected 13 arrests for warrants issued by the Bloomfield Municipal Court satisfying approximately \$2,617.00 in outstanding forfeitures.

During the month of February 2018 the Bloomfield Police Department responded to 891 calls for service compared to 630 calls for service during the month of February 2017. During the month of February 2018 the police department affected 142 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 88 arrests during the month of February 2017.
