## NJ TEEN PERSEVERES THROUGH HOMELESSNESS TO GET ACCEPTED TO 17 COLLEGES



In the wake of the nation's largest-ever college admissions scandal, a Jersey City teen is defying the odds through hard work, coming back from homelessness to receive nearly 20 college acceptance letters.

Dylan Chidick, 17, has received 17 acceptances so far, having applied to 18 schools. Dylan, who moved with his family from Trinidad when he was 7 years old, is on a quest to become the first person in his family to go to college.

"I wasn't really sure if I wasn't going to get into college because I don't have the perfect grades or perfect GPA or perfect SAT score," Dylan said. "But I knew that when college admissions read my essay and see me as a whole person, I'd be OK."

Although Dylan has always wanted to go to college, it was a quick conversation with his mom, Khadine Phillip, that sealed the start of his ambitious journey.

"He came home one day and said 'Mom do you want me to go to college?,' "Phillip said. "And I said 'Yup. You're going to be the first one in our family to go to college.' "

For his college admission essays, Dylan chose not to write about his homelessness. At first, he was ashamed of it, he said. Instead he wrote about racism. Dylan wrote about how people who say they don't see color can't see who someone really is, he said.

But ever since his first acceptance, to New England College, in October, the wave of letters have shown Dylan that he is finally seen for who he truly is, he said.

"I thought that people were listening to me and understanding me and seeing who I was as a whole, entire person," he said.

## STATES WITH THE MOST UNSHELTERED HOMELESS PEOPLE

There were an estimated 552,830 people experiencing homelessness across the United States in January 2018, essentially the same number as the same time last year.

The U.S. Department of Housing and Urban Development delivers to Congress annual estimates of homelessness across the nation. There is a great deal of variation in homelessness across the country.

Based on the latest report from HUD, 24/7 Wall St. reviewed the share of each state's homeless population that is unsheltered. Nationwide, approximately twothirds of homeless individuals were staying in sheltered locations, while one-third lived on the street, in abandoned buildings, and other unsheltered places.



## HUD accuses Facebook of housing discrimination — and eyes Google and Twitter too

The Department of Housing and Urban Development alerted Twitter Inc. and Alphabet Inc.'s Google last year that it is scrutinizing their practices for possible housing discrimination, a sign that more technology companies could be ensnared in a government probe of their lucrative demographic ad targeting tools, according to three people with direct knowledge of the agency's.

HUD charged Facebook Inc. with housing discrimination Thursday, alleging the social networking giant's targeted advertising platform violates the Fair Housing Act by "encouraging, enabling, and causing" unlawful discrimination by restricting who can view housing ads "They want to make sure that other companies aren't getting away with something that one company is investigated for," said someone with direct knowledge of HUD's outreach to other tech companies who is not authorized to discuss the communications.

## Word on The Street — When bad intension s undermine good causes

A homeless man and a woman pleaded guilty Wednesday to federal charges in a GoFundMe scheme that prosecutors say netted \$400,000 with a phony story about him coming to her aid.

Johnny Bobbitt, 36, of Philadelphia, pleaded guilty to conspiracy to commit money laundering, and Katelyn McClure, 28, of Bordentown, New Jersey, pleaded to a charge of conspiracy to commit wire fraud.

Bobbitt conspired with McClure and her thenboyfriend Mark D'Amico to make up a story in 2017 about Bobbitt giving McClure cash for gas when she was stranded along a Philadelphia highway, according to prosecutors. The scheme raised

\$400,000, which the couple claimed would be donated to Bobbitt. Instead, New Jersey authorities said, the three split the money and spent lavishly, including on a car, designer bags, and trips to Las Vegas, Disneyland, Disney World, the Grand Canyon and New York City. GoFundMe says it has refunded all the donations.

#### HOMELESS BILL OF RIGHTS FIZZLE IN WASHINGTON

The text of the bill is straightforward — cities within Washington should stop criminalizing homelessness, allowing them to redirect funds spent on enforcement and incarceration towards investments in evidence-based practices for ending homelessness, such as supportive housing. This approach is based on multiple studies showing that the criminalization of homelessness is counterproductive, as well precedents from around the country and the world. Although so called 'quality of life' laws aimed at clearing our streets and plazas of public displays of poverty have recently grown in popularity, they are frequently challenged in court and often struck down as unconstitutional. HB 1591 thus builds upon current judicial decisions and helps protect Washington municipalities from potential lawsuits.
