- **B)** Arena Report: *Youth Rodeo will be rescheduled when there are not other youth rodeos going on, so during our Fall Festival. * Doing another barrel race series, working on sponsorships for that * CVGA Gymkhana is working with us on dates.
- C) Rentals we have 8 large events and 6 small events already scheduled for this next year in addition to our events.
- **D)** Fair * Re-cap meeting with the City had many changes they would like to see from "Event Staff" with different colored shirts that can help people the suggested ratio is 1 "events staff" for every 50 people. The "event staff" would know the gate codes, be able to help people leave is there is an incident.
- * Another thing they want is a head count as to how many are on the grounds at certain times of every day * would like all who enter to be "Wand"ed as they come in the gate. * There are still many electrical upgrades the City wants us to do.
- **E)** .5 **K** Beer Fest October 11th not getting the individual breweries due to a lot of Octoberfest events happening at that time, but we can work with Canyon Distributing to get craft beers to serve and if the brewers can come, that will happen. We will need a lot of volunteers to make this event happen.

- A) Water Truck update No update at this time, need to make sure the tires are good and what is our timeline.
- B) Capital Improvements The current list of Capital Improvements were handed out. Before the next meeting the Board needs to put the items they want in order of 1 5 and we will make the top 5 items our priority making sure to add Small Stock Barn to match the current pavilion size. 5 new laptops for the auction in October Microsoft will have an update that our current machines will not be able to handle. Cover the current "dance floor" by the stage with shade so we can do more and enhance that area. More shade by the office with tables.
- C) **Budget** Draft the draft budget was presented with estimated numbers for June 30, 2025 this will be updated for the July meeting. Staff salaries were handed out and the board will make final decisions at the July meeting.

IX New Business

- A) **RV Horse camping fees around** Staff put together a list of places that allow for RV camping with horses the VVF does not offer covered stalls but the current rate of \$10 per horse per night is in line with other locations.
- B) 7th Street Ownership/Easement There is an easement to the fairgrounds off of 7th Street during the budget process, if the board is interested the staff will pursue this easement. At the City re-cap meeting when VVF brought this up both the Police and Fire department felt it was a good way to have other access points to the fairgrounds.
- C) Added Money for Fair Rodeo to get better riders Discussion included ways to re-coup some of the rodeo costs that we currently put out for the Friday and Saturday night rodeo. How many people attend the fair only because of the Rodeo, If we did more added-money would we have better riders. What would it take to do a separate entrance fee for the Rodeo after people come into the fair. Other revenues we have to acknowledge is that those that come to the Rodeo also purchase beer/soda, food and ride the rides for a complete package.
