Winter parking rules

Winter parking rules are in effect from *November 15th to April 1st* between 1:00 a.m. and 6:00 a.m. Park cars on the odd or even side of the road that corresponds to the day from 1 a.m. to 6 a.m. (Example at 1 a.m. on the 16th you would need to be parked on the even side of the road.) IF YOU ARE A LANDLORD PLEASE NOTIFY YOUR TENANTS!

Snow emergency parking in addition to alternate side parking!

A snow emergency is AUTOMATICALLY declared when a snow is forecasted to be 3" or more during any period of 24 hours or less. Under a snow emergency **ALL** vehicles must be **OFF** the streets until they have been plowed. We will enforce our ordinance 32-155.

Open burning

Burning trash and garbage is prohibited. Fall burning of dry leaves and other non-offensive dry yard debris is only allowed from October 1st thru November 30th. Please be 30 ft from neighboring properties and monitor the fire until it is completely out. Outdoor cooking and campfires are allowed per Village Ordinance but must be supervised at all times. See ordinance section 14-84 and 14-85 for more information.

Yard waste site for leaves/brush

There will not be a scheduled leaf pick-up in the Village; instead you can now take your leaves and any brush to the site located off Vince Street at the intersection of Savannah Trail. Site is open Monday – Friday from 7:30-3:30 and the 1st and 3rd Saturday of the month from 8-12 noon.

The Village Board is encouraging residents to participate in their local government. Three Village Board trustee positions and Village President are up for re-election in April 2021. The candidate must be a Village resident and at least 18 years of age. Interested candidates may pick up the election nomination papers from the Village office on or after Dec. 1, 2020. The filing deadline to be a candidate for Village offices is no later than 5:00 p.m. on Jan. 5, 2021. The elected officials will begin their term of office the third week of April 2021. Tax collection information

Village Hall will be closed the following days for the holidays: **Dec. 24 & 25; Dec.31 and Jan.1**. For your convenience, real estate taxes can be receipted for the 2020 year if postmarked on or before Dec. 31 or placed in the drop box prior to January 3, 2021. The first half of your tax bill is due at Village Hall by January 31, 2021 and the final payment is due at the County Treasurer's office by July 31, 2021.

Private wells

All private wells and sand points must comply with DNR codes, Village ordinance section 16-55 through 16-58 and REQUIRE A PERMIT!! Please contact the office if you have a drilled or sand point well to obtain the proper permit (permits are required to be renewed every 5 years). We will begin contacting those with wells that do not have a valid permit on file.

Snow Removal

Don't forget that you must clear the snow/ice from your sidewalk within 24 hours after the snow has stopped. **Snow/ice should not be pushed or blown onto the street.**

If there is a fire hydrant in the right-of-way on your property, please remove the snow around it. This is for your safety and the safety of your neighbors in case of a fire emergency this winter.

For those with mailboxes...

The Village of Pardeeville **WILL NOT BE RESPONSIBLE** for mailbox damage caused by the plowing of snow (force of the snow being pushed).

Christmas tree collection

The Village will pick up your used tree the second week of January. Place the tree at the curb by Monday, January 11, 2021 for it to be picked up!

License your pet(s)

Dog and cat licenses are required annually. You must bring in proof of rabies vaccination from your veterinarian's office (this must include date of vaccination, tag # and manufacturer of vaccine; not your receipt of services). We will begin issuing license tags for 2021 on December 1, 2020. Licenses are due by April 1, 2021 or a late fee will apply!

License Fees: Spayed/neutered dog or cat \$5.00. Unaltered dog or cat \$10.00. You can drop off your rabies certificates with payment and a self-addressed stamped envelope and we will mail your tags if you cannot make it to the office during open hours.
