RESOLUTION NO.: SL - 47 - 2024

**TITLE: APPROVAL OF CONTRACT WITH PROGRESSIVE PEST
MANAGEMENT (PPM) TO PERFORM INVASIVE PLANT
TREATMENTS ON THE RESERVATION (SLPT FUNDS 152/1502, BIA -
A20AV01054/BOR - R20AV00010)**

WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 8, 1965, granting certain powers to the Summit Lake Paiute Council; and

WHEREAS, the Summit Lake Paiute Council has the responsibility for the general welfare of its tribal membership including tribal natural resources; and

WHEREAS, the Summit Lake Paiute Council is the duly constituted governing body within the Summit Lake Paiute Reservation; and

WHEREAS, the Summit Lake Paiute Council has been organized to represent, develop, protect, and advance the views, interest, education, resources, and general welfare of the Summit Lake Paiute Tribe membership; and

WHEREAS, the Summit Lake Paiute Council supports natural resources management that protects, conserves, and enhances plants and wildlife native to the Summit Lake basin and aboriginal area of the Summit Lake Paiute Tribe; and

WHEREAS, the Summit Lake Paiute Council has organized a Natural Resources Department (NRD) to provide technical expertise and services to manage air, water, soil, fish, wildlife, plants, and infrastructure within the Summit Lake Paiute Reservation and off Reservation areas considered the aboriginal homeland of the Summit Lake Paiute Tribe; and

WHEREAS, the Summit Lake Paiute Tribe has been awarded grants (SLPT Funds 152 and 1502, BIA - A20AV01054 and BOR - R20AV00010, respectively) to eradicate or control invasive plant species on the Reservation; and

WHEREAS, the NRD has determined that Progressive Pest Management (PPM) possesses the skills and equipment to perform the above referenced work and anticipates completing the work in fall 2024, per the grants' schedules; and

WHEREAS, the NRD and PPM have previously worked together on these projects; and

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council hereby authorizes, approves, and consents to contract with PPM to perform invasive plant treatments on the Reservation; and

BE IT FURTHER RESOLVED that the Summit Lake Paiute Council does not waive, alter, or otherwise diminish its Sovereign Immunity, whether expressed or implied, by virtue of this grant contract for any and all administrative or legal action which may arise directly or indirectly from the same. Furthermore, the Summit Lake Paiute Council hereby authorizes the Tribal Chairwoman to execute any instruments as may be necessary and appropriate to accomplish the above-mentioned actions in the name of and on behalf of the Summit Lake Paiute Tribe.
