RESOLUTION NO.: SL-10-2016

TITLE: AMENDMENT OF BIA CONTRACT A10AV00360 RANGE MANAGEMENT PROGRAM TO PURCHASE A TRACTOR AND BOOM MOUNTED MOWER

WHEREAS, The Summit Lake Paiute Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984), as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Tribal Council; and

WHEREAS, The Summit Lake Paiute Tribe is currently administrating a Fire Resilient Landscape grant awarded in 2015 for the amount of \$200,000 and added to the BIA Contract A10AV00360 Range Management Program as Modification 25, to mitigate potential wildland fire threats to the habitat of wildlife species on the Summit Lake Indian Reservation: and

**WHEREAS,** the procurement of a tractor and mower heads is needed to mow vegetation along fences and roadsides within the Reservation to serve as fire breaks; and

**WHEREAS,** the cost to purchase a boom mounted mower on a tractor was initially budgeted at \$86,600; and

**WHEREAS**, new boom mounted mowers on tractors generally cost greater than \$165,000.

**NOW, THEREFORE BE IT RESOLVED** that the Summit Lake Paiute Council hereby approves a budget modification to increase the line item for Equipment >\$5,000 to be paid by BIA Contract A10AV00360 (Tribal Fund Code 1041) to buy a boom mounted mower on a tractor, not to exceed \$165,000 and to adjust salaries and operating costs accordingly.

**BE IT FINALLY RESOLVED** that the Tribal Chairwoman, Vice-Chairwoman, and the Natural Resources Department Director, are hereby authorized to amend and adjust Contract A10AV00360, as needed, to include any changes in the amount of funds available for obligation, and to execute any and all documents necessary to effectuate the intent of this Resolution and to inform the Bureau of Indian Affairs (BIA) of this decision.
