

# One System of Justice

In many Western societies today, there is a two-tiered system of justice. One that applies to native-born citizens, but a different standard for those who enter from abroad. One of the driving forces behind this is the self-righteous ideology of those in leadership positions who believe it is "racist" to apply the same standard of justice to foreigners as they would their own citizens. Many of these leaders know precious little about God's law and, even those who claim to, will not apply God's clear instructions in this matter.

*"More than two decades after UK authorities first became aware of systemic child abuse in Rochdale, in the north of England, where nine men of Pakistani origin were convicted of sex trafficking and other offenses including rape of children in May 2012, there remains a reluctance, even a fear, of acknowledging the activities of Asian grooming gangs. More recently, in neighboring Rotherham, a similar case has shocked the nation, having been allegedly "covered-up" by police officers whose fear of being labeled "racist" apparently over-rode their sense of duty (equal justice under the law). Most of the victims are white and most of the convicted offenders are of Pakistani heritage.....with the exception of one town there is scant evidence of work being undertaken in British Pakistani communities to confront the problem of "pimping gangs" largely consisting of members of the British Pakistani community"* (<https://eutoday.net/news/politics/2020/grooming-gangs-uk-cover-up>; Ed. note in parenthesis).

So, what does Almighty God have to say about having different standards of justice that cater

to different groups of people within any given nation?

***One law shall be for the native-born and for the stranger who sojourns among you*** (Ex. 12:49; NKJV used throughout unless otherwise noted; emphasis added).

***One law and one custom shall be for you*** (native-born citizen) ***and for the stranger who sojourns with you*** (Nu. 15:16; Ed. note in parenthesis; emphasis added).

***You shall have the same law*** (*one standard of judgment*) ***for the stranger and for one from your own country***, for I am the Lord your God (Lev. 24:22; Ed. note in parenthesis; emphasis added).

But as the Apostle Paul stated in Romans 1:28, *"they did not like to retain God in their knowledge."* One of the direct consequences, of dismissing what God has to say, leads to lawless behavior including acts of sexual perversion.

*God gave them over to a debased mind, to do those things which are not fitting; <sup>29</sup>**being filled with all unrighteousness, sexual immorality, wickedness, greed, malice....*** (Rom. 1:28b-29a; emphasis added).

Similarly, the current administration in the USA does not want to enforce border laws because it might appear to be "racist." One consequence of this foolish and self-serving behavior is that many women/young girls are being sexually exploited and trafficked. The following is an excerpt from an article by Leah Barkoukis in Townhall.com (March 31, 2021).

*The Biden administration finally allowed reporters into a Customs and Border*

*protection facility in Donna, Texas, on Tuesday where more than 4,000 individuals are crowded into a space that's only intended for 250 people. Most there are children, and in a video Reuters posted on Twitter, Oscar Escamilla, the acting executive officer for Border Patrol's Rio Grande Valley operations, shared some of the heartbreaking stories he's hearing from them. He said about six weeks ago he spoke to "one of the little girls" in the facility who he said they were ready to send to the hospital. He said he noticed she couldn't speak, so he asked the medical team there what had happened. They explained the reason she was going to the hospital is because she had gotten gang raped along the way to the border. The reason she couldn't speak was because she had lost her voice in the process of getting raped.*

Now if the Biden administration was enforcing the border laws equally between those who apply to come into the US legally, versus those who enter illegally, situations like the one described by Leah Barkoukis would not occur because everyone would know there is only one set of laws being applied to everyone. Therefore, it would deter people from attempting to cross the US border illegally, and eliminate any sexual abuse, injury, or death associated with making this journey.

Sadly, this two-tiered, or some would argue multi-tiered, system of justice has crossed over to the political arena. The end result will be deep division within a nation that can be exceedingly difficult

Instead of strife and division, there will be cooperative governance based on God the Father's system of justice, as summarized by His law and commandments. So, no political parties will exist at this future time. Instead, anyone responsible for serving his/her fellow-citizens will represent the value-system of Almighty God, which has no party affiliations (see study: New World Leaders "In Waiting").
