Ordinance No. 666.

An ordinance to levy a corporate tax and special Sewer and pre Stre

Paving assessments in the City of Garnett, Kansas, for the year of 1916.

Be it ordained by the Mayor and Commissioners of the City of Garnett, Kansas.

- Section One.) That a corporate tax be and the same is hereby levied on
 - all taxable property in the City of Garnett, Kansas, for general revenue fund purposes, Eighteen Cents on each one-Hundred dollars valuation.
- Section.2. That a corporate tax be and the same is hereby levied on all the taxable property in the City of Garnett, Kansas, for street fund purposes, five cents on each one-hundred dollars valuation.
- Section 3. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for the fire department fund, two cents on each one-hundred dollars valuation.
- Section 4. That a corporate tax be and the same is hereby levied on all taxable property of the city of Garnett, Kansas, for water works extension bond sinking fund, Eight cents on each One hundred dollars valuation.
- Section 5. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for water wak works extension bond interest fund, seven cents on each one-hundred dollars valuation.
 - Section 6. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for water works extension bond sinking fund 1913, one cent on each one-hundred dollars valuation.
- Section 7. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for water works extension bond interest fund 1918, Two and one-half cents on each one-hundred dollars valuation.
- Section 8. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Mansas, for water works improvement bond sinking fund, two and one-half cents on each one-hundred dollars valuation.
- Section 9. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for water works improvement bond interest fund, five cents on each one-hundred dollars valuation
- Section 10. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for Electric Light bond sinking fund, two cent on each one-hundred dollars valuation.

- Section 14. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for main sever bond interest fund, five cents on each one-hundred dollars wit valuation.
- Section 15. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for library fund, four cents on each one-hundred dollars valuation.
- Section 16. That a special assessment be made on all lots and pieces of ground in sewer district number one, liable for sewer assessments for the purpose of paying one-tenth of the original assessment, and six per cent interest for one year on five-tenths of the original assessment.
- Section 17. That a special assessment is hereby made on all Lots and pieces of ground in sewer district number two, liable for special assessment for the purpose of paying one-tenth of the original assesswent, and six percent interest for one year on five-tenths of the original assessment.
- Section 18. That a special assessment is hereby made on all lots and pieces of ground in sewer district number three, liable for special assessments, for the purpose of paying one-tenth of the original assessment, and at Rivertexx six percent interest for one year on five-tenths of the original assessment.
- Section 19. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for the purpose of paying one-tenth of the cost of paving and improvements of intersections, on Fourth street, and Oak street, and four and three-fourths percent interest on said cost of improvement for one year, thirteen cents on each one-hundred dollars valuation.

- Section 20. That a special massessment is hereby made on all lots and pieces of ground abutting on fourth avenue, fifth avenue, and oak street, liable for special assessment, for paving fund, for the purpose of paying one-tenth of the original assessment, and four and three-fourths per cent interest on the original assessment for one year.
- Section 21. That this ordinance shall take effect and be in force from and after ten days after its passage by the commissioners, and its approval by the Mayor, and after its publication in the Passed and approved this 7 day of Gary 1916.
