Village will spray hazard tripping area with yellow paint.
- Tamisha Matus, Creating Healthy Communities Coordinator at UCHD updated council on the Active transportation plan and requested permission to work with Magnetic Springs in conjunction with Richwood for Northern Union County plane. Mayor and council saw no issues in working together and combining the projects. The project will be 100% grant funded.
