#### Old Business:

- a. Roads/Bridges: No report
- **b.** Dam Project: Officials were provided, in writing, with an update and summary of the work that has been completed.
- **c.** Special Land Use Permit Kari Dickenson. No action. The request will be approved at the Planning Commission meeting November 13, 2025.

#### **New Business:**

- a. Fire Department Update A lease agreement has been signed with Doug Sturgis effective November 15, 2025. EAFD will be out of the current facility before November 25, 2025. The Fire Association is looking at this as a bridge, whether the Main Street location is purchased down the road or if a new building is built in the future.
- **b.** Clinton Area Ambulance A written report was presented to officials.
- c. Stop sign Purchase B Levey presented an updated price for the stop signs requested at the corner of Colony and Shepardsville and the corner of Shepardsville and Island roads. The original estimate was \$10,000 the current cost is \$13,201.00. Discussion followed. It was moved by R Ladiski to purchase the signs with the cost increase and supported by R boots. Approved.
- **d.** Clerk's Request It was noted that Duplain Township is not actively looking at pursuing the Village of Elsie. Money will not be spent on rumors.

Clerk's Report – It was noted that funds will need to be moved from the unallocated Road Fund balance to cover the remaining 2025 road projects. Expenditures totaling \$174,612.67 were presented for approval. It was moved by R Boots and supported by R Ladiski to approve the expenditures. Approved.

## Things that need to be talked about:

- **a.** R. Ladiski inquired about the status of the apartments to be developed at the former Elsie High School site. It was reported that grants have dried up and the government shutdown has had an impact on the project (D Sturgis)
- **b.** R Boots spoke to Ferral's regarding tree removal at the Duplain Township Cemetery. B Levy has not received quotes; he would like them removed in February or March. R boots will follow up, stump grinding to be included.
- c. A Bowen will set up MiClass meeting in December or January. Also, Elba Township is moving the township hall to an abandoned gas station. Ashley Fire Department is looking at utilizing office space at the old township site.
