RESOLUTION NO.: SL-07-2020

TITLE: ADOPTING HUNTING AND FISHING REGULATION AMENDED CHANGES

WHEREAS, the Summit Lake Paiute Tribe, is organized pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Council; and

WHEREAS, the Summit Lake Paiute Council has the responsibility for the general welfare of its tribal membership including natural resources; and

WHEREAS, over time the members of the Summit Lake Paiute Tribe have regained a small fraction of their historic land base, including the Tribe's reserved lands (Reservation), and the Indian allotments outside the Reservation boundaries; and,

WHEREAS, the Summit Lake Paiute Council is the duly constituted governing body within the boundaries of the Summit Lake Paiute Reservation; and

WHEREAS, the Summit Lake Paiute Council has been organized to represent, develop, protect and advance the views, interests, education, resources, and general welfare of the Summit Lake Paiute Tribe membership; and

WHEREAS, the Summit Lake Paiute Council has organized a Natural Resources Department to provide technical expertise and services to manage air, water, soil, fish, wildlife, and plants within the Summit Lake Paiute Reservation and off-reservation areas considered the aboriginal homeland of the Summit Lake Paiute Tribe; and

WHEREAS, in 2014 the Natural Resources Department solicited input from Tribal Members regarding proposed changes to the Tribe's Hunting and Fishing Ordinance No. V and used that input along with information about ongoing Natural Resources Department projects to suggest an amendment to the hunting and fishing regulation; and,

WHEREAS, on May 17, 2014, the Tribal Council agreed through the passage of a motion at a duly held Tribal Council meeting to adopt the proposed

hunting and fishing regulation amendment for a two year period ending May 1, 2016; and

WHEREAS, an official amendment to the Tribe's Hunting and Fishing Ordinance No. V was not introduced in the time following the expiration of the adopted amendment to the hunting and fishing ordinance; and

WHEREAS, the Natural Resources Department is currently in the process of informing the Tribal Council of ongoing projects regarding fish and wildlife on the Reservation, has solicited input from Tribal Members regarding hunting and fishing activities over the past five years; and,

WHEREAS the Natural Resources Department will research the process to officially amend Tribal Ordinances, specifically to update the existing Hunting and Fishing Ordinance No. V, throughout the next year.

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council adopts the hunting and fishing regulation amendment first approved on May 17, 2014 and extends the conditions described therein through March 1, 2021 or an official revision and amendment to the Hunting and Fishing Ordinance No. V is presented to and approved by the Tribal Council, whichever comes first.
