The consensus is the broken pipe was due to the significant age of the cast iron pipe and not due to contractor negligence or error.

# WASTEWATER TREATMENT PLANT UPGRADE & CONSENT ORDER AND AGREEMENT (COA)

HRG continues to coordinate with PSI to ensure that all items included in Correction Period punchlist are completed by PSI.

PSI recently completed work at the WWTP to seal conduits and electrical devices that experienced water intrusion caused by heavy rainfall attributed to hurricane Debbie.

#### HALIFAX TOWNSHIP SEWER EXTENSION PROJECT

Construction activities associated with the Project include the following significant work items since last month's meeting:

# **Doli Construction (Contract 2022-01):**

- Doli has stopped work within the PennDOT ROW until 2025 pursuant to the Contract Time extension. The tentative start date for work in the PennDOT ROW is Mid-March, dependent on weather and availability of pavement.
- The main focus of work has been on installation of grinder pumps within the project area. Doli is currently completing air testing of the low pressure sanitary line on Creek Road. Once this section is completed, crews will begin working from Creek Road towards the Borough installing grinder pumps on homeowners properties.

Doil's formal request for a Contract Time extension for work on SR 225 was approved at the October Authority meeting. May 29, 2025 has been established as the new Substantial Completion date.

## PSI Contracts (2022-02 & 2022-03):

 PSI continues to perform work to ready the Roadcap Lane Pump Station for service, though this station will likely not be started until Spring/Summer 2025 when the remainder of Doli's work is completed and all main-line sewers and force mains in SR225 are completed and tested.

#### Miscellaneous Project Items:

HRG continues to wait on dates for completion of the additional lateral extensions to serve the Dollar General and Hornungs stores, although based on preliminary discussions with Doli and their subcontractor, it is anticipated this work will be completed in early January. These crossings are intended to be performed via horizontal directional drilling. There are three other lateral crossings to be installed across SR225 near the Sheetz that we anticipate will be performed at the same time.

HRG completed a substantial completion walkthrough for the contracts and is finalizing Substantial Completion documents for portions of the work determined to be Substantially Complete.

HRG continues to coordinate with Hoover Financial Services for notifying residents of connection requirements and issuing notice to connect letters.

## PENNVEST Requisition No. 17:

HRG has assisted the Authority in preparing PENNVEST Requisition No. 17 for the project in the amount of \$394,297.28, which includes interest costs and contractor payment requests. The cost breakdown of the requisition amount is listed below.

## **Updates since November 2024 Meeting:**

HRG conducted a Substantial Completion inspection on December 5<sup>th</sup>, 2024 with representatives from HAWASA and Mid-State Paving. Mid-state paving has completed all work associated with replacement of the mains along Fifth Street and Armstrong street and has reconnected all service lines. All pavement within Borough ROW has been repaired. Paving within PennDOT ROW will be completed in the spring along with vegetative restoration. HRG has prepared a punchlist of minor work items to be completed before Mid-State Paving demobilizes until spring.

HRG has prepared a CDBG Monthly Progress Report for the October reporting period for submission to the County. In conjunction with Application for Payment No. 12 HRG has prepared and submitted CDBG Payment Request No. 5 to the County.

## **NEW LAND DEVELOPMENT PROJECTS**

Sycamore Ridge - Halifax Township

**NO UPDATE. PREVIOUS REPORT:** There have not been any recent updates on the Developer's Plans for this Project.

Halifax Commons - Halifax Township

**NO UPDATE. PREVIOUS REPORT:** HRG conducted fire hydrant testing on April 25, 2024 with the help of Authority staff. This information was provided to the Developer's Engineer for review.

HRG has been providing some additional assistance to the Developer's Engineer on operation of the water system and available pressure and has provided standard construction details for inclusion in their pending plan resubmission.

# Rise Beverage - Halifax Township

Light-Heigel & Associates submitted a draft preliminary subdivision plan to HRG for review. The modified site would be sub-divided and house a new restaurant facility with a drive through, a new retail establishment, and a new counter service style restaurant. Light-Heigel & Associates have also requested certification of capacity letters from the Authority for water and sewer service.

HRG recommends an escrow be established for this development to facilitate review.

HRG has also been asked to provide recommendation on the willingness of the Authority to forego a sanitary sewer easement on the property.

# **MISCELLANEOUS SERVICES**

HRG has provided services to assist with the Authority's pursuit of funding assistance for the following:

## Lead and Copper Service Line Inventory:

- The Lead and Copper Service line Inventory was submitted to PA DEP by the October 16, 2024 deadline
- 2. HRG has been assisting Authority staff in posting notice to homes per requirements of the Inventory.

# **Grant Funding Opportunities:**

#### 1. CFA LSA Statewide Grant Program:

- a. HRG finalized and submitted an application for a proposed water main replacement project along Peters Mountain Road to the LSA Statewide Program
- b. Applications are due November 30, 2024

#### 2. Susquehanna River Basin Commission (SRBC) Consumptive Use Mitigation Grant Program

- a. SRBC provides a grant funding stream to municipalities seeking to complete improvements within their water system to mitigate water losses. HRG has successfully submitted grant applications for clients to this program for projects related to leak detection and monitoring. The SRBC program may provide an opportunity for funding replacement of meters within the system with meters equipped with leak detection.
- b. The grant is contingent upon a 20% match.
- Applications are due January 31, 2024.
