JUDGING CRITERIA

- **Muscularity and Body Conditioning** - Judges will be looking for competitors who display muscular size, symmetry, balance and proportion, with an emphasis on definition and condition. The ideal physique will display an aesthetic appearance highlighted by a small waist.

The judging is scored 100% and will consist of comparisons of quarter turns and the following five mandatory poses:

- Front double biceps
- Side chest
- Back double biceps
- Abdominals and Thighs
- Favorite Classic Pose (no most muscular)

The finals will consist of posing routine up to a maximum of 60 seconds
