## National Earth Day - April 22nd, 2017

In the wake of the Viet Nam war protests U.S. Senator Gaylord Nelson, the "Father of Earth Day" initiated and promoted environmental actions and activities beginning in 1962. He continued his pursuit of environmental awareness and in 1970 proposed a National Earth Day. It was the first nationwide environmental protest to shake up the political establishment. On that Earth Day, April 22, 1970 an estimated 20 million Americans took to the streets in support of the environment and to protest harmful environmental practices. This effort brought about greater awareness that our planet has limited resources and that our eco-system was self contained and finite. The things we were putting in the air, water and earth are impacting us.

- 2. We must look for ways to inspire, encourage and recruit new members. Don't stop with collecting their dues. Invite them to a meeting. Take them to coffee or lunch to build a friendship. We tend to respond best to people who have similar interests and issues. Recognize activity and the growth of your state and local organizations.
- 3. Work to organize and activate additional local Auxiliaries. According to the Constitution and Bylaws, it takes at least four (4) members to create a local Auxiliary. To be a chartered Auxiliary you must have the following: an EIN number, elected officers, and a Constitution. The national Auxiliary does have a template of a generic Constitution.
- 4. State organizations are significantly stronger if they have active local auxiliaries. They bring the entire state together and discuss long term activity, innovation, new organizations, increases in membership, special projects and involvement in any or all of the five Auxiliary objectives. If we are all engaged in similar activities, it aligns us in a universal effort. The glue of our organization is the APWU and the jobs we have at the USPS. It is a common thread that guides many of our actions. And the USPS is the thread that links our work with the community. Everyone is touched by the work of the USPS.

But it is not just about signing up new members – it's about recruiting, retaining and rewarding excellence/dedication to our organization. We're encouraging activity in the five points of the Auxiliary star. Pick a point – get motivated and let us know what we can do to

## It is Time to File the IRS 990N For This Year

#### It is time to file the IRS 990N again for this year

Form 990-N is due every year by the 15th day of the 5th month after the close of your <u>tax year</u>. You cannot file the *e-Postcard* until after your tax year ends. Remember, failure to file this annually will result in the loss of the not for profit status of your organization. That means you are required to file forms as a business and pay taxes. Sending a copy of the "accepted" form to the national treasurer for filing helps protect your organization. You can send this via email or mail.

If you are having trouble with your passwords and did not file last year, you will need to reset your password and user name. The IRS migrated to an IRS site last year.

The following link is the IRS site to use when filing your 990-N.

Or you can go to www.irs.gov and then use the search and type in 990N.

This form is simple to complete and after you register, it only requires about 10 minutes for completion.

## The Right Organizations Can Change the World

The right organizations can change the world. With people and a purpose a movement can be made. What exactly would you need? Who would you need? How will it be done? When do you start? Hopefully this article will not only inspire you but give you the key components to help you, me, your local, your state and your community to make that difference.

# "Never doubt that a small group of thoughtful committed citizens can change the world. Indeed, it is the only thing that ever has." Margaret Mead

There are so many non-profits and organizations out there that all have a purpose. What makes each one different? How are they the same? How do some have too many helpers and others have just a few that carry on the whole program? Keeping and recruiting those who will make that difference, those who will help carry out the word of the program, and those who simply help are key What about drama, political differences, personality conflicts and negative people who want to help? And then there are so many who have done it their way for so many years and see no reason to have new people join. It's easy to say, "I don't understand why people don't do anything" when there are many reasons for them to say, "I don't understand why people do those So how do we get more people involved? Following are some ideas that may help!

- 1. Ask Yes just that simple. However, if you ask the same people over and over you may get the same answer. So where do we ask, who do we ask and when do we ask?
  - A. Where at a local or state picnic when family members are invited to participate. Invite all members to bring a spouse, family member, or friend. Or at a local or state union luncheon or dinner where spouses or family members are attending. Have a table set up where you have information to share before the event begins. Walk around and speak with the guests and introduce yourself. You are more likely to get a yes from a person who knows you than from a stranger.
  - B. Ask union members if they have older kids, a partner, or family member that they could sign up. Don't forget your retirees.
  - C. Ask at appropriate times. Stay away from meetings that involve elections or if you know it's going to be a heated meeting.
  - D. Remember those you meet. After seeing them a few times you may feel more comfortable asking them to get involved.
- 2. Focus The Auxiliary may be confusing with the many activities in which we are involved. Mention one or two things they might be interested in, rather than

- overwhelm them with all that is going on. Ask them if they would like to help or volunteer with a project.
- 3. Know you audience Know who you are asking. Get to know people. Remember that quantity isn't always quality. In order for a tool to work you have to have the right parts. If you know your crowd, it's easier to get those quality members. Don't waste time on a person who will never say yes.
- 4. Educate yourself Get to know your organization's goals. The Auxiliary deals with legislative issues that affect postal workers. What are the issues? Have you been to a rally or attended a town hall meeting? Do you keep up with postal issues? Human relations projects?
- 5. Values, morals and manners Remember that we are asking people to volunteer their time in a variety of ways. It may appear to be a thankless job. So, we need to remember to say please and thank you. Offering donuts and coffee at a meeting can make a difference. Be pleasant being hard to work with will deter those "great volunteers" from ever joining. Treat people with kindness. Simple gestures such as a pat on the back or saying, "Great job," can do wonders. Don't exclude people. We should have common values, common morals and good manners. Treat all people with respect. With that you will have faithful members.
- 6. Communication We are all guilty of this out of sight, out of mind. If you meet someone new, send a card. If a family member has a tragedy, remember them with a card. If your local is having a picnic, pick up your phone and ask, "How can I help?" Find a common ground with people and talk. Conversation may lead to asking why a person hasn't been involved. Their answer might be, "Because you never asked." So, don't be afraid to ask!
- 7. A new member joins the Auxiliary now what? Share your passion, your stories, your experiences. Let them know about the various projects and find out where their interests are. They may get involved in a project and become passionate about it and find that inner drive to be involved.
- 8. Be a team As a leader learn to delegate, to guide, to focus, to set the pace and to reward. Lead by example. Encourage your team to take on leadership roles. Keep your team abreast of current issues and provide feedback that can be helpful.

Hopefully this will give you a few ideas on how to go out and recruit new members into the Auxiliary to the American Postal Workers Union!

## Postal Reform Act of 2017 Moves Forward

The APWU supports **H.R.** 756 advancing through the legislative process and will continue to provide updates and work with lawmakers and allies to ensure a robust future for America's public Postal service.

After H.R. 756 was introduced in January, President Dimondstein and APWU's Legislative Department requested clarifying language to ensure that prescription drug benefit coverage under FEHB would not decrease through Medicare integration.

Another concern the APWU voiced with lawmakers is the unintended consequence of certain postal annuitants who could not benefit from Medicare Part B. On this issue, Chairman Chaffetz and Rep. Lynch committed to further investigate and consider any necessary revisions going forward to address this.

Committee also adopted amendment by Rep. Mark DeSaulnier (D-CA) requiring the Postal Service to give members of Congress advanced notice if a postal facility in their district would be subject to closure, consolidation or a reduction in service. As we have seen in past efforts to shutter post offices and mail processing facilities, members of Congress can be key allies in rallying community support in the fight against counterproductive cuts.

#### H.R. 760

The Postal Service Financial Improvement Act of 2017 (H.R. 760), introduced by Rep. Stephen Lynch (D-MA) and Rep. David McKinley (R-WV), was marked up and sent out of committee on March 16th as well.

The bill is intended to be companion legislation to H.R. 756. If passed, it would require the Department of Treasury to invest between 25-30% of the Postal Service Retiree Health Benefit Fund (PSRHBF).

Under current law, the PSRHBF is only invested in Treasury Bonds with very low-yielding returns. Medical inflation rises much faster than Treasury Bonds which results in projected unfunded liabilities. If the PSRHBF could be invested in higher yielding funds, like those used for the Thrift Savings Plan, it would produce returns that would help keep up with medical inflation at a much faster pace. This frees up postal funds that could be directed to improve service and strengthen infrastructure.
