**III. CURRENT FINANCIAL CONDITION**

  - Was straightened last month but is leaning again

- **Trees need trimming**
  - Board removed some low-lying branches
- **Maintenance of Roads**
  - Board decided to put this project on hold until the fall and after other projects are completed
  - Jim Holtzman will get pricing for getting smaller amounts of milling at a time instead of mass amount when the board moves forward.
- **Speed Limit and Children at Play Signs**
  - Board will start placing new signs and posts, at night, beginning next week.
- **Pressure washing Playground, street signs and front gate/entry**
  - Polley is going to start the end of this week. was scheduled to start this week.
  - Kevin Hoover will ask him to pressure wash the white fencing at the entrance to the community.
  - Barrett Smith mentioned that the fence at the lake may also need to be pressured washed
- **Picnic Tables**
  - Board decided to wait until the Fall to finish the picnic tables and purchase the material at that time.
- **Ranch House**
  - A homeowner presented the board with a quote that he got for a 30'x16' metal building lean to for \$21,000. Slab price not included nor interior build-out
  - Jim Holtzman showed the board members a design of a 20x40 wood frame building (approximately \$60K-\$65K – price includes slab, insulation, electrical, etc. Does not include installation cost. Will need to be constructed by neighborhood) Jim will fine tune costs
  - Kevin Hoover showed the board members a design that was approximately \$47K with a slab included in price, with company doing the installation. Price does not include interior build-out. Approximate cost with interior build out is \$62,000.
  - Board will have the pricing and detail for the options so it can be presented to the community for their vote at next meeting
