All projects must be turned into the St. Marys Chamber Office on 301 E. Spring St., St. Marys by Monday August 5<sup>th</sup> at 4:00pm to be judged. Artwork will be displayed at the Chamber of Commerce Office during SummerFest and after. You may pick up your artwork as early as Monday August 12<sup>th</sup>, but you can also leave it in our office for a week or two so people can come see it. We do ask that all artwork be picked up no later than August 26<sup>th</sup>. Artwork that is left at our office after September 26, 2024, will be discarded if not picked up.
