If you have not exhibited at the Verde Valley Fair in the past two years, please list references from other fairs or exhibitions you have worked. Include name of event, date, contact name and telephone (please use additional paper if needed).

All contracted concessionaires are required to provide product and general liability certificates of insurance for \$1 million prior to set-up. Workman's Compensation Insurance is required for those not self-owned and operated.

If for any reason, you cancel within sixty (60) days of the fair, all monies will be forfeited to the Verde Valley Fair Association, Inc. Any cancellation earlier than sixty (60) days before the fair shall be subjected to an administrative/cancellation fee (\$50.00). If you are not assigned a location, your monies will be returned.
