At the beginning of this month, a couple of hundred ladies came to Celebration Center's new location and were blessed and strengthened by the ministry of Natalie Runion. She encouraged and challenged them to embrace the call of God on their lives, to persevere, stay in and serve the local church.

#### 2023 DECORUM REPORT

#### **SECTION I** - 2023 DECORUM REPORT

#### 1. RULES OF ORDER

- A. Robert's Rules of Order shall govern the business procedure of the convention in all cases not specified herein.
- B. Robert's Rules of Order shall apply to all alike.

#### 2. BAR AND HOURS OF BUSINESS

- A. The chairperson shall set the limits of the bar and shall appoint a timekeeper.
- B. Hours of business shall be according to the time necessary to conduct the business of the convention.

#### 3. **REPORTING**

- A. The committee chairperson or an appointee shall read the committee report and move the adoption of the report. After a second motion has been secured, Conference members may refer to paragraphs for amendment.
- B. The report of Pacific Western Network Ministries, also referred to as Conference officials shall be limited to

five minutes except the Superintendent and Secretary who shall be given unlimited time to report. All minister and church reports are to be tabled.

#### 4. DEBATE

- A. No member shall speak longer than two minutes at any one time or on any one question.
- B. A speaker shall confine his remarks to the question before the convention.
- C. A speaker shall be courteous in language and deportment. Personal reflection on the character of fellow members shall not be permitted. This does not prohibit any member from offering constructive criticism regarding the policies and programs of the Conference.
- D. As much as possible, the chairperson shall alternate speakers with opposing views on the topic at hand.
- E. No member shall offer more than one amendment to a numbered topic.
- F. Any new motion must be submitted in writing with ten signatures.

#### 5. VOTING

- A. Absentee or proxy voting shall not be permitted.
- B. Voting on motions, resolutions, and acceptance of reports shall be by voice.

- d. Train, equip, and resource local church Women's Ministries.
- e. Enlist the cooperation of local women's fellowships in denominational and regional ministry projects and in carrying out the statement of purpose of Women's Ministries.
- f. Develop ministry tools that are generational in scope, designed to reach girls and young women for the kingdom of God.
- g. Serve and support the vision of the Conference.
- The Women's Ministries Director shall represent the Conference at Women's Ministry functions locally, nationally, and internationally as necessary.

#### d. CHILDREN'S MINISTRIES

1. The purpose of Children's Ministries is to:

reach boys and young men for the kingdom of God.

- g. Serve and support the vision of the Conference.
- 2. The Men's Ministry Director shall represent the Conference at Men's Ministry functions, locally, nationally, and internationally as necessary.

#### c. WOMEN'S MINISTRIES

- 1. The purpose of Women's Ministries is to:
  - a. Encourage local Women's Ministry leaders and participants to use their ministry gifts as servants of Christ in ministry to women in their congregations, communities, and within the Conference.
  - Encourage women to train and serve in effective Women's Ministry, within the local church.
  - c. Encourage the formation of effective local Women's Ministries.

C. During open hours of the bar, no electronic communication devices shall be permitted.

#### 6. NOMINATIONS AND ELECTIONS

- A. Candidates for Conference Executive Council must be actively engaged as a Licensed or Ordained Minister in the Conference and must be in good standing with a local church within the International Pentecostal Holiness Church (IPHC). In good standing includes, but not limited to personal tithing, and supporting conference events.
- B. Candidates for nomination to the Conference Executive Council must be certified ministerial delegates. Nominations will be submitted for Superintendent, Assistant Superintendent and three at large positions. The names of the candidates shall be submitted in writing, via email or USPS, to the Conference office for eligibility determination to run for the Executive Council within twenty (20) days before the Quadrennial Session.
- C. Nominees for Superintendent that were not elected for the position, will be automatically considered for the Assistant Superintendent if they so choose. Nominees for Assistant Superintendent that were not elected for the position, will be automatically considered for the at large positions if they so choose.
- D. Voting will be limited to eligible nominees on the ballot.

- E. All elections shall be by a majority of all votes cast.
- F. If there is no election on the first ballot, the nominee receiving the fewest votes shall be dropped on the second ballot. If there is no election on the second ballot, the three nominees receiving the highest number of votes shall be run on the third ballot; if there is no election on the third ballot, the two nominees receiving the highest number of votes shall be run on the fourth ballot.
- G. After each vote, a tally will be taken to verify that the number of votes cast is not more than the voting strength determined by the chair for that round of voting. Should the number of votes cast exceed the determined voting strength, that round will be disregarded, and a new vote will be taken.
- H. The number of abstained votes will be tallied and recorded in the minutes.
- When possible, those chosen to count votes will be from different churches and will not be part of the bar. The counters shall not be related to, nor shall they be employees of the nominees. The number of counters will be determined by the Presiding Officer.
- J. If the Presiding Officer appoints a runner to serve him with the tally, the runner shall not be part of the bar.
- K. Only the Presiding Officer, the counters, and the runner may have access to the counting room during election proceedings.

#### b. MEN'S MINISTRIES

- 1. The purpose of Men's Ministries is to:
  - Encourage local Men's Ministry leaders and participants to use their ministry gifts as servants of Christ in ministry to men in their congregations, communities, and within the Conference.
  - Encourage men to train and serve in effective Men's Ministries within the local church.
  - c. Encourage the formation of effective local Men's Ministries.
  - d. Train, equip, and resource local church Men's Ministries.
  - e. Enlist the cooperation of local men's fellowships in denominational and regional ministry projects and in carrying out the Statement of Purpose of Men's Ministries.
  - f. Develop ministry tools that are generational in scope, designed to

Appointees to the various Ministry Councils shall be submitted to the DMD Council for approval and shall serve at the discretion of the Ministry Director and DMD Council.

E. The DMD shall consists of the following ministries:

#### a. YOUTH MINISTRIES

- 1. The purpose of Youth Ministry is to:
  - a. Encourage, promote, and strengthen ministry to youth within the Conference.
  - Develop ministry events such as camps and training within the Conference as appropriate.
  - c. Equip and resource Youth Leaders and local church youth ministries.
  - d. Serve and support the vision of the Conference.
- The Director of Youth Ministry shall represent the Conference at Youth Ministry functions locally, nationally, and internationally as necessary.

L. During election proceedings, no electronic communication devices shall be permitted in the counting room.

#### **SECTION II - RULES AND REGULATIONS**

#### 1. PROGRAM COMMITTEE

- A. The Program Committee shall be composed of the Executive Council, any directors representing functions or departments of the Conference, and one lay member from each District or Cluster appointed by the Council. (Districts or Clusters shall be determined by the Executive Council.) The total number of members serving on the committee shall be no less than 12. The Assistant Superintendent shall serve as chairman.
- B. The purpose of the Program Committee shall be to draft an alternative overall program to be presented to the Conference for ratification. This Committee has the power to alter any ad hoc committee recommendations.
- C. The Program Committee shall meet three months prior to Quadrennial and Biennial Conferences. Additional meetings shall be scheduled as necessary.
- D. The Program Committee shall complete its work and forward copies of the report to all Conference members including church delegates 30 days prior to the Quadrennial Conference.

E. The names and addresses of Committee members shall be included in the report.

#### SECTION III – PACIFIC WESTERN NETWORK MINISTRIES

#### 1. Pacific Western Network Ministries

Pacific Western Network Ministries is a body of believers in Christ who are in fellowship with one another in which ordained and licensed clergy and churches comprise a specified membership in the International Pentecostal Holiness Church (IPHC). They are joined to one another through voluntary acceptance of certain covenants, by which they serve one another, benefit from supporting a shared vision, and from engaging their efforts toward building the kingdom of God in the context of that vision, guidance, and instruction of the denomination.

#### 2. The IPHC Manual

Pacific Western Network Ministries is a member conference of the International Pentecostal Holiness Church (IPHC), and as such is fully bound by and subject to the bylaws and policies of the denomination as expressed in the IPHC Manual (2022-2026) and succeeding editions and amendments, by the stated authority of the General Conference in session, and by the rulings of the Council of Bishops in between sessions of the General Conference (cf. IPHC Manual 2022-2026).

For the purpose of these bylaws, particular attention is drawn to Article II - Organizational Structure- Conferences, and Article III Organizational Structure- Local Churches. When in session the Quadrennial Conference of Pacific Western Network Ministries is the most authoritative body

- A. Discipleship Ministries Division (DMD) is the discipleship ministry of the IPHC. The Executive Council and the DMD Director shall develop and implement programs and practices that are designed to support the local church in its efforts to make disciples.
- B. The DMD shall:
  - a. Promote the general DMD vision whenever possible.
  - b. Develop, train, and encourage each local church to develop an effective discipleship ministry for all ages.
  - c. Encourage each local church to support DMD both financially and through participation.
  - d. Partner with other Conference ministries to enhance discipleship functions within the Conference.
- C. The DMD Director shall be appointed by the Executive Council. Directors of the various ministries under the umbrella of DMD shall be appointed by the DMD <u>D</u>irector and then submitted to the Executive Council for approval.
- D. Each Ministry Director shall serve as a member of the DMD Council. Each Ministry Director shall develop a Ministry Council of not less than three members to assist in the successful work of that ministry.

# SECTION VII - CONFERENCE DEPARTMENTS AND MINISTRIES

#### 1. CHURCH GROWTH AND REVITALIZATION MINISTRIES

- A. The Conference shall make fulfilling the Great Commission top priority by:
  - a. Promoting a vision of growth.
  - b. Planting new churches.
  - c. Revitalizing plateaued or declining churches.
  - d. Providing training to promote growth.
  - e. Providing administrative training.
- B. The Church Growth and Revitalization Director in consultation with the Superintendent, will develop a program of church planting and revitalization. The Conference shall make church planting and church revitalization the highest priority and shall provide church planters physical, spiritual, intellectual, emotional, and relational resources. The Church Growth and Revitalization Director shall be available to churches for consultation.

#### 2. DISCIPLESHIP MINISTRIES DIVISION

When the Quadrennial Conference is not in session, the Executive Council of the Pacific Western Network Ministries will serve as the most authoritative council, board, or committee of the Conference. As such it shall be the primary policy-making body of the Pacific Western Network Ministries between Quadrennial Conference sessions.

#### 3. Pacific Western Network Ministries Bylaws

Where the current IPHC Manual or future editions do not address specific areas, or where its policies and bylaws do not address specific issues and needs to be applicable to the unique ministries, churches and situations of the Pacific Western Network Ministries, the Pacific Western Network Ministries Bylaws will establish policy and guidelines for the Conference that will be adopted in business session at the Quadrennial Conference, and may be amended by the Executive Council of the Pacific Western Network Ministries in between sessions.

In its relationship to the International Pentecostal Holiness Church, Pacific Western Network Ministries functions and operates under what has in the past, been called the traditional Conference model.

#### A. Revision of Bylaws

1. The Pacific Western Network Ministries Executive Council shall serve as the standing committee on revision of Bylaws. All revisions shall be recommended to the Conference in session by the Bylaws Revision Committee.

- The Pacific Western Network Ministries Conference in session may amend and approve changes to the Bylaws. All resolutions offered from the floor of the Conference shall bear at least 5 signatures of other Conference members. The resolution shall be submitted in writing.
- A two-thirds majority vote shall be required to revise the Bylaws between Quadrennial Conferences.
- 4. The Conference Executive Council shall have the authority to amend the Bylaws between sessions of the Annual Conferences.

## SECTION IV- EXECUTIVE COUNCIL

- The Executive Council shall consist of the Superintendent, Assistant Superintendent, Secretary-Treasurer and two Council Members.
- 2. The Executive Council will be elected during the Quadrennial Session. The elected Executive Council shall serve a four-year term and assume office upon election.
- 3. The Conference in session will vote for the Superintendent, Assistant Superintendent and three Council Members.
- 4. The Superintendent shall appoint a Secretary-Treasurer from the three elected Council Members based on their knowledge, skills, and expertise.

- B. The Commission shall assist with financial and loan planning where possible, offering advice and counsel to churches upon request.
- C. A resolution must be obtained from the local church membership before the local church can buy, sell, lease, or encumber, any church property.
- D. A copy of said resolution shall be presented to the Conference Executive Council for authority to obtain a loan from any source to buy, sell, lease, or encumber any church property.
- E. The Executive Council shall request that a lender send any delinquency notices to the Conference office and the Pastor if loan payments are delinquent.
- F. Conference churches seeking to acquire property through rental, conditional use, or lease contract, shall be required to secure approval from the Executive Council.
- G. All Pastors, local Church Councils, or their designees, and all church real estate transactions, shall comply with the Church Properties and Titles in the IPHC Manual when dealing with any property issues.
- H. All churches are required to provide evidence of property and liability insurance to the conference office annually upon renewal.

- 8 When a local church changes pastors, the outgoing pastor should receive compensation from the local church for a minimum of 30 days when possible.
- 9 Local Churches should seek to provide health benefits for their Pastor, spouse and minor children subject to financial capacity of the church.
- 10 Local churches should strive\_to pay the moving expenses of incoming pastors.
- 11 The Superintendent and Senior Pastors should be granted not less than 3 weeks paid vacation annually, and not less than four weeks after five years of continuous service in the same church or office.
- 12 Since 1998, retirement benefits are put into a retirement fund for Superintendents as part of the compensation package.

#### **CONFERENCE PROPERTY**

- 1 The Executive Council shall act as the Conference Property Planning Commission, referred to as the Commission.
  - All applications for loans from any source that exceed \$10,000.00 must first be approved by the local church, whose property is held in trust by the Conference, and then forwarded to the Commission for approval.

- 5. As a member of the Executive Council, the Superintendent shall act as the Chief Corporate Officer and primary visionary and facilitator, to implement and promote the vision of the Conference. The Superintendent shall have the honorary title of Bishop while in office. The duties of the Superintendent are outlined in the current IPHC manual.
- 6. The Executive Council members Superintendent, Assistant Superintendent, and the three at large positions are not limited to a specific number of terms in any one office.
- 7. In the event that an Executive Council Member resigns from the Council, the remaining members of the Council has the authority to fill the vacant position.

The incumbent Superintendent shall stay on the payroll for 30 days to allow for the transition and orientation of the incoming Superintendent.

- 8. The outgoing Superintendent shall be considered as an employee of the Executive Council under the supervision of the new Superintendent.
- 9. Transitional time guidelines for the incoming Executive Council are as follows:
  - A. Within 60 days after the Quadrennial Session, the newly elected Council, in cooperation with the IPHC, shall appoint Ministry Directors necessary to carry out the vision of the Conference.

- B. The Quadrennial Session minutes shall be printed and distributed within six months following the Quadrennial Session.
- C. Within 90 days, the Executive Council, in cooperation with Ministry Directors, shall appoint members to Ministry Councils. Ministry Council members may include church lay members.
  - 1. Where possible, each Ministry Council shall consist of a director and at least three other members.
  - When considering appropriate qualified candidates for the Ministry Councils, consideration should be given to generational and cultural representation whenever possible.
  - 3. All appointments for Ministry Councils shall comply with the IPHC Manual, especially in the areas of reporting and tithing to the Conference and the Covenant of Commitment.
- B. The Executive Council shall develop a written statement of vision and mission for the next Quadrennial Session and send it to Conference members within six months. The vision and mission shall promote the seven core values of the IPHC which are Prayerfully Valuing Scripture, Pentecostal, Holiness,

8 It is highly recommended that all churches be incorporated and submit a copy of the incorporation to the conference office.

#### **RECOMMENDED PASTORAL CARE**

- 1 The local church council should consider their county's median income and their Pastor's experience and tenure of ministry as a starting base for their Pastor's salary and should give a reasonable cost of living raise annually.
- 2 Housing or a housing allowance and utilities should be provided for each pastor.
- 3 Local churches should provide one half of FICA taxes for any of its full-time pastors who have no other means of employment.
- 4 Local Churches are encouraged to provide a monthly retirement fund contribution for their Pastor at not less than 6% of the Pastor's monthly salary.
- 5 Local churches are encouraged to honor their pastors on his or her birthday, and during Pastor Appreciation season each October.
- 6 Local churches are encouraged to provide for their pastors to attend training events, retreats, and other available pastoral or ministry development opportunities.
- 7 The Pastor and Local Church Council should see that guest speakers are paid a liberal sum for their ministry services, and related travel and lodging expenses.

- 1 The Conference fiscal year shall be on a calendar basis, January 1 through December 31.
- 2 Church tithes shall be sent to the Conference office by check or money order, or by electronic means, payable to Pacific Western Network Ministries Inc. by the fifth of each The Monthly Church Report and Church Tithe is also due at this time. The office shall make ministry report forms available on the Conference website.
- 3 Contributions to building fund, missions, and other ministries in the local church are not considered to be church tithes. A local church only tithes to the conference on funds received as tithes and general offerings.
- 4 All funds sent to the Conference office are to be accompanied by a completed church financial and statistical report. IPHC rulings and bookkeeping preferences shall be honored by the Conference when possible.
- 5 All profit from Conference properties sold because of church closure shall be placed into the church growth budget.
- 6 Any pastor leaving a church in financial distress shall not be reassigned until the situation has been rectified with the Conference.
- 7 The Executive Council shall set budgets for all departments under its jurisdiction.

Christ's Kingdom, All Generations, Justice, and Generosity.

- The date and place of the Annual Conference shall be decided by the Executive Council in consultation with the General Superintendent of IPHC.
- 11. The Executive Council shall promote at least one annual event for the Continuing Education Units (CEU) offered to licensed and ordained ministers within the Conference. All licensed and ordained ministers will be required to attend at least one event.
  - A. Continuing Education Unit events will be determined by the Executive Council.
  - B. It is the responsibility of each minister to meet the Continuing Education requirements as stated in the IPHC manual.
  - C. The Executive Council shall establish and oversee the Continuing Education program and compliance thereof.
- 12. Members holding office and voting in the Quadrennial Session shall be certified by the Executive Council. When certifying members, the Executive Council under the authority of the General Conference of IPHC, shall humbly uphold its governing guidelines concerning membership status, office nominations, and eligible voters. (See the appropriate bylaws in the current IPHC Manual).

- Church <u>d</u>elegates and alternates attending the Quadrennial Session shall be certified by the local church council.
- 14. Each church may have one delegate per 25 members. Members is being defined as average Sunday attendance.
  - A. Names must be submitted to the Executive Council not later than 30 days prior to the Quadrennial Session to meet the requirement that each certified attendee receive a copy of the Decorum Report.
  - B. Certificates shall be sent to each church delegate certified to attend the Quadrennial Session. Alternate certificates shall remain on file with the Conference and shall be available at the Quadrennial Session, should the Alternate be needed.
- 15. An Annual Conference orientation meeting shall be conducted. The orientation meeting shall be mandatory for all newly Licensed and Ordained Ministers and incoming transferees. Meeting agenda shall include, but not be limited to the following:
  - A. Resources and contacts available through the Conference and the IPHC.
  - B. Each Conference department's function
  - C. The Conference and IPHC obligations
  - D. Use of current forms and publications
  - E. Conference calendar

#### SECTION V - COMMUNICATIONS AND PUBLICATIONS

- 1 Conference News
  - A. Superintendent or designee shall provide important Conference news and events guided by the vision and mission of the Conference as needed.
  - B. The newsletter will be sent to ordained and licensed ministers and local church ministers.
- 2 Conference Calendar
  - A. The conference shall maintain a calendar of events on its website.
  - B. Conference departments shall submit their upcoming year's calendar of events by September 1, whenever possible.
- 3 <u>Church Communications</u>
  - A. Ordained Ministers, Licensed Ministers, and Pastors and/or appointees are encouraged to develop communication skills using email and other new technologies.
