TOP POOL RULES TO KNOW PRIOR TO ENTERING POOL AREA

- 1. Current pool tag is required to enter
- 2. A Member (or their tenant) with a current pool tag must accompany all guests. Only **TWO** guests are allowed per address.
- 3. Children twelve (12) years old and under must be accompanied and supervised by an adult eighteen (18) years or older at all times.
- 4. Lifeguards are not responsible for the supervision of underage children.
- 5. Only children six (6) years of age and under may use the wading pool. These children must be accompanied by an adult eighteen (18) years or older.
- 6. All swimmers must wear bathing suits- no cut-off jeans allowed.
- 7. Persons with open cuts and sores are not allowed in the pool.
- 8. No running or horseplay in the pool area.
- 9. No skateboards, bicycles, hover boards, etc. are allowed in the pool area.
- 10. No loud, abusive, or vulgar language.
- 11. No pets, except service dogs allowed on premise.
- 12. No glass allowed in the pool area.
- 13. No food, drinks, or gum allowed in the pool.
- 14. No alcoholic beverages.
- 15. No diving.
- 16. Only lifeguards are allowed in/on the guard stand.
- 17. Patrons should not talk to the lifeguard on the stand unnecessarily.
- 18. Deposit all trash in the garbage cans provided- Please don't litter.
- 19. Failure to follow the rules may result in immediate removal from the pool area.
- 20. The lifeguards on duty have full authority to enforce all rules pertaining to safety at the pool.
- 21. Use of these facilities is at your own risk.
- 22. Illegal and/or criminal conduct is not permitted and violators will be escorted from the facility.
- 23. ADDITIONAL POOL RULES ARE POSTED WITHIN THE POOL AREA.
- 24. INCASE OF AN EMERGENCY DIAL 911, EMEGERECY PHONE LOCATED ON WALL BETWEEN RESTROOMS.
