GUIDELINES FOR IN-PERSON CONSULAR SERVICE APPLICANTS

WHAT TO DO BEFORE GOING TO THE CONSULATE



- Go to the website:
www.newyorkpcg.org
- Schedule an appointment.
NO APPOINTMENT. NO ENTRY
- Download and complete Passport application
- Prepare further requirements (photocopies, IDs, or other necessary documents)
- Bring USPS prepaid envelope, and cash or money order (payable to Philippine Consulate General in New York)



Walk-in applicants will not be entertained.

GUIDELINES FOR IN-PERSON CONSULAR SERVICE APPLICANTS

WHAT TO DO WHILE AT THE CONSULATE



- Applicant will be allowed to enter 15 minutes before their appointment
- A mask is required to enter the facility
- Your temperature will be checked using a non-contact thermometer. If your temperature is 100.4F or higher, you will be asked to go home.
- Only applicant is allowed to enter unless accompanying a minor, very elderly, pregnant or disabled
- Please practice social distancing (6 ft apart)

Please be advised that late applicants will lose their slot & will need to reschedule.
