OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS OF EMMONS COUNTY, NORTH DAKOTA AT IT'S REGULAR MEETING OCTOBER 7, 2025

Chairman Dan Materi called the meeting to order at 9:00 A.M. with Commissioners James Gartner, Erin Magrum, Craig Miller and James Vander Vorst being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

The September, 2025 end of month fund balance report and the year to date expenditure reports were distributed to the board.

Commissioner Magrum motioned to approve the minutes of the September 2, 2025 regular meeting. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the agenda as presented. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Old and Unfinished Business:

Chairman Materi and Commissioner Miller asked States Attorney, Joseph M. Hanson, if there were any responses from the four individuals regarding the Glencoe fire expenses from April 12, 2025, and also asked for copies of the letters that were sent. Joseph M. Hanson responded by asking the commissioners to stop by his office for copies after the meeting.

New Business:

VA Officer, Brad Huber, appeared and gave his quarterly report.

Acacia Stuckle and Nancy Deis, Extension Agents, provided a quarterly narrative report.

The list of real estate property forfeited to the county due to delinquent taxes, pursuant to NDCC 57-28-10 was reviewed by the board. Commissioner Magrum motioned to set the value for all three properties at the recommended sale price. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Gregory A. Lang submitted a building permit to erect a 42 X 42 pole barn on Lot 4, Block 2, Missouri Hills Estate, Section 23, Township 132, Range 79. According to Josh Odden, the lot is only .3 acres and the setbacks per county's zoning ordinances puts the building too close to the road and to the neighbor's lot. After discussion, Commissioner Magrum motioned to deny the building permit. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried. Gregory A. Lang mentioned that he could shrink the size of the building and move the location of the building to the north. After more discussion, Commissioner Magrum motioned to approve the building permit for Gregory A. Lang contingent that Josh Odden gives final approval and the setbacks are following the county's zoning ordinances. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

The agenda included an opportunity for an individual in attendance to provide public comment pursuant to Senate Bill No. 2180.

Russell Lawler, Road Superintendent, provided a monthly update on activities for the county road department and also provided an update on the Strasburg shop energy grant project. The contractors are hauling gravel, the road department employees are installing culverts and blading. The road department employees were present to discuss sick leave and vacation policies, and also pay for emergency situations. The consensus of the board was to follow the current employee handbook and consult with our Human Resource Consultant before making any amendments to the handbook.

Jon Martin, PE, Wold Engineering, P.C., appeared to present a settlement agreement for payment to cover the cost for additional dirt needed to meet the new elevation, change order #1, Project #BR-0015(21) PCN 23706, 3 Mile North & 9 Mile East of Strasburg, Bridge Structural removal and replacement. Commissioner Gartner motioned to approve the Settlement Agreement and General Release between Emmons County and Wold Engineering, P.C. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the building permit for T-Mobile (Crown Castle) to remove existing batteries in secure ground cabinet and replace with new batteries on FCL SE ¼ Less 2.6 Acres to NB Pipeline, Section 4, Township 132, Range 76. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Vander Vorst motioned to approve the building permit for Craig Miller to move in a 40 X 20 wooden granary on the NE ¼ Less RW, Section 30, Township 134, Range 76. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi and Vander Vorst. Motion carried. Commissioner Miller abstained from voting due to conflict of interest.

Commissioner Gartner motioned to approve the building permit for Carter VanderWal to erect a 60 X 90 Shop on the SW ¼ of Section 2, Township 129, Range 78. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the building permit for Kim Lees to add a 42 X 20 lean-to along the west side of the existing pole building on Lot 21 and .61A Tract and .90A Tract of Lot 20, Beaver Bay Subdivision, Section 23, Township 132, Range 79. Seconded by Commissioner Magrum. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the building permit for Kim Lees to add a 40 X 12 lean-to on Tract of Lot 4, Section 33, Township 132, Range 79. Seconded by Commissioner Magrum. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Vander Vorst motioned to approve the building permit for Gregory Metzger to erect a shed and deck on Lot 4, Burgad Views, Section 23, Township 132, Range 79. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Vander Vorst motioned to approve the building permit for Myron Huber to move in a 26 X 76 manufactured home and build a 40 X 45 garage on North 78' of Lot 7, Meyer Subdivision, Section 32, Township 129, Range 78. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the building permit for New Cingular Wireless PCS, LLC to remove six antennas, install nine new antennas. Remove six RRH radios, install nine new RRH radios. Remove three TMA, remove six diplexers, remove all COAX lines, update power/fiber cables and surge protectors on FCL SE ½ Less 2.6 Acres to NB Pipeline, Section 4, Township 132, Range 76. Seconded by Commissioner Magrum. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Magrum motioned to approve the Plat of Lot 1 of QCD Life Estate in the SE $\frac{1}{4}$ of Section 33, Township 135, Range 75. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the application for abatement or refund of taxes for parcel #28-0000-03839-010 for tax year 2025. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the building permit for Doug Coyle to build a 26 X 36 garage on Lot 4, Coyote Hills Subdivision, Section 23, Township 132, Range 79. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miler and Vander Vorst. Motion carried.

Commissioner Magrum motioned to approve the building permit for Syd Lawler to replace the machinery storage building destroyed by a tornado and to erect a 42' diameter grain bin on the SW ¼ of Section 1, Township 132, Range 79. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Miller motioned to approve the following Utility Permits:

- * South Central Regional Water District to install one-inch waterline crossing on 18th Avenue SE from the SW ¼ of Section 30 to the SE ¼ of Section 25, Township 129, Range 75.
- * KEM Electric Cooperative, Inc. to install and maintain the facilities on county right-of-way on Sections 8 & 17, Township 129, Range 76.
- * Jack Dockter to install and maintain the facilities by boring a waterline under Main Avenue.

Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the Memorandum of Understanding between the North Dakota Secretary of State's office and Emmons County, North Dakota for providing an accounting of the election equipment in Emmons County's care and outlines the expectations for both the Office of the Secretary of State and Emmons County in ensuring the proper use, storage, maintenance, and administration of the election equipment. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Magrum motioned to respond to the Bureau of Land Management's invitation to become a Cooperating Agency with the Bureau of Land Management in preparation of an environmental impact statement for a revision to the current North Dakota resource management plan by stating that Emmons County does not desire to become a cooperator at this time, but requests that our address be added to the project mailing list to receive notification of public meetings and the availability of draft documents for public review and comment. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Director of Tax Equalization, Christina Seppanen, presented an updated spreadsheet listing what other county's in North Dakota charge for assessing, and recommended that Emmons County increase the rate from \$1.00 per parcel to \$3.00 per parcel plus mileage for the equalization meetings. After discussion, Commissioner Gartner motioned to take Christina Seppanen's recommendation of \$3.00 per parcel and mileage for

equalization meetings. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Per Senate Bill 2367, the State requires Tax Directors, in coordination with county governing body, to develop a schedule of soil modifiers to be used in adjusting agricultural property assessments. Director of Tax Equalization, Christina Seppanen, stated that her office has conducted a review of land characteristics that affect agricultural productivity. While the Productivity Index already accounts for a wide range of soil-related limitations such as salinity, sodicity, erosion, gravel content, drainage challenges, and the presence of rocks, certain chronic, localized conditions may not be fully reflected in current valuations. One such condition is longterm water retention in low-lying areas that consistently impacts crop performance. To maintain efficiency, consistency, and manageability in the assessment process, the Tax Director office is recommending Old Water as the only modifier for Emmons County. Limiting the number of modifiers will help minimize administrative burden, reduce the frequency and complexity of reviews, and ensure that the application of modifiers remains consistent and defensible across the county. Old Water refers to low-lying areas or depressions in the landscape that have been prone to ponding or retaining water consistently for at least the past ten years. These conditions must cover a minimum of ten acres and result in crop loss or reduced yields. Parcels or areas actively used for grazing or pasture are not eligible for the Old Water modifier. The modifier is intended solely for land where water retention significantly impacts crop production, not for land still capable of supporting livestock grazing or similar agricultural uses. After discussion Commissioner Magrum motioned that Emmons County create Old Water as a modifier to the Tax Assessor's office for parcel valuations. This process starts with applying at the Tax Assessor's office and the GIS department, and then present that application to the County Commissioners where they will either approve or deny the application. The approval would be a ten-year exemption or reduction of taxes. The applicant would need to reapply after ten years. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried. Commissioner Magrum also motioned to value the land for the Old Water the same as the permanent water valuation. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

The Commissioners received a letter from a resident along with other phone calls regarding Conex boxes in the recreation district. The boards general agreement was to uphold Resolution 22-03-01 adopted by the Commissioners on July 5, 2022 regulating mobile homes, Conex boxes and other structures.

Donavin Grenz reappeared to further discuss a building permit for a storage building. Linton City denied the permit due to FEMA's set policy. A violation to FEMA's policy may put the jurisdiction at risk for removal of participation in the National Flood Insurance Program (structure and contents) for the entire jurisdiction. Regardless of whether Grenz is in the city or county, he is within the $\frac{1}{2}$ mile jurisdiction and FEMA/NFIP regulations remain the same.

States Attorney, Joseph M. Hanson, explained the process for creating a County Zoning Board (Planning Commission). NDCC 11-33-02 and 11-33-04 states that a board of county commissioners may create by resolution a county planning commission to prepare and administer zoning regulations. The resolution must appear in the board minutes and be kept on file in the Emmons County Auditor's office. Commissioner Miller motioned to adopt the following Resolution:

RESOLUTION 25-10-01

$\frac{\textbf{RESOLUTION ESTABLISHING THE EMMONS COUNTY PLANNING AND ZONING}}{\underline{\textbf{COMMISSION}}}$

WHEREAS, N.D.C.C § 11-33-02 authorizes boards of county commissioners to regulate and restrict the location and use of buildings, structures, and land for trade, industry, residence, or other purposes through county zoning regulations; and

WHEREAS, N.D.C.C. § 11-33-04 provides that a board of county commissioners may, by resolution, create a county planning commission for the purpose of preparing and recommending zoning resolutions and performing related planning functions; and

WHEREAS, the Board of County Commissioners of Emmons County, North Dakota, desires to exercise its zoning authority and establish a county planning commission to be known as the Emmons County Planning and Zoning Commission to prepare a comprehensive plan and zoning resolution for the unincorporated areas of the county and to carry out the duties specified in Title II, Chapter 33, of the North Dakota Century Code.

NOW, THEREFORE, BE IT RESOLVED by the Emmons County Board of County Commissioners as follows:

1. Creation.

The Emmons County Planning and Zoning Commission is hereby created pursuant to N.D.C.C. § 11-33-04.

2. Membership.

The Commission shall consist of nine (9) members, appointed by the Board of County Commissioners as follows:

* At least two (2) members shall be appointed from the governing body of the City of Linton, the county seat;

- * Not more than two (2) members shall be members of the Emmons County Board of County Commissioners; and
- * The remaining members shall be appointed from the county at large. Because Emmons County elects' commissioners who reside in specific districts, at least one at-large member shall be appointed from each of the five (5) commissioner districts, as required by N.D.C.C. § 11-33-04.

3. Terms of Office.

The initial terms of the appointed members shall be staggered so that approximately onethird of the terms expire each year thereafter. Subsequent appointments shall be for threeyear terms or until a successor is appointed and qualified.

4. The Planning and Zoning Commission shall hold its organizational meeting within thirty (30) days after the appointment of its members, shall elect a chairperson and such other officers as it deems necessary, and may adopt bylaws governing its proceedings. (N.D.C.C. § 11-33-05).

5. Secretary.

The Emmons County Auditor shall serve as the secretary to the Planning and Zoning Commission, shall maintain its official records, and shall provide clerical assistance as Necessary, (N.D.C.C. § 11-33-06).

6. Duties and Powers.

The Commission shall perform all functions prescribed by law, including:

- * Investigating and preparing proposed zoning resolutions and amendments;
- * Holding public hearings as required by law;
- * Making recommendations to the Board of County Commissioners concerning adoption, amendment, or repeal of zoning regulations; and
- * Performing such other planning functions as the Board may delegate by motion or resolution.

7. Filing.

APPROVED:

A certified copy of this Resolution shall be filed in the office of the Emmons County Auditor, and shall be maintained as part of the permanent records of the Board of County Commissioners.

Commissioner Magrum motioned for the Emmons County Planning and Zoning Commission to be compensated \$100.00 per meeting. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner and Commissioner Miller volunteered to serve on the Emmons County Planning and Zoning Commission as members of the Emmons County Board of County Commissioners.

Noted was the Public Service Commission Public Hearing on the application for the Emmons-Logan Energy Storage, LLC project will be held on November 20, 2025 at 9:00 A.M. at the Emmons County Courthouse Auditorium.

Commissioner Gartner motioned to adjourn the meeting and reconvene at 6:30 P.M. for the county budget hearing. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

At 6:30 P.M., a public hearing was held on the proposed preliminary budget for calendar year 2026 at which time written or oral comments from the public will be considered concerning the proposed annual budget.

Sharon Schiermeister questioned what the bulk of the \$164,467.91 increase in property tax revenue covers and also asked about expenditures paid out of the general fund including employee salaries and benefits. Auditor Ohlhauser explained that there's a new mill levy for supporting the airport and other increases are from the county road and bridge fund, and the county general fund where there's an increase in election costs, audit examination costs and other overall increased costs throughout departmental budgets.

David Moch Inquired about the airport mill levy suggesting that the county remove the levy and hold a public meeting in the future for details of what this taxable revenue all details. Commissioner Gartner stated that the Commission had discussion with the Airport Board at the July 1, 2025 commission meeting and emphasized that the county is not taking on any debt. The mill levy will be used to help with a shortfall that the airport has been experiencing, rather than losing a twelve-million-dollar airport that is used by landowners for spraying and for emergency services. The airport is a federal airport. David Moch asked about charging pilots a quarter or dime per acre to the farmers so the money comes back to the airport.

Airport Board Member, Roger Martin, was present and stated that McIntosh County has a county airport mill levy that is split between the Ashley Airport and the Wishek Airport. Engineers have written federal grants where the airport was awarded with a cost share of 5%, state share of 5% and the federal share was 90%. These grants were used for project improvements to the airport over the past ten years.

Roger Martin stated that the airport has a five-member board with one vacancy and possibly another two with all serving from the Linton area. They would like to fill the vacancies with at least two members from the county. There can be a name change possibly the "Emmons County Airport" because the airport provides services for the entire county. Shall this move forward, the state wants 100% of their input making sure everything gets changed over.

Stephanie Doolittle suggested that the board ask the big agricultural companies flying out of the airport to make annual donations towards the airport.

There was further discussion to the 2026 county budget to include the grade/step salary structure. Commission Magrum motioned to approve and adopt the 2026 county budget which includes the grade/step salary structure without any changes. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Chairman Dan Materi called the meeting to order at 9:00 A.M. with Commissioners James Gartner, Erin Magrum, Craig Miller and James Vander Vorst being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

The August, 2025 end of month fund balance report and the year to date expenditure reports were distributed to the board.

Commissioner Vander Vorst motioned to approve the minutes of the August 5, 2025 regular meeting and the August 12, 2025 special meeting. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the agenda with the addition of gravel update. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Old and Unfinished Business:

Commissioner Miller asked States Attorney, Joseph M. Hanson, if bills were sent to the suspects for the costs incurred by the county in suppressing the Glencoe Fire on April 12, 2025 where Mr. Hanson replied that he did send out the letters.

New Business:

As advertised, at 9:15 A.M., a public hearing was held to receive public comment and direction in regards to a Petition to close the section line described as follows: a portion of the section line, lying between Parcel No. 27-0000-03703-000 and Parcel No. 27-0000-03722-010. Specifically, the portion of the section line from the Southwest Corner of Section 17, Township 132, Range 76, and running East until it reaches the east edge of Parcel No. 27-0000-03804-020. The portion of the section line to be closed is approximately 780.7 feet, and the land on the north side is owned by Kenneth and Doris Jochim. Said petitioner hereby petitions the Emmons County Commissioners to close the above-described section line between the above-described property, pursuant to NDCC 24-07-03.

Chairman Materi opened the public hearing and asked Petitioner, Kenneth Jochim, to come forward to explain his reasoning for petitioning to close the section line. Mr. Jochim commented that he's not trying to cause problems nor step on anyone's toes as he just wants to plant some trees on a section line that leads to nowhere. "There's waterways and no approaches, so in order to get to land you have to drive on private property." The section line is encroached upon with tires and concrete, and Mr. Jochim just wants everyone to follow the same rules. There's a thirty-three-foot easement from the center of the section line, and he doesn't have a problem with anyone using the section line so long as everyone follows the thirty-three feet rule.

Commissioner Magrum stated that the section line was probably never developed or utilized because it dead ended to the railroad, and now that the railroad is gone, the road could become more usable.

Commissioner Gartner stated that if somebody told you to go out and drive this section line, you would struggle on trying to figure out where to drive.

Mark Andresen, son-in-law of landowners Leo and Carol Bosch, was present and stated that their main concern is getting access to a piece of property which is a huge amount of their acreage. This section line is the only access to a portion of their property from Highway 83. There's a spillway behind their barn for access, but when the river floods the only access is this section line. Mr. Andresen concluded that the county re-builds this section line to fit everyone's needs and requested that the petition to close the section line be denied.

Present was Leo Bosch who suggested that the county blade the road making the section line straight so it's drivable, and install a culvert so nobody has to drive on other people's property to access their property.

Commissioner Magrum motioned to deny the Petition to close the section line. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Magrum motioned that proper notification be sent to the landowners that encroachments have to be removed off the section line right of way. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Vander Vorst motioned to approve the building permit for Tanner and Natasha Dosch to build a 28 X 46 family lake cabin on Lot 5 of Lot 46A Walther's Subdivision and easement area in Section 23, Township 132, Range 79 contingent upon approval from Western Plains Public Health for their septic and drain field permit application. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the application for abatement or refund of taxes for parcel #52-0013-00783-000 for tax year 2025. Seconded by Commissioner Magrum. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Magrum motioned to approve the building permit for AT&T Mobility to upgrade their equipment on the existing cell tower located on the W ½ W ½ of Section 26, Township 130, Range 79. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

The Central Dakota Six County Commission meeting will be held on September 9, 2025 at 10:00 A.M. at Carrington.

Commissioner Gartner motioned to approve the building permit for Andrew Vetter to construct a 55 X 46 home with a 38 X 26 attached garage on the Southwest corner of Section 1, Township 132, Range 74. Seconded by Commissioner Magrum. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Vander Vorst motioned to approve the application for a local raffle permit for District 8 Republican Party of North Dakota. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Jon Martin, Civil Engineer for Wold Engineering, P.C., is submitting three projects for flex grant funding for years 2026 and 2027. Presented were two options for funding project #1, 17th Avenue SE grade raise north of Braddock where the Commission agreed to apply for funding using option #2 funding 51% of the construction costs with Federal Aid Funds and funding the remainder 49% of construction costs plus 100% of the engineering with flex grant funds. The engineer's estimate for this project is \$2,912,465.

Russell Lawler, Road Superintendent, provided a monthly update on activities for the county road department. There were hands on and classroom training at the county shop for the new operators for pulling shoulders. Also, four employees attended a class in Fargo for installing culverts. The county was approved for an energy grant through the ND Department of Commerce for spray foam insulation, repairing the chimney and a wall and for new LED lighting in the Strasburg shop and new LED lighting at the Linton shop. The board reviewed a quote from RTS Shearing, LLC for crushing and stockpile gravel. There was some discussion regarding a request for temporary cattle crossings.

Commissioner Magrum motioned to approve the Utility Permit for South Central Regional Water District to install 10" and 12" PVC Pipeline for service to Napoleon MTL Expansion. Four Crossings, 78th St. SE, 17th Ave SE, 79th St. SE and 23rd Ave SE and to approve the Utility Permit for KEM Electric Cooperative to bore underground primary cable under gravel roadway at a minimum depth of 48" from the intersection of 69th St. SE and 23rd Ave SE. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

The agenda included an opportunity for an individual in attendance to provide public comment pursuant to Senate Bill No. 2180.

The board reviewed a preliminary budget proposal for the year 2026 prepared by County Auditor/Treasurer, Marlys Ohlhauser, for the general fund and each special revenue fund with detailed breakdown of estimated revenues and expenditures for the preceding year, current year and ensuing year and the appropriations requested. A budget hearing is scheduled for October 7, 2025 at 6:30 P.M.

Commissioner Magrum motioned to enter into a contract with RTS Shearing, LLC to crush 25,000 tons of class 13 gravel and to crush 25,000 tons of class 5 gravel for a total of \$450,000.00. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Jeffry Verdoorn appeared to discuss the building permit application for Candace Verdoorn for placing two 8 X 40 shipping containers twenty feet apart with a roof placed to connect for storage on Lot 30, Subdivision of Lots 22-31 and Lots 8B and 8C, Rudy's Subdivision 1A, Section 5, Township 130, Range 79. Jeffry Verdoorn stated that his intentions are to insulate, wire and heat the containers and use them as work sheds.

Emmons County Commission reviewed Resolution 22-03-01 that was adopted on July 5, 2022 that specifically regulates Conex boxes or similar structures by adding a provision that there shall be a limit of one Conex Box per lot. In order to approve this permit, a variance would need to be granted. Following further discussion, Commissioner Magrum motioned to deny the building permit application. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried. The Commission will re-visit the matter in November or December.

Christina Seppanen, Director of Tax Equalization, provided information to the commission for determining whether a Battery Energy Storage System (BESS) is centrally or locally assessed.

Donavin Grenz appeared to discuss the building permit application to erect a 60 X 40 storage building on site of former Heyerman house with a 60 X 40 detached garage located on Block 5, Section 7, Township 132, Range 76, Patterson's Addition in Linton City. Following discussion relative to this property being in the floodway and subject to FEMA building regulations, Commissioner Gartner motioned to deny the building permit based on the grounds that Mr. Grenz needs to obtain a building permit from the City of Linton. Seconded by Commissioner Magrum. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commission Magrum was designated as Emmons County's Voting Delegate for the NDACO annual business meeting held in October.

Commissioner Gartner motioned to remove Ardella Deis and add Marlena Hartze-Kelsch on all bank accounts with BNC National Bank, Strasburg State Bank, Bank of Hazelton, Hometown Credit Union and Unison Bank. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Zoning Ordinance update discussion was held. Commissioner Magrum stated that in light of the discussions from previous public hearings and reviewing Sheridan and Dunn County's zoning plans, he has a few ideas for consideration. One suggestion was a \$600 nonrefundable application fee for a conditional use permit. Once the permit is approved then have a permit fee structure. Sheridan County's is 1/10th of 1% of the cost of construction. Another suggestion was a 120-day option of review for the board to review and act on a conditional use permit application or zoning decision. Dunn County has defined process with stages that defines the sequence of steps that an application needs to go through. Another suggestion was having a minimum and maximum permit fee schedule, and also implementing a fee schedule to accommodate financing options to ease burden. There was also discussion on having only one permit application. States Attorney, Joseph M. Hanson, will draw up a proposed Resolution for the October meeting.

OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS OF EMMONS COUNTY, NORTH DAKOTA AT IT'S SPECIAL MEETING AUGUST 12, 2025

Chairman Dan Materi called the meeting to order at 9:00 A.M., with Commissioners James Gartner, Erin Magrum, Craig Miller and James Vander Vorst being present. Also present was States Attorney Joseph M. Hanson.

The Pledge of Allegiance was recited.

Chairman Materi welcomed everyone to the meeting and asked the commission if they had any questions or wanted more discussion regarding the conditional use permit application submitted by Emmons-Logan Energy Storage, LLC to construct, operate or maintain an Emmons-Logan Energy Storage Project in Emmons County.

Commissioner Miller asked NextEra Energy Resources Representatives how they arrived at the 7.2 million in property taxes over the life of the project? Clint Scherb, Project Developer for NextEra Energy Resources, replied that NextEra Energy Resources hired a third-party economic studies group that did their analysis pertaining to the property taxes, and are pretty certain that the property taxes spent over the twenty-five-year period would equal between five to seven million. Commissioner Miller asked how they came about this figure as North Dakota doesn't have anything set up for battery storage taxes? According to Clint Scherb, NextEra Energy Resources reached out to the state, but they indicated that they can't give a firm number right now. The analysis did confirm from a couple different groups that the project would be locally assessed because it's not utility owned.

State's Attorney, Joseph M. Hanson, stated that he visited with Christina Seppanen, Director of Tax Equalization, and she's concerned about the project being locally assessed because the batteries themselves being personal property, rather than being taxed as real property. Joseph M. Hanson asked NextEra Energy Resources if they could file an affidavit of attachment or consider those facilities and equipment to be real property that can be assessed? Casey Furey, Crowly Fleck Law Firm, responded that this question would have to be brought back internally to be discussed as they don't know if they could commit. They've been communicating with the ND Tax Commission who is unable to provide a firm number at this time, but are working on their framework.

Commissioner Vander Vorst asked if NextEra is changing its holdings or changing the company to XPLR? Clay Cameron, NextEra Energy Resources Director of Development, responded that XPLR is a separate company outside of NextEra Energy Resources and are the transmission owner entity that owns their transmission assets.

Chairman Materi felt that after Tuesday's public hearing, the commission have to pull the brakes on this project, and get the permit fee that was approved in August 22, 2022 cleared up. It's clear that this project is an industrial project, and out of good faith, we cannot accept the \$62,000 when the permit fee should be 3% of the \$181 million-dollar project. Clint Scherb responded understanding the commission believing that the application fee of 3% of the project costs applies to industrial types, not meaning the zoning of the land or the district that it's zoned in, but the type of project. Mr. Scherb continued by stating that they understand the context now after reviewing the commission meeting from Tuesday morning prior to the hearing where a gentleman presented some context. And after communicating our concerns regarding the applicability of the fee for this project, and believe the basis of the amount of the fee is unclear, and because of the late stage of our permit application, NextEra Energy Resources wants to agree to the 3% of the project costs for the fee. For the purpose of calculating the fee, they looked at the total project costs of the infrastructure, including batteries and inverters. The project costs would be \$132 million equating to a \$3.96 million application fee. NextEra Energy Resources is requesting to pay in a milestone type paying ten percent upon conditional use permit approval, forty percent after Public Service Commission approval, and fifty percent within thirty days upon construction.

There was some discussion relative to paying the permit fee in one lump sum or agreeing to the milestone payment schedule. Commission Magrum agreed to NextEra Energy Resources idea of paying the permit fee in portions and thought it was an excellent idea. This is usually how contractors operate when doing jobs, they require so much money down and throughout the phases, you have a payment schedule.

Commissioner Gartner commented that the wind farm conditional use permit fee was \$27,000 and NextEra Energy Resources is offering \$3.96 million for this project. This moves us forward ensuring that whenever there's projects, there's an economic impact.

Commissioner Vander Vorst commented that the project seems lucrative to the county; but it doesn't change the scope of the project for him, and he has to vote his conscience, and not his pocketbook.

Commissioner Magrum motioned to approve the Conditional Use Permit for Emmons-Logan Energy Storage, LLC to construct, own, and operate the Emmons-Logan Energy Storage Project with a fee of \$3.96 million, and agree to their permit fee schedule. Seconded by Commissioner Gartner. During discussion, Commissioner Miller stated that when the commissioners took this job, it was for the betterment of the county to do what was right for the county, and to protect the citizens of the county. Commissioner Miller also stated that he heard nothing about this project that really scared him and didn't hear any objections from the landowners in the area of the project. Commissioner Magrum commented that by putting a percentage amount on these permits is just trying to gain some value because most of these projects that are

coming into the county are low impact or have no impact when to comes to fulltime employment. Chairman Materi stated that his concern is that the permit fee should be a full amount paid upfront of the project and put into an escrow account that stays there until the project is completed. A roll call vote was taken. "YES": Gartner, Magrum, Materi and Miller. "NO": Vander Vorst. Motion carried.

There being no further business before the board, Commissioner Magrum motioned to adjourn. Seconded by Commissioner Gartner. The meeting adjourned at 10:00 A.M.

Chairman Dan Materi called the meeting to order at 9:00 A.M. with Commissioners James Gartner, Erin Magrum, Craig Miller and James Vander Vorst being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

The July, 2025 end of month fund balance report and the year to date expenditure reports were distributed to the board.

Commissioner Magrum motioned to approve the minutes of the July 1, 2025 regular meeting. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the agenda with the addition of oil tank discussion. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Old and Unfinished Business:

Commissioner Magrum stated that Skyler Prellwitz called him and provided a history on the county oil tank. The tank was purchased from Purple Wave Auction from a county in SD for \$2,500.00 plus another \$3,000.00 for freight. The heating system was dismantled because they had to take it apart in order to haul it. Skyler had plans on contacting one of the Heating and Air business's for putting the heating system back together. The cost for a new oil tank is \$200,000.

New Business:

Strasburg Care Center Administrator, Robert Sheckler, appeared to provide an update on a proposed new facility in Strasburg. The new building project was announced at their annual picnic that had great community support serving over 350 people. The new project site would be across the street from the current care center where 4.5-5 acres have been secured. The cost of the new facility is eighteen million dollars. Mr. Sheckler is currently applying for a loan through the Bank of North Dakota for five million dollars. The ND Legislatures passed a bill appropriating funding for new building projects for nursing homes with current facilities needing to be at least thirty years old. The maximum that the Care Center can borrow is ten million dollars. The remaining three million dollars is being requested from the county. States Attorney, Joseph M. Hanson, is researching a possible bond guarantee fund relating to nursing homes that would require placing a measure on the ballot for a voter approved mill levy. Robert Sheckler will also reach out to Lewis and Clark Regional Development Council and the Long-Term Care Association for resources.

The Commission instructed States Attorney, Joseph M. Hanson, to seek civil damages from the suspects for the costs incurred by the county in suppressing the Glencoe Fire on April 12, 2025.

The board reviewed the pay grade and pay step structure organizing and compensating employees based on factors such as job responsibility and longevity from a blue print previously used by Pam Binder, previous Emmons County Human Resources.

Russell Lawler, Road Superintendent, provided a monthly update on activities for the county road department. The road department has been busy graveling, blading and installing culverts. Next week, plans are to work on the road by the Wolbaum Pit and then gravel/blade the road west of Hazelton on 67th St. SW.

The county is submitting applications requesting Flex Funding for road projects to include 17th Ave SE Grade Raise north of Braddock, Patching and Overlay on Linton shop road and Strasburg West on CMC 1536 and Cattail Bay Road Cement Stabilization/New Box Culvert.

The Commission discussed forming a planning and zoning board for Emmons County. According to States Attorney, Joseph M. Hanson, North Dakota Century Code 11-33-04 states that in counties with five-member boards of county commissioners, the planning commission consists of nine members, of whom at least two must be appointed from the governing body of the city that is the county seat and of whom at most two may be appointed from the board of county commissioners. The remaining members shall be appointed from the county at large. In counties that elect county commissioners from districts, at least one at large member of the planning commission must be appointed from each district.

David Moch provided copies of the county commission minutes from August 22, 2022 where the commission approved a motion to amend the industrial conditional use permit application fee to 3% of the total cost of the project. David Moch emphasized that bringing this forward has nothing to do with the NextEra battery storage project, it just happens to be the first big project that's coming to Emmons County since this motion was passed. "These companies are coming here for a reason and we don't have a lot of zoning rules, they want our land and are making billions of dollars off of these projects, and we are still sitting at a \$250 permit fee." David Moch questioned why the 3% fee isn't being applied to the Emmons-Logan Energy Storage project conditional use permit application? Commissioner Magrum explained that Emmons County has a conditional use permit application and an industrial conditional use permit application. The conditional use permit application is for little projects for our citizens while the industrial conditional use permit was to be used for

larger projects such as wind generation facilities. The industrial conditional use permit application was amended according to the minutes from August 22, 2022. When NextEra applied for a conditional use permit, they did not use the industrial conditional use permit application because according to our Zoning Ordinance, Article II, Agricultural District, conditionally permitted uses includes electric transmission facilities and water, gas, oil or coal, and transmission pipelines. The interpretation is that because this energy storage project is located in an agricultural zone versus industrial zone, NextEra applied for a conditional use permit. According to States Attorney, Joseph M. Hanson, in order to make an amendment to the zoning ordinance would require two readings. Once somebody changes the use on the property, it doesn't change how it's zoned. You would need a separate zoning hearing to change a parcel of property.

Commissioner Magrum motioned to deny the Plat of Lot 1 of QCD Life Estate Reservation DOC #179106 in the SE ¼ of Section 33, Township 135, Range 75 until more clarity is brought to the board. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the Plat of Tracts A and B, within Govt. Lot 1, in the NW ¼ of Section 30, Township 132, Range 75 of the Fifth Principal Meridian, Emmons County, ND. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried

Commissioner Magrum motioned to approve the Plat of Auditor's Lot "B", SE ¼ of Section 8, Township 130, Range 79. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the Plat of Auditor's Lot No. 1, Part of the Northeast Quarter of Section 26, Township 135, Range 76, Emmons County, ND. Seconded by Commissioner Magrum. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Magrum motioned to approve the applications for abatement or refund of taxes for tax year 2025 for parcels #52-0017-00855-000, #52-0020-00906-001 and #52-0020-00906-003. Seconded by Commissioner Vander Vorst. Roll Call "YES": Magrum, Materi, Miller and Vander Vorst. Motion carried. Gartner abstained from voting due to conflict of interest.

Commissioner Magrum motioned to approve the building permit for James Silvernagel for replacing windows, siding, and remodel the inside of the home located in the NW ¼ of Section 25, Township 136, Range 76. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

The 2026 County Budget hearing was set for October 7, 2025 at 6:30 P.M. at the Emmons County Courthouse (courtroom).

Commissioner Gartner motioned to approve the amended Gaming Authorization to include Prize Board Dispensing Devise for Linton Lions Club at the Dock Bar & Grill, LLC, 8049 Hwy. 1804, Linton, ND 58552. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the building permit for Chris and Nicole Weigel for putting up two (2), 24,000-bushel grain bins on the SE ½ SW ½ of Section 13, Township 134, Range 74. Seconded by Commissioner Magrum. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Magrum motioned to adjourn the meeting and reconvene at 6:30 P.M. for an advertised public hearing. Seconded by Commissioner Gartner. The meeting adjourned at 3:00 P.M.

As Advertised, at 6:30 P.M., a public hearing was held to consider the application for a conditional use permit to construct, own, and operate the Emmons-Logan Energy Storage Project.

Chairman Materi opened the public hearing by welcoming the local citizens and NextEra Energy Resources Representatives, and then turned the meeting over to Clint Scherb, Project Developer for Next Era Energy Resources, who presented an overview of the project. The project will be located adjacent to the existing wind site collector substation on the corner of 21st Avenue SE and 72nd St. SE and encompasses approximately 24 acres including the existing five-acre substation. This project will connect to the existing Logan Wind 230 KV collector substation and will utilize the existing transmission to the point of interconnection on the grid to the Napoleon substation. If the conditional use permit is approved, the process will begin with the North Dakota Public Service Commission to obtain a final certificate of site compatibility before construction can start. Construction is expected to start in May of 2026 with commercial operation targeted for December of 2026. The project will be 140-megawatt, 4-hour battery energy storage project (560 MWh). Anticipated local spending impact includes 150 short-term jobs during construction and one to three fulltime operational jobs after construction. Preliminary estimates assume \$7.2 million in property taxes over the life of the project.

Evan Shea, Battery Storage Development for NextEra Energy Resources, stated that NextEra Energy Resources has been developing battery energy storage systems since 2013, and since then they have over fifty systems safely operating across the United States and Canada. Presented was a preliminary site layout and project design of the Emmons-Logan Energy Storage project.

Josh Adams, Fire Safety Engineering Manager for NextEra Energy Resources, talked about the codes, standards, safeguards, safety regulations and testing of the battery energy storage systems. The project is designed to follow National Fire Protection Association 855 and International Fire Code. NextEra Energy Resources works closely with government officials, fire departments and the AHJ's making sure they understand their product and are following all the local regulations. There's 24/7 monitoring from their renewable operations control center that tracks all facilities around the clock.

Following NextEra Energy Resources' presentation of the project, Chairman Materi invited citizens present who wish to speak to come forward.

Commissioner Miller asked if the 45-decibel level for noise is per unit, where Clint Scherb responded that's the total combined noise including the existing wind turbines and the substation.

Senator Jeff Magrum addressed his concerns about the contamination to Lake Aquifer should NextEra Energy Resourses expand on this project in the future. Josh Adams explained the approach in the rare event of a fire and confirmed that there's no risk of contamination. Senator also asked if NextEra Energy Resources is planning on putting a battery energy storage at each of their thirteen industrial wind developments where Clint Scherb stated that this might be one of the goals due to the benefits that it brings to the grid and to the overall transmission system.

Questions were asked about the property taxes paid to the county where Clint Scherb stated that the state is still uncertain whether the project will be centrally assessed or locally assessed, while the opinion of a third-party consultant group is estimating property taxes of 7.2 million dollars over twenty-five years.

Commissioner Magrum asked what their disposal strategy is where Josh Adams replied that they work with manufactures to recycle the batteries. Current recycling technologies that exist today can recover 97% of the metals from lithium-ion batteries that are recycled. The batteries will never go to the landfill. Kenneth Huber questioned which fire department would be responsible for responding as the project is twenty miles from Linton and twenty miles from Napoleon where Clint Scherb stated that he's had a conversation with

Emergency Manager, Mary Senger, where plans are being made to meet with all the fire districts this fall to offer training. Kenneth Huber stated that the land east of the project within a half mile begins with pasture. The land south of the project is also pasture. There is 25 quarters of land that touches each other that is used for grazing. The concern was should a fire happen and takes off, a lot of land will be lost in a short time. Allan Weigel who has cattle in some of this pasture asked about the width of gravel outside of the containers. Clint Scherb stated that NFPA 55 guidelines are 100 feet from the batteries to the property line and the entire facility is clear of vegetation.

David Moch asked if the plume from the smoke is toxic because there are concerns about toxic substances on the surface water. According to Josh Adams, a report that came out at the end of March written by Fire Risk Alliance stated that they assessed the environmental impacts of historical events and every single one of those events showed no contamination to the surrounding air, water or soil. The lithium-ion batteries primary constituent gases that come out of them in case of a runaway is hydrogen, carbon dioxide and carbon monoxide.

Stephanie Doolittle expressed her opinion and stated that multi-million-dollar companies come into our communities and tell us how great their project is going to be. Communities all over our state and our country are being inundated with all this green energy stuff and we know it's all heavily subsidized. The taxpayers are paying for this; but, we are made to believe that this is good. If people aren't going to stand up and defend themselves and our communities, there's going to be a wind tower, solar panel, and batteries all over Emmons County and this entire beautiful state.

Randy Meidinger, City of Linton, believes that the batteries in our garages are going to be more dangerous than the battery project that NextEra is proposing. Randy touched on the property taxes paid by the natural gas pipeline and the Dakota Access pipeline that pays a quarter of million dollars that's divided amongst schools, fires, etc. in Emmons County.

Commissioner Magrum thanked everyone for coming to the hearing and wants to be completely fair to NextEra Energy Resources. It's been a total open process with them. Emmons County has had far too cheap of a permit fee for too long. We have an industrial conditional use permit and then we have a conditional use permit. The interpretation with the county is that the conditional use permit is mostly for locals trying to conditionally amend small things inside of zoning areas. The industrial conditional use permit is meant to permit industrial projects. Emmons County has amended the permitting fee on the industrial conditional use permit to 3% of the total project versus \$250 for the other conditional use permit. The commission is in the process of going through our ordinances trying to figure out the right way because our ordinance book has not been amended for 30-40 years. Commissioner Magrum feels that the commission should adhere to this because they did properly amend the fee through our ordinance process.

Casey Furey, Crowly Fleck Law Firm, who assists NextEra Energy Resources with local and state permitting matters for state projects addressed some of the points that were raised with respect to the application. The application was submitted pursuant to Emmons County's existing ordinances. Electric transmission facilities, which NextEra Energy Resources has filed under, are designated as conditional use in Agricultural districts and the permit was submitted based on this.

Tim Leppert who serves on the Russell Township in LaMoure County came forward and stated that corporations are coming into their township wanting to build infrastructure, and they were not prepared so they decided to update their zoning ordinances and comprehensive plan. Two-year moratoriums were placed until the zoning ordinances are updated and in compliance with the state to protect their citizens. Their first concern was to protect the resident landowners in the township. One change to the ordinances will be a requirement of the corporations to present their business plan, financial statement and to post a certificate of credit.

Commissioner Gartner commented that with these data centers and AI coming to our country, Emmons County is going to be the only place with nothing in it, or we're going to get on board, and we do need to restructure our fees because a \$500 million company building a \$200 million project through Emmons County should be able to pay a 3% permit fee. Commissioner Gartner also commented that he would like to get to the bottom of the property tax impact to Emmons County. How is the project taxed and what is the benefit to Emmons County? "We have to find those answers out before we can 100% approve this project."

Chairman Materi stated that in his opinion he feels that the board should table the permit until the county's zoning ordinance is amended. NextEra Energy Resources can re-submit the permit that will then comply with our amended zoning ordinance.

Commissioner Vander Vorst commented that it really doesn't matter to him as he see's no benefit for the county.

The Commission concluded to table the conditional use permit and have a special meeting on August 12, 2025 @ 9:00 A.M. Chairman Materi thanked everyone for attending the hearing. The hearing closed at 9:55 P.M.

There being no further business before the board, Commissioner Miller motioned to adjourn the meeting. Seconded by Commissioner Magrum. The meeting adjourned at 10:00 P.M.

OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS OF EMMONS COUNTY, NORTH DAKOTA AT IT'S REGULAR MEETING JULY 1, 2025

Chairman Dan Materi called the meeting to order at 9:00 A.M. with Commissioners James Gartner, Erin Magrum, Craig Miller and James Vander Vorst being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

The June, 2025 end of month fund balance report and the year to date expenditure reports were distributed to the board.

Commissioner Magrum motioned to approve the minutes of the June 3, 2025 regular meeting and the June 6, 2025 special meeting. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Miller motioned to approve the agenda. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Old and Unfinished Business:

Commissioner Magrum motioned to appoint Cecile Long to the Emmons County Housing Authority Board to fill the unexpired term of Melvin Jahner. Term is effective July 1, 2025 and will expire on January 1, 2029. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

New Business:

VA Officer, Bead Huber, appeared and gave his quarterly report.

Strasburg Care Center Administrator, Robert Sheckler, appeared to request support from the county for building a new thirty-six bed facility in Strasburg. The request was for three million dollars in the form of a mill levy over a twenty-five-year period. The projected cost of the new facility is eighteen million dollars with another source funding from USDA and the Bank of ND.

The Strasburg Care Center is a CMS 5-Star facility and was recognized as a 2023 recipient of the bronze achievement in quality award by the American Health Care Association, and also received the silver quality award in 2024.

Mr. Sheckler provided the commissioners with information about the current building. The facility was built in 1962 out of cinder blocks with the water pipes behind the block. In order to fix the plumbing, the wall has to be torn out. When the pipes leak, the water goes underneath the flooring. There are four old fuel injector boilers with one of the four boilers being replaced recently for a cost of \$80,000.00. To replace the roof on the building would cost one million dollars. With new regulations effective January 1, 2025, the facility will lose \$300,000.00 this year (\$25.00 per day/per resident) from the State of North Dakota due to the age of the building.

Lewis & Clark RDC Executive Director, Brent Ekstrom, presented an overview and update of services that the Lewis & Clark Regional Development Group offers to businesses throughout the state.

At 9:45 A.M., a motion was made by Commissioner Gartner to enter into executive session under NDCC 44-04-19.1 for Attorney consultation regarding Case No. 08-2024-CV-3614. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

The executive session adjourned at 10:25 A.M. and the meeting reconvened in regular session.

Clint Scherb, NextEra Energy Lead Project Manager Development, presented an application for a Conditional Use Permit to construct, operate or maintain an Emmons-Logan Energy Storage Project on 24 acres out of the W½, SW¼ of Section 34, Township 134, Range 74 of the 5th P.M. in Emmons County, North Dakota zoned in an Agricultural district. Commissioner Magrum motioned to conduct a public hearing for this Conditional Use Permit application on August 5, 2025 at 6:30 P.M. at the Emmons County Courthouse. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Acacia Stuckle and Nancy Deis, Extension Agents, provided a quarterly narrative report.

Nancy Deis, Agriculture and Natural Resources Extension Agent, reported that she was contacted by a concerned producer who suspected an outbreak of water hemlock, a highly toxic weed. She invited NDSU Extension cropping systems specialist, Jeff Stachler, to help identify the plant. After observation, it was confirmed to be water hemlock, which is extremely poisonous to livestock and humans and can be fatal. Due to the risk and aggressive spread, the producer requested the weed be added to the county's noxious weed list to encourage landowners to take responsibility for control. Nancy Deis met with the Emmons County Weed Board to discuss the issue, and at its June 25, 2025 meeting, the board voted to add water hemlock to the county's noxious weed list.

Departmental budgets were presented for calendar year 2026.

The board recessed for lunch and reconvened at 1:30 P.M.

Russell Lawler, Road Superintendent, provided a monthly update on activities for the county road department. The department is installing culverts, hauling gravel and blading the roads. Two independent contractors were also hired to haul gravel. Commissioner Magrum mentioned that the road on 65th St. SE and 3rd Avenue SE has some rough spots. Russell Lawler stated that he's having the road dept make a couple of rounds with the gravel truck. Also brought forward was the intersection on Main Avenue by 74th St SE and 76th St. SE needs a culvert. Presented was the road departments 2026 budgets.

Jim Wagner was present to discuss the Cattail Bay Road Cement Stabilization (2 miles) project and also inquired about getting an estimate from an engineer on paving the gravel road from the highway to the cattail boat dock.

Commissioner Gartner motioned to approve the Utility Permit for KEM Electric to bore the gravel road to replace overhead power lines in section 27 and 28, Township 133, Range 74. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Miller brought forward setting up road restrictions after a rain event. The northwest corner of the state puts on road restrictions after receiving twenty hundreds of rain, and will keep the restriction in force until the roads dry up. Roger Martin, Linton Municipal Airport, and Sharon Jangula, Linton City Administrator/Auditor, presented a 2026 budget request of \$160,400.00 which would amount to approximately four mills.

Chairman Dan Materi called the meeting to order at 9:00 A.M. with Commissioners James Gartner, Erin Magrum, Craig Miller and James Vander Vorst being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

The May, 2025 end of month fund balance report and the year to date expenditure reports were distributed to the board.

Commissioner Vander Vorst motioned to approve the minutes of the May 6, 2025 regular meeting and the May 15, 2025 special meeting. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Gartner motioned to approve the agenda with the addition of Housing Authority board member and dust control on gravel roads. Seconded by Commissioner Magrum. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Old and Unfinished Business:

Commissioner Magrum reported that Kathryn Holzer declined the appointment of Emmons County Housing Authority board member.

New Business:

Commissioner Gartner motioned to accept the proposal from Twin City Roofing, LLC in the amount of \$32,719.00 to repair the upper middle roof area of the courthouse. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

As per publication, at 9:15 A.M., the County Board convened as a Board of Equalization to take up matters of Equalization of Assessments.

Commissioner Gartner motioned to approve the Homestead Property Tax Credits and Veterans Tax Credits for the 2025 tax year. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Vander Vorst motioned to approve the 2025 property exemption list. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Tax Equalization Director, Christina Seppanen, provided a list of the properties that were sent a Notice of Increase where the true and full valuations increased by \$3,000 or more and 10% or more from the amount of the previous year's assessment.

Christina Seppanen presented current and prior years true and full values for residential, commercial and farmland properties. The 2025 residential values increased due to sales. By North Dakota state law, as property values change in the market place, those changes must be reflected in the assessor's estimated market values. The assessment must fall within the mandated tolerance as established by the State Board of Equalization which is between 90% and 100% for the year 2025. Rural residential values increased by 10.18%, residential land and commercial land held their own values, while commercial properties increased overall by 13.45%. The Ag Land values as decided at the February 4, 2025 commission meeting will maintain a 92% tolerance level. Commissioner Magrum motioned to approve the equalization and valuation assessments for Emmons County for 2025. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

The ND Legislatures passed HB 1176 which requires that Assessment Notices be sent to all property owners starting in the year of 2026. These notices will include the current and prior years true and full values, date, time, and location for local Board of Equalization meeting. Christina Seppanen estimated a cost of \$7,000.00 in postage for mailing these notices.

Discussion was held in regards to increasing the assessment fee for the cities and township which is currently at \$1.00 per parcel. No action was taken.

The County Board of Equalization meeting adjourned at 10:00 A.M.

Discussion relative to Zoning Ordinance update was discussed. Commissioner Miller stated that he signed up for a webinar on zoning for large industrial land held on June 5th, 2025. Commissioner Magrum suggested that the board evaluate Dunn County's Land Development Code at the July 1, 2025 meeting.

Theresa Thom, Vision Zero Outreach Coordinator for the Southwest Region in North Dakota, appeared to provide a crash summary report for Emmons County. There were 89 fatalities throughout North Dakota between the years of 2019-2023. Emmons County had one fatality in the past five years. Emmons County had 13 serious injury crashes between the years of 2019-2023. Most of these crashes happened during the day with dry weather conditions. 69% of these injuries were single vehicle rollovers. Out of the 13 crashes, 5 were not

wearing seatbelts and ejected from the vehicle. Vision Zero is working in schools with the hope to reach the students to start good behavior sooner. They have a program called Vision Zero Schools where they work with the schools and student councils asking if the students are interested in the Vision Zero Program.

Russell Lawler, Road Superintendent, provided a monthly update on activities for the county road department. Verizon Connect is installing the vehicle trackers. Started hauling gravel out of the Knoll pit to the southeast part of the county. The employees are tracking the gravel inventory. Equipment operators are out blading the roads. The department is also trying to get the closed roads back open and will start replacing the damaged culverts. Commissioner Miller thanked the road department employees for working on the roads over the weekend and on Memorial Day. There was also some discussion relative to dust control on the gravel roads.

Chairman Materi brought forward Russell Lawler's six-month introductory period that is complete. The Commissioners have the choice to either extend the introductory period or classify Russell Lawler as a regular full-time employee. Commissioner Vander Vorst motioned to accept Russell Lawler as a full-time regular employee. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Miller motioned to approve the utility permit for South Central Regional Water to install a 2" rural waterline crossing 8th Avenue SE from the SE ¼ of Section 32, Township 134, Range 76. Seconded by Commissioner Magrum. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

James Haid reappeared to request gravel on the road located on the NE ¼ of Section 32, Township 133, Range 76. States Attorney, Joseph M. Hanson, stated that he's still waiting for one of the adjacent landowners to sign an easement.

Roger Martin, Linton Municipal Airport and Sharon Jangula, Linton City Administrator/Auditor appeared and requested \$45,000.00 from the county to go towards the Linton Municipal Airport apron reconstruction project, and also to inquire about a potential county mill levy to help fund future projects and support operations and maintenance of the airport. Presented was a capital improvement program that listed planned projects for the next ten years. Roger Martin emphasized that the airport, established in 1937, is not a private business; instead it's a federal funded entity for government service providing medical fixed wing transfers and helicopter flights and fueling, aerial applications and utility and pipeline companies.

Kyle Wanner, Director for the ND Aeronautics Commission, was asked about charging for aerial applicators where he emphasized that it's not appropriate practice to charge higher amounts to any sort of businesses on the field for significant projects. The airport is a federal obligated airport and needs to charge a fair market value and appropriate rates.

Discussion was held relative to appointing an individual to serve and represent the county on the airport authority board where there is currently one vacant seat to the five-member board. The Commission also entertained the idea of changing the name of the airport to the Emmons County Airport. Grant Turwick, Airport Planner for the ND Aeronautics Commission, explained that changing the name of the airport is a simple process where the airport would be a county airport and still be sponsored and run by the Linton Airport Authority. To create a county airport authority or a joint regional airport authority would involve a joint resolution between the county and the city which would also require a seven-member board and a new EIN number and account number with the FAA. Linton Airport Authority has their own tax number and account with the FAA where they receive grants for the airport.

Commissioner Gartner motioned to approve the applications and issue liquor licenses for Todd Nieuwsma/dba The Ouencher Bar:

At 9:20 A.M., the Board of County Commissioners reconvened in regular session.

Sheriff Gary Sanders introduced Deputy Joseph James who started his employment with Emmons County on May 1, 2025.

As advertised, at 9:30 A.M., a public hearing was held to receive public comment and direction in regards to a Petition to close the section line from the Northwest Corner of the NW ¼ of Section 27, Township 131, Range 74, and running East for ¾ of a mile. The portion of the section line to be closed is approximately ¾ miles. Also, at 9:40 A.M., a public hearing was held to receive public comment and direction in regards to a Petition to close the section line from the Northeast Corner of the NE ¼ of Section 28, Township 131, Range 74, and running South until it reaches the Northeast corner of the South Half of the North Half of Section 28, Township 131, Range 74. The portion of the section line to be closed is approximately ¼ mile.

Terry Buechler and Douglas Gefroh were present and stated that they want to put up new fencing and would like to see the section lines closed as they haven't been traveled on since the early 80's. There were no citizens present in opposition to close the section lines. The Commissioners had concerns about closing the section line running north and south because the road is travelable, even if it leads to nowhere, and acknowledged the importance of maintaining public access. After further discussion, Commissioner Vander Vorst motioned to close the section line from the Northeast Corner of the NE ¼ of Section 28, Township 131, Range 74, and running South until it reaches the Northeast corner of the South Half of the North Half of Section 28, Township 131, Range 74 due to the condition of the road being unsafe and dangerous for the people to travel. Seconded by Commissioner Magrum. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried. Present was VA Officer, Brad Huber.

Tabled was the Zoning Ordinance update, Article VI, pages 15 – 18, conditional use requirements.

Tanya Wieler, Independent Human Resource Consultant, telephoned into the meeting with recommended changes to the Employee Handbook. Commissioner Gartner motioned to amend the employee handbook as follows:

Section 3 – EMPLOYMENT POLICIES, Section 3.5 – change the last sentence to read "during this introductory period and throughout the duration of the employment relationship, both the employee and Emmons County have the right to terminate employment without advance notice".

Section 3 – EMPLOYMENT POLICIES, Section 3.16 – amend the third paragraph to read "employment with Emmons County is based on mutual consent, both the employee and Emmons County have the right to terminate employment at will, with or without cause at any point during the employee relationship".

Section 3 – EMPLOYMENT POLICIES, Section 3.16 – remove the words "in advance" from the fourth paragraph.

Seconded by Commissioner Magrum. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner's Gartner and Miller reported that they attended the After-Action Review (AAR) at the courthouse auditorium that was conducted by Emergency Manager, Mary Senger. The event was interesting and well attended by participates of the Glencoe Fire event.

Commissioner Miller brought forward discussion relative to sending road department equipment operators to firebreak training.

Jon Martin, PE and Michael R. Rivinius PE, Wold Engineering, P.C., appeared to present a cost estimate in the amount of \$671,764.50 for the Cattail Bay Road Cement Stabilization project (East-West 2 miles only). Emmons County was approved for funding through the Special Road Fund Program with the NDDOT. The maximum NDDOT contribution is limited to 60 percent, with the financial participation amount limited to \$300,000.00. Commissioner Gartner motioned to accept the \$300,000.00 from the Special Road Fund Program through the NDDOT and to proceed with the two-mile Cattail Bay Road Cement Stabilization project. WHEREAS, July 2nd, 2025 will mark the 70th Anniversary of the national debut of "The Lawrence Welk Show" on television; a show which was aimed at family friendly variety in acts and music which spanned numerous genres such as Country, Jazz, Pop, Polka, and Patriotic.

WHEREAS, Lawrence Welk, a native of Strasburg, North Dakota took to the national stage values and love for music that started like crops in North Dakota soil and the harvest benefited generations of Americans during times of war and peace, prosperity and difficulty.

WHEREAS, in North Dakota he was recognized in his lifetime such as being inducted into the Rough Rider Hall of Fame in 1961, awarded an honorary degree by North Dakota State University in 1965. Later, his birthplace, the Ludwig and Christina Welk Homestead where he lived until he was 21 was placed on the National Register of Historic Places, and is today open to the public, and owned by the State of North Dakota.

WHEREAS, many North Dakotans are of full or partial German and/or Norwegian descent, it is noteworthy that Lawrence Welk was a German (German Russian) heritage, and Myron Floren originally from Webster, South Dakota was the son of immigrants from Norway and was himself inducted into the Scandinavian American Hall of Fame in Minot, North Dakota in 1984. Their success stories are among the examples of how far Americans from anywhere in America can go with hard work and perseverance.

WHEREAS, "The Lawrence Welk Show" is still aired regularly across America in a number of states including North Dakota (on Sunday evenings in North Dakota) more than 40 years after its last episode, and more than 30 years after his passing.

WHEREAS, his aim at family friendly entertainment is an example of a worthy goal in any generation as in the idea of bringing together quality from the past and present, and worth of all corners of North Dakota to come together to celebrate.

NOW, THEREFORE, The Emmons County Commission hereby proclaims July 2, 2025 Lawrence Welk Day and a day to honor "The Lawrence Welk Show" in Emmons County, North Dakota.

Seconded by Commissioner Miller. Roll Call "YES": Magrum, Materi, Miller and Vander Vorst. Motion carried. Gartner abstained from voting due to conflict of interest.

Eric Hoberg, Napoleon Economic Development, and Jim Guler, Moore Engineering, Inc., appeared to further discuss the proposed Irrigation Project aimed at utilizing water from the Missouri River into Logan County for Irrigation. Eric Hoberg provided a list of fifteen (15) local farmers expressing support for the proposed Irrigation Project and has additional interest from others in the Long Lake and Strasburg areas. Commissioner Gartner had a conversation with a young farmer who emphasized the potential benefits of diversifying crops noting that younger farmers are keen on exploring diverse agricultural practices, which could lead to increased profitability. Last year this local farmer successfully implemented irrigation for crops such as onions.

Jim Guler provided a handout on why this feasible study matters and the scope of the study. The study will help determine the best routes for water distribution from the Missouri River. Creating an irrigation district could allow landowners the ability to increase yields and expand farming opportunities, improve drought resilience and boost the local economy by supporting agricultural production.

The Commissioners were asked to contribute \$25,000.00 towards the local cost share of the grant received from the Department of Water Resources to generate the feasibility study. Concerns were addressed regarding the use of county funds for the feasibility study due to compliance with legal and budgetary constraints.

Clint Scherb, NextEra Energy Lead Project Manager Development, appeared to outline plans to apply for a Conditional Use Permit for the proposed Emmons-Logan Energy Storage Project. The fee structure would be similar to that of the previous wind farm project with a suggested fee of \$250.00 per battery container resulting in a total of \$34,500 for the 138 containers. The Energy Storage project will be located on a 15 acre parcel adjacent to the substation. The anticipated lifespan of the battery system is projected to last between 30 – 35 years.

Russell Lawler, Road Superintendent, provided a monthly update on activities for the county road department. Tyler Scherbenske from RTS Shearing, LLC was present to discuss gravel sampling test results. There was discussion on hiring an additional fulltime equipment operator and purchasing retriever discs for the front of the blades.

Commissioner Gartner brought forward a county JDA (Job Development Authority) after participating in an ILG class "Role of County Commissioner" where commissioners noted that every county and city should ideally have a JDA to facilitate job growth and development and emphasizing the importance of having dedicated funds for economic projects. Emmons County has the authority to levy up to four mills for a JDA. States Attorney Joseph M. Hanson explained that the Board of County Commissioners, by resolution, may create a job development authority for the county, or may discontinue a job development authority which has been created for the county.

Commissioner Gartner motioned to approve the minutes of the February 4, 2025 regular meeting. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Miller motioned to approve the agenda with the addition of gravel discussion. Seconded by Commissioner Magrum. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Old and Unfinished Business:

Auditor Ohlhauser reported that the NDIRF adjuster completed the claim investigation regarding the farm equipment damage from a rock and ruts in a field, and will be denying the claim because there were no findings where the county is negligent. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Magrum motioned to approve the building permit for Richard Weigelt to replace windows, doors and flooring to the residence, tract 425.6 X 177' and tract 3 in the SE ½ SE ½ of Section 6, Township 132, Range 76. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

The Six County Commission meeting hosted by McIntosh County will be held on March 11, 2025 in Ashley, ND.

As advertised, at 9:15 A.M., a public hearing was held to receive public comment and direction in regards to a Petition to close the section line in between the N $\frac{1}{2}$ of Section 7, Township 130, Range 75 and the N $\frac{1}{2}$ of Section 8, Township 130, Range 75, pursuant to North Dakota Century Code 24-07-03. Kenny and Danny Nieuwsma were present and provided a history of the road from 1950 to present. States Attorney, Joseph M. Hanson provided his opinion from Chapter 24-07 in the North Dakota Century Code that reads the board of county commissioners, if petitioned by a person having an interest in the adjoining land, after a public hearing, may close section lines which are not used for ten years, are not traveled due to natural obstacles or difficulty of terrain, are not required due to readily accessible alternate routes of travel, or are intersected by interstate highways causing the section line to be a dead end. There were no citizens present in opposition to close the section line. Commissioner Gartner motioned to close the section line. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

The board reviewed zoning ordinance, general provisions and Article 1, RA – Recreation District. Commissioner Magrum motioned to begin a list of amendments with the first amendment proposed for the list would be to take item #2 under 1.A. and move it into item #8 under 1.B. in Article 1. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

There was some discussion regarding the potential hiring of an engineer. Commissioner Gartner reported that the county engineer should have expertise in gravel, culverts, bridges, and if there's going to be a cost share with any of the cities, the engineer should also have expertise on curb and gutter and pavement. Noted was the salary range for an experienced engineer, and the lack of office space in the county shops and courthouse, suggesting possible location at Linton City Hall.

Eric Hoberg, Napoleon Economic Development, and Carl Jackson, Market Engineer for Moore Engineering, Inc., appeared to further discuss the proposed Irrigation project aimed at utilizing water from the Missouri River into Logan County for Irrigation. Eric Hoberg stated that he's trying to make a large impact by utilizing water from the Missouri River for an irrigation project with the potential to impact local agriculture and economic development. Carl Jackson reported that in order for this project to move forward one of the requirements of the Department of Water Resources is that an Irrigation District is formed. This would involve a feasibility study to gauge interest among landowners and assess the potential costs and logistics of establishing an Irrigation District. Requested was for Emmons County to contribute \$25,000.00 towards the local cost share of the \$200,000.00 grant received from the Department of Water Resources to generate the feasibility study so the district can be brought to a vote of the landowners. Commissioner Magrum expressed concerns about spending \$25,000.00 to seek out if landowners want this project, and would like to see a list of landowners that have an interest in the project. Further discussions will be held with Eric Hoberg and local landowners regarding the project.

Commissioner Magrum will take the responsibility of finding a Housing Authority Board Member to replace the unexpired term of Melvin Jahner.

Leon and Therese Beitelspacher appeared to request road maintenance on the one mile stretch running within Section 3 in Township 133, Range 77. Commissioner Magrum motioned to authorize the Road Superintendent to maintain Lyla Lane as he sees fit. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

OFFICIAL PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS OF EMMONS COUNTY, NORTH DAKOTA AT IT'S REGULAR MEETING FEBRUARY 4, 2025

Chairman Dan Materi called the meeting to order at 9:00 A.M. with Commissioners James Gartner, Erin Magrum, Dan Materi, Craig Miller and James Vander Vorst being present. Also present was States Attorney, Joseph M. Hanson.

The Pledge of Allegiance was recited.

Commissioner Magrum motioned to approve the minutes of the January 7, 2025 regular meeting. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Vander Vorst motioned to approve the agenda with the addition of section line discussion. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Old and Unfinished Business:

Further discussion was held regarding county employees being able to volunteer for local organizations, (such as Fire Department, EMS, etc.). Commissioner Magrum motioned that Emmons County allow for county employees to have eight hours of annual volunteer time, approved by the department head, with any modifications being at the discretion of the board of county commissioners. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Reported was the NDIRF insurance claim is still open regarding the farm equipment damage from a road project (rock and ruts in field); therefore, no action was taken.

Discussion was held on updating the Zoning Ordinance Manual where the board agreed to work through a chapter every month with States Attorney Joseph M. Hanson. The commission decided to add zoning ordinance update – general provisions in chapter one on the March agenda.

Chairman Materi and Commissioner Miller looked into the section line matter located on the NW ¼ of Section 7, Township 136, Range 78, 55th St. SW tabled from the December 3, 2024 meeting. Chairman Materi reported that the section line is not drifted in as previously described; instead, there's a 15 – 20-foot embankment and ravine grown over with trees. Citizens are driving on a trail south of the section line. There's a small pile (wheelbarrow size) of cement pieces on the section line. GIS Coordinator, Josh Odden, stated that he found a photo dated back in the 1950's where citizens were driving around the section line. State's Attorney, Joseph M. Hanson, provided an opinion that the county could grant permission to Mr. Woodland to improve the section line using his own equipment to build up the road so that it's drivable; but, the county has no obligation to this road. The board concluded that this is not a county matter.

New Business:

Commissioner Vander Vorst inquired about the section line located in between Sections 4 and 9 in Township 131, Range 74, asking if the county would be responsible if something would happen if the section line gets washed out and impossible to cross. States Attorney, Joseph M. Hanson, stated that this section line is not part of the county's road system, and if the section line becomes dangerous, the county could close access to the road.

Commissioner Gartner motioned to enter into a Limited Services Agreement with Tanya Wieler of Dakota Dynamics, Human Resource Consulting for Local Government, for providing general Human Resource assistance and guidance to Emmons County. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Magrum motioned to terminate Easement No. DACW45-2-70-6059 within Section 6, Township 135, Range 78, and release it to the U.S. Army Corp. of Engineers. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Director of Tax Equalization, Christina Seppanen, appeared to present the 2025 agricultural land valuations provided by the Agribusiness and Applied Economics Department of the North Dakota State University. NDSU calculated the statewide average values per acre with the following results:

Cropland \$910.51 Non-cropland \$163.09 All agricultural land \$676.46

Emmons County's average value per acre for the year 2025 is as follows:

Cropland \$924.38 Non-cropland \$165.55 All agricultural land \$675.89

North Dakota Century Code ruling requires County's to be within a tolerance level of 90% - 100% on their agricultural land values determined by the North Dakota State University Agricultural Economics Department.

Commissioner Gartner motioned to maintain a 92% tolerance level to keep the county average in compliance with state requirements. Seconded by Commissioner Magrum. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

NextEra Energy Resources Representatives, Clint Scherb and Evan Shea, appeared and presented information on a proposed Emmons-Logan Energy Storage Project. The project would be located on a 15-acre parcel adjacent to the substation in Emmons County. The project includes a 140-megawatt, four-hour battery energy storage project (560 megawatt hours), and is aimed to start construction in 2025 with commercial operation targeted for December 2026. The project has a lifespan of 30-35 years.

Tony Holzer and Becky Thatcher-Keller provided an update on the Emmons County Senior Food Services. The State Director for Council on Aging for Senior Services called for a Kidder County Commission meeting to be held to discuss issues with the KESS (Kidder Emmons Senior Services). There were problems with financial reports, releasing money belonging to Emmons Seniors, and bad business decisions with closing down meal sites. After a heated discussion between the State Director, board members, and guests, the Kidder County Commissioners ordered the Secretary/Treasurer with KESS to pay Emmons County Senior Food Service \$39,002.90 from a savings account for Emmons County Senior Food Services. The State Director ordered an audit so it's unclear whether the Emmons County Senior Food Services will be receiving more funding. The Kidder County Commissioners asked all the KESS board members and the director to resign effective February 1, 2025. The Commissioners complimented Tony Holzer for the excellent job that he's doing with the Emmons County Senior Food Services. Tony Holzer stated that they are very thankful for the community contributions that they received. Noted was meals on wheels will begin delivery to Strasburg.

Francis Krumm appeared and provided a correction to the public record and comments made at the January 7, 2025 meeting regarding frost boils to the county roads at the time he was the county road superintendent. Mr. Krumm stated that when he was road superintendent, he had a conversation with Emergency Manager, Mary Senger, who recommended that the county supply all the road department employees with county owned cell phones in case of open record requests that their personal information would not be jeopardized. With the help from Mary Senger and FEMA, all grade operators were trained to locate and measure each of the frost boil sites accurately. The employees did an excellent job of locating the frost boils and provided all the paperwork requested by FEMA. After the paperwork was completed, it was turned in to Mary Senger who then filed the paperwork with FEMA. According to the conversation held with Mary Senger, FEMA did not cover the frost boils in Emmons County during that time period, and the denial had nothing to do with the paperwork process. She filed the paperwork the second time and was denied again. There were 309 frost boils, but only 109 needed to be repaired for a cost of \$518,159.82. The other frost boils only needed grading. Before Francis Krumm was road superintendent, there was no paperwork or time cards kept by the employees. The Commission agreed that the road department needed to have paperwork and documentation, so they hired Kelly Krumm to do the paperwork. Every hour of every work day over the course of 2020 and 2021 was documented by each employee. The time cards listed what each employee was doing, what piece of equipment was used and the hours spent on each task. This information was used to provide the cost of each road repair project. Books were compiled that contained all the annual road projects completed. Each Commissioner was provided with one of these books that should be handed down to the next commissioner.

Russell Lawler, Road Superintendent, provided a monthly update stating that the department has been blading on warmer days, riprapping out by Larry Leier's and Gefroh's on the federal aid road, doing maintenance in the shop, building fenders on the Low Boy trailer, building racks for outside, and a couple of employees are working on some packers in Strasburg. There was some discussion on various roads that need culvert work, blading and graveling.

Commissioner Gartner reported that he's waiting on a quote from Verizon Wireless for tracking graders and possibly trucks and pickups as a tool to protect the employees.

Commissioner Magrum motioned to amend the 2024 appropriations for prairie dog road by \$184,108.10, LATCF by \$9,267.12, police contract by \$33,971.41, and ARPA by \$75,874.92. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Magrum motioned to approve the plat for the west 47' of the N½ of lot 9 of the NE¼ of the SE¼ of Section 17, Township 132, Range 79. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Magrum motioned to approve the plat for Lot C of the SE ¼ of Section 18, Township 132, Range 76. Seconded by Commissioner Gartner. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Clerk of Court/Recorder, Robin Mosset, introduced Wayne Ehley, newly hired Deputy Clerk of Court and Myckea Gross, newly hired Deputy Recorder.

Commissioner Gartner motioned to approve the application for abatement or refund of taxes for parcel #15-5426-10 for tax year 2024 and to approve the application for abatement or refund of taxes for parcel #22-0000-04698-000 for tax year 2024. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Acacia Stuckle and Nancy Deis, Extension Agents, provided a quarterly narrative report. Commissioner Vander Vorst volunteered to be assigned the portfolio for the Emmons County Extension Agents, and will participate in their performance reviews.

Eric Hoberg, Napoleon Economic Development, and Jim Guler, Moore Engineering, Inc., appeared and presented information regarding a potential Irrigation project that they've been working with the Department of Water Resources on that would bring water out of the Missouri River into Logan County for Irrigation. Hoberg stated that Logan County currently has about 6,000 acres that could be productive with the use of irrigation. If a

pipeline is run through Emmons County from the Missouri River, Logan County could increase that acreage to 66,000.

In order to make a request for the irrigation to become a project that the state would consider was to form an Irrigation District which meant that you need a comprehensive study, and you need 51% of the potential landowners to sign a petition. Eric Hoberg collected the signatures for the petition identifying the area on lands that would be good for irrigation. A draft study conducted by Moore Engineering, Inc. was submitted to the state. The cost of the study is approximately \$200,000. There is a cost share program with the state for 75% of the cost with a local cost share of 25% if partnered with a county.

During discussion, it was noted that the Horsehead Irrigation District that was formed years ago has become active again where two meetings were held. Eric Hoberg will be reaching out to the district.

Jim Guler approached the Commission about a joint effort or to team up in some capacity as the pipeline project would run straight through Emmons County. Commissioner Magrum asked if there was a preliminary design or a rough draft? Also, having a rough pipeline size and knowing a rough depth of the pipeline are questions that are going to be asked by the landowners.

Commissioner Magrum questioned whether the water moving through the pipeline would be considered potable due to recent updated zoning ordinances. Another question asked by Commissioner Magrum was are there plans on adding outlets to the pipe with the idea that you could add irrigation for Emmons County? Eric Hoberg stated that he's hoping to design this project so that they can service all of the land in Emmons County and Logan County that's irrigable.

VA Officer, Brad Huber, appeared and gave his quarterly report.

Commissioner Gartner motioned authorizing the Chairman and the County Auditor to sign the County Deeds conveying the county's interest in tax deed property as follows:

Russell Lawler, Road Superintendent, reported on activities for the county road department.

Time card processing discussion was held. Equipment is being moved to repair the bridge in the SE ¼ of the NE ¼ of Section 28 of Township 133, Range 75, approximately 5.5 miles east and 2 miles north of Linton, ND. The Commission noted positive comments received from the public on the recent blading done to the roads. Discussion was held regarding the tar tank owned by the county and if they would sell tar to cities where Russ Lawler commented that he will do some research and report back.

Commissioner Vander Vorst, Commissioner Miller and Road Superintendent, Russell Lawler, attended a meeting at Morton County and reported that they have a good system where two commissioners, road supervisor and a couple of citizens from the community meet to discuss road matters/projects, and bring their ideas and recommendations before the commission at their regular meeting. Chairman Materi and Commissioner Gartner will be attending the next meeting at Morton County on January 15, 2025.

Commissioner Gartner motioned to approve the building permit for Orville Dykema to erect a 34 X 30 residence with a 54 X 30 attached garage on the SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 21, Township 129, Range 77. Seconded by Commissioner Vander Vorst. Roll Call "YES": Gartner, Materi, Miller and Vander Vorst. Magrum abstained from voting due to conflict of interest.

Commissioner Magrum motioned to approve the application for abatement or refund of taxes for parcel #52-0006-00523-000 for tax year 2024. Seconded by Commissioner Miller. Roll Call "YES": Gartner, Magrum, Materi, Miller and Vander Vorst. Motion carried.

Commissioner Magrum motioned to adopt the following Resolution:

WHEREAS, the bid in the amount of \$1,182,691.99 from Industrial Builders, Inc. received in the bid opening of December 13, 2024 for Project BRJ-0015(021) was the low bid received.

WHEREAS, this bid is considered reasonable.

NOW, THEREFORE, be it resolved by the Board of County Commissioners of Emmons County will award to Industrial Builders, Inc. the contract for Project BRJ-0015(021) and hereby authorizes the Chairman of the Board to sign said contract.

It is further understood that the County shall reimburse the North Dakota Department of Transportation for any payments made under this contract, which are not collectible from the Federal Highway Administration.
