PETITION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS*

COMES NOW the Petitioner/Appellant, Heath Stocks, *pro se*, who hereby petitions the court for Leave to Proceed *In Forma Pauperis* and does allege and state as follows:

1. That Petitioner/Appellant, a resident of the State of Arkansas, has prepared and desires to file with the Arkansas Supreme Court an Appeal from the denial of his Writ of Error Coram Nobis/Writ of Audita Querela petition by this Court on January 18, 2018.

2. That Petitioner/Appellant has completed an Affidavit in Support of Request to *Proceed In Forma Pauperis* setting out his/her income and assets. Petitioner/Appellant's Affidavit accompanies this petition.

3. That Petitioner/Appellant's income barely suffices to meet the costs of life's daily essentials and includes no allotment that could be budgeted to pay for court fees and costs incident to this proceeding.

4. That Petitioner/Appellant has no other income in addition to that described in his Affidavit and no means of paying such costs without being reduced to total impoverishment.

5. That Petitioner/Appellant believes that he is entitled to appeal to the Arkansas Supreme Court by law, and that such action is not brought for a frivolous or malicious purpose.

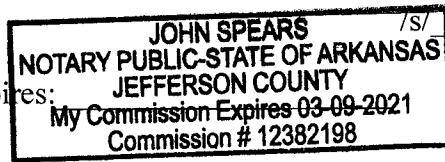
