#### Report from Department Head

Lee Gunn also reported the Santa run went well. He also reported Garrett Nelson would be leaving and Josh Parker want to gone the Fire department. Parker has a broken finger but should be ok in about a month, and Nelson said he would stay until they found someone.

Terry Jackson reported on several water leaks. He also reported that the Limb truck is down and going to cost too much money to fix. Jackson asked for the service to be suspended until they come up with a solution.

Council Member Chapman moved to table the Limb truck until the next Council Meeting. Council Member Collins seconded the motion. The motion carried with votes being as follow: Yeas: Council Member Benson, Littleton, Collins, Chapman and Crumpton.

Terry Jackson reported that the Garbage men would be working Monday and be off Friday. Jackson had already gotten with the Mayor.
