- 1. Introductory – Intro Test C (jumps 2' mostly logs on ground)
- 2. Starter – Beginner Novice Test A (jumps 2'3", XC course logs on ground working to roll top, coops, and dog houses)
- 3. Beginner Novice – Beginner Novice Test A (jumps 2'7")
- 4. Novice Level – Novice Test A (jumps 2'11")
- 5. Training Level – Training Test A (jumps 3'3")
