RESOLUTION NO: SL – 25 - 2021

TITLE: Approval of National American Indian Housing Council/Wells Fargo C19 Housing Assistance Program (HAP) Policy and Application

WHEREAS, the Summit Lake Paiute Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 (48 Statue 984), as amended, with the Articles of Association, and approved by the Secretary of Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Tribal Council; and

WHEREAS, the Summit Lake Paiute Tribe is responsible for financial matters and the organization of operating policies to provide accountability of the benefits received by the Tribe on behalf of its members; and

WHEREAS, in the early part of 2020, multiple cases of the Coronavirus (COVID-19) appeared throughout the United States causing the State of Nevada and many other states to declare a state of emergency which included a mandatory stay at home order in place for all persons excluding essential workers. The Coronavirus was declared a National Pandemic; and,

WHEREAS, Through the C19HAP, NAIHC will use \$880,000 for eligible NAIHC members to assist in their response to the COVID-19 pandemic and its effect on housing in their communities. The funds are provided to assist with eligible activities included, but are not limited to: Developing immediate housing opportunities to provide safe and responsible temporary or permanent housing or quarantining of individuals affected by COVID19; Housing Assistance to individual families or households impacted by COVID-19; Procurement of PPE or testing equipment for staff and/or members in the community; Other projects intended to respond to or protect against COVID-19; and,

WHEREAS, Summit Lake Paiute Tribe was awarded \$44,000.00 from the National American Indian Housing Council (NAIHC)/Wells Fargo Housing Assistance Program;

WHEREAS, The Tribal Housing Program Manager proposes the following Summit Lake Paiute Tribe’s NAIHC/Wells Fargo C19HAP Policy and application, to enable the tribe to meet the needs of tribal members; and

WHEREAS, the Summit Lake Paiute Council has deemed it to be in the best interest of the Tribe, to adopt the National American Indian Housing Council/Wells Fargo C19HAP Policy and Application to aid tribal members with Emergency Rental/Mortgage and Utility Assistance; and

NOW THEREFORE BE IT RESOLVED, that the Summit Lake Paiute Council, the governing body of the Summit Lake Paiute Tribe of Nevada hereby approves the adoption of the SLPT's National American Indian Housing Council/Wells Fargo C19HAP Policy and Application.
