THOSE ARE JUST A COUPLE ISSUES THAT OUR BOARD OF DIRECTORS WILL BE ADDRESSING NEXT MONDAY WHEN THEY MEET FOR THEIR QUARTERLY BOARD MEETING. PRAY FOR GOD'S WISDOM AND GUIDANCE AS WE WORK THROUGH THESE ISSUES OF CHANGE.
