OFFICIAL RULES

1. Saturday May 17th-Start time 6:00AM
MUST BE CHECKED IN BY 3:00PM
Sunday May 18th-Start time 6:00AM
MUST BE CHECKED IN BY 12:00PM
2. Live release will be in effect.. ½lb will be deducted for each dead fish. Protect your fish through proper handling.
3. Headquarters and weigh-in site are located at Lake Tawakoni Bass Club, 2448 Arrow Lane Quinlan, TX. Limited camping spaces available on first come basis. Trailering is permitted.
4. Entry fee is \$200.00 per team including \$20,00 Big Bass pot.
5. You do not have to be a member of any bass club to fish, however the club with the most members fishing will receive a trophy.
6. All local, state, and federal laws will be observed.
7. No alcoholic beverages will be allowed in the boat during fishing hours,
8. No person may participate in the tournament that has guided black bass on Lake Tawakoni in the last 12 months or any current LTBC member.
9. Limit 5 black bass per team per day, 14" minimum length in accordance with TP&W regulations.
Any fish under 14" (on the official club measuring board only) presented for weigh-in will automatically have the weight of that fish plus 1/2lb deducted from the team's weight for that day. No fish will be weighed that has been on ice.
10. No boat may fish within 25 yards of another boat.
11. Polygraph may be in effect.
12. All fishing must be done from boats on Lake Tawakoni only.
13. Only artificial bait may be used. No live bait. Only one rod per person in the water at a time.
14. One person may fish as a team providing they pay the full entry fee. Team members must fish with the same person both days. No alternates will be allowed. Only one person from each boat is required to stand in weigh-in line.
15. Electronic trolling motors are permitted, however trolling as a method of fishing is prohibited.
16. Judges will be at the headquarters as well as on the lake. All contestant's boats are subject to surveillance and inspections. All judges decisions are final.
17. In case of a place tie, the cash awards for that place and the following place will be combined and equally divided. A coin toss will determine which contestant will get the trophy
18. Each participant will be required to wear a chest type life preserver anytime the internal combustion engine on the lake is running. Sportsmanship, courtesy, safety and conservation is expected by each participant at all times.
19. All teams must be preregistered at the tournament headquarters prior to the start of any fishing. As you check in you will be furnished a team number. Teams may begin to preregister at 5:00PM on Friday until 9:00pm and will resume Saturday at 5:00AM to 6:00AM .
20. Each team must have a team captain registered with the tournament headquarters. Team captains may, in case of a need, be called on to act as a grievance judge. All grievances or disputes must be given to the tournament director within 30 minutes after weigh-in each day. Any team captain may vote on a grievance concerning his/her team. All decisions of the judges are final.
21. Only trophy fish may be kept, all others will be returned to the lake per live release program.

FREE KIDS TOURNAMENT Saturday from 8AM to 11AM for kids up to 16 years of age. Fishing will be from the shore of Lake Tawakoni Bass Club property. Trophies will be given out to top boy and girl and overall big stringer. Tickets will be given out for a prize drawing after the tournament. There will be games and activities for the kids after fishing.

Register Early!!! Registration forms that are postmarked by May 9th will be put into a drawing for a paid registration fee for our 206 Invitational. Drawing will be Sunday after weigh-in. Entry fee is \$2.00 per team, Enclose a check or money order with registration form and mail to:
