**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**  
**and CONSENT FORM FOR MEDICAL TREATMENT**

In consideration of being permitted to use the grounds and facilities at Grace Lutheran Church/Camp, DeWitt, Iowa, for recreational or other activities, or to participate in any activity conducted or sponsored by Grace Lutheran Church/Camp, regardless of location, the undersigned, for himself, his personal representatives, heirs, spouse, parents, siblings, children, and assigns, hereby:

Acknowledges, agrees, and represents that he has or will immediately acquaint himself with the rules of Grace Lutheran Church/Camp and ask an employee or volunteer if he has any questions regarding the rules or concerns regarding the safe use of the facilities.

Releases, waives, discharges and covenants not to sue Grace Lutheran Church/Camp, its officers, servants, directors, trustees, agents and employees, and Grace Lutheran Church of DeWitt, Inc., its officers, servants, directors, trustees, agents and employees (hereinafter referred to as "Releasees") from all liability to the undersigned, his personal representatives, assigns, heirs, parents, siblings, spouse, and children for any and all liability, loss or damage, and any claim, cause of action or demands therefore on account of injury to the undersigned's person, his death or damage to his property, which occurs as a result of the undersigned's presence at Grace Lutheran Church/Camp, or participation in any Church/Camp sponsored/conducted activity, whether such death, injury or property damage is caused by the negligence or other wrongful conduct of, or breach of contract or warranty by, one or more of the Releasees.

Agrees to indemnify and save and hold harmless the Releasees and each of them for any loss, liability, damage, or cost (including, but not limited to attorney fees and other defense costs incurred in defending a claim brought by the undersigned, his relative, heir, successor, assign or personal representative) one or more of them may incur arising out of or related to the undersigned's use of or presence at the facilities known as Grace Lutheran Church/Camp, or the undersigned's participation in any Church/Camp sponsored/conducted activity, whether such claim is based on one or more of the Releasee's negligence, breach of contract or warranty, or other legal theory.

Assumes full responsibility for any risk of bodily injury, death or property damage arising out of or related to the undersigned's presence at or use of the facilities known as Grace Lutheran Church/Camp, or participation in any Church/Camp sponsored/conducted activity, whether caused by the Releasee's negligence, breach of contract or warranty or other legal theory.

Agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all claimed wrongful acts of Releasees, whether sounding in tort, contract or other legal theory, and that said Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement is intended to be as broad in scope as is permitted by the laws of the State of Iowa. The undersigned further agrees that in the event any portion of this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement is held in valid, the balance shall, notwithstanding, continue in full legal force and effect to the greatest extent possible under Iowa law.

Consent and authorize Grace Lutheran Church/Camp, its agents, employees, representatives, assigns and/or Youth Counselors, to seek and authorize medical treatment of all types, including surgery (only if a parent or guardian cannot be reached), for myself or the above referenced child, so long as said treatment is recommended by a licensed physician admitted to practice in the state of Iowa, or the state in which the group's activity is located.

I have read this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me, and I intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by Iowa law.

Pronouns indicating the masculine gender shall be construed as feminine where necessary, and singular pronouns or other words shall be construed as plural where necessary and vice versa.

No variation in the terms of this Release and Waiver shall be effective unless in writing and signed by the Camp Board President.
