Barbara was a very special lady. She was instrumental in focusing the mission of the Program to serve low-income people living in assisted housing in Montgomery County. In the early days of the Program when we were struggling with the application and application process, then the screening of applicants, Barbara served on the Screening

Committee and was always focused on the little guy. Whenever a requirement or weighting value was to be assigned she would regularly point out how some requirement negatively affected or made it more difficult for the lowest income applicants and raise our sensitivity to that and push for eliminating language that had disparate impact on the poorest of the poor. 

Yvette Hammond: Setting a goal and sticking to it

If **Yvette Hammond** had thought at all about where she would be in 12 years when she graduated from Seneca Valley H.S in 2000, it's unlikely that she would have envisioned herself as an honors graduate of Montgomery College and a board-certified Registered Nurse. In her own words, Yvette was a "mediocre" student who couldn't wait to finish high school. It wasn't that she couldn't do better, but she simply lacked the interest and drive needed to excel—a bright underachiever.

Born in Houston, Texas to hard-working parents, Yvette moved to the Maryland suburbs in the late 1980s. She was especially close to her dad who was a college graduate and someone who could inspire her to follow in his footsteps. But, adding to her other problems, this self-described "daddy's girl" lost her father in 1997 when she was still at Seneca Valley and—in the ensuing trauma—also lost whatever incentive she

may have had to improve her grades. So after graduation, Yvette found herself facing teenage motherhood with only an undistinguished high school diploma, a limited options, no real goals to aim for, and limited tools to achieve them.

Change doesn't happen overnight; it takes time for someone to realize that there has to be something to aspire to other than low-wage jobs and surviving day-to-day. After years of working, Yvette began to realize that she could do better and had thought hard about careers that would be both personally and professionally rewarding and still provide services to people in the community who needed them most.

As is often the case, the spark that finally lit the fire came from another person. Yvette was leaning toward a career in social work, when her supervisor at a psychiatric hospital *told* her— not suggested —that she was going to be a nurse. So Yvette took her advice and enrolled in the Montgomery College in 2007 and entered the nursing program in January of 2010. So, that sounds like the end of a perfect story: girl sets goal, girl achieves goal. Well, not quite!

To make ends meet, Yvette continued to work full time. But a year or so after starting school, her position was upgraded to one that required a degree and she found herself with no obvious way to support her and her son and continue her education. That's where the *Bernie Scholarship Awards Program* and other student aid programs came to the rescue. Her Family Self-Sufficiency worker from the Housing Opportunities Commission told her about the program and encouraged her to apply. Not only was she selected for an award, but she also received grants in the two following years.

Over time, Yvette became expert in understanding and using the student aid system, researching, applying for, and receiving financial aid from a number of sources. As a result, she was able to complete her studies free of encumbering loans, graduating with honors in December 2011 with a GPA of 3.56 and selected for Phi Theta Kappa, a national honor society that recognizes the academic achievement of two-year college students. In addition, she managed to find time in her busy schedule to mentor a junior nursing student and serve as the student representative on the Nursing Curriculum Committee.

Because of these accomplishments, and with the help of the same mentor who had helped get her started in nursing, Yvette was hired by a community health organization in Montgomery County and is now doing a job she loves with a real future. On March 10, 2012—15 years and one day after the loss of her father—Yvette passed the nursing board examinations, making her a full-fledged member of the profession.

And that's not the end of the story: once she takes a breather from schoolwork, Yvette plans to enroll in the University of Maryland to work toward her Bachelor of Science degree in Public Health.

In Yvette's own words, "It was a huge sacrifice, but definitely worth it. If you set a goal and want it bad enough, you'll achieve it no matter what the obstacles." As for the importance of financial aid like that provided by the *Bernie Scholarship Awards Program*, "It's indispensable; without it there's no way I would have been able to complete my studies."
