

#### President's Message – August 2018

As I write this message, we're in the last days of August 2018, summer is still a string of hot days, schools and colleges are opening, and, yes, another legislative session is about five months away on January 15, 2019. To the proverbial question of *how full or empty is the glass of water*, we at RSEA have got a lot done this year and we also have more to do.

Let me recap a few highlights.

You'll remember that we've designated 2018, RSEA's 41<sup>st</sup> year, as our "Year of Renewal" with goals to:

- increase our ability to recruit and retain members of our association;
- enhance our capacity to educate our members about the benefits of state retirement, and the need to protect them, as well as the benefits of membership in RSEA; and,
- develop best-practice methods for how to communicate with RSEA members as well as potential new members.

I can report from interim progress. First, to "renew" we'll need new members, and our recent membership drive has brought to us more than 400 new RSEA members! To those wonderful new members receiving your first newsletter, we not only welcome and thank you for your service to Texas – we also welcome the opportunity to serve you. Second, we are working to engage a third-party to help us modernize our business enterprise, including our website and communications infrastructure. I hope to have more news about this soon.

Then, I always like to remind people that RSEA was created in 1977 as the Texas organization whose **singular commitment is to retired state employees**, their pensions and their health benefits. Our last newsletter focused on pensions and this brief newsletter includes a focus on health benefits, so I encourage everyone to take a look at page 3 of this newsletter and respond to our survey of RSEA retirees who are on Blue Cross-Blue Shield. Information we receive will help in educating policy-makers, including the legislature and the recently-formed Benefits Advisory Committee at ERS, about retiree health insurance issues and needs.

We'll report back to you on the results. *Reminder:* The survey is for retirees on BCBSTX, not for retirees covered by Medicare.

Next, you can see from our cover page that plans are underway for our annual membership meeting October 4. One of our regular highlights will be an update from ERS Executive Director Porter Wilson on retiree benefits programs and ERS' biennial budget request.

Also, as we are in a pre-legislative mode this year, I am particularly excited to have as our key-note speaker Keith Brainard, a nationally-known and respected analyst of trends across-the-nation in the pension arena, especially defined benefit programs. We're looking forward to relevant information and ideas on how we can keep moving forward to address past years of chronic underfunding in Texas, primarily from the Legislature.

I never want to miss an opportunity to say that RSEA and your Board of Directors are dedicated to both recognize and promote the value of public service everywhere and in all forms. We are heartened by our long-standing members, and are both encouraged and excited by our new members. This is an especially good time to join us at RSEA – either as a member of our association or even as a Board member -- in this cause, especially as we must provide more education in response to efforts to de-value the important, in fact *essential*, role of public service in our society, our nation, our world.

As I close this letter, let me end on a note of personal privilege. We've all seen the sad news this weekend about the passing of Senator McCain. I know of no one who more exemplified a model of public service and civility in our public discourse. I remember like yesterday watching him get off that plane after his release from years of captivity. Let our continuing thoughts be with his family in the coming days.
