Meeting called to order at 12:00 pm

Discussion of Regional Forms at State Championships

As some athletes decide to not participate at Regionals, even if they earned a qualifying score at State Championships, SC had developed the procedure whereby all coaches must turn in the form identifying which of their athletes would and would not be attending regionals, if they were to qualify. This form must be turned in by the start of March-In of the athletes' session, to allow time for proper time to review, update systems, and verify prior to the end of the competition. This form is provided to coaches in the days prior to the competition, and coaches of clubs with missing forms are asked during Open Stretch for them to complete the form. If forms are not received by the beginning of March In, it is assumed all qualifying athletes will attend Regionals.

Anna made a motion for this procedure to continue for the current year's State Championships.

Dana seconded the motion Motion PASSED unanimously

Discussion of the type of scoring of Sapphire athletes during State Championship

As determined earlier in the year, Sapphire athletes will be competing with Level 8's at the State Championships. Level 8's are required to have Open Scoring, whereas the SC SAC had determined for previous years, that Xcel would not have Open Scoring. It is not technically possible with current software to allow some gymnasts in a session to have Open Scoring, and other gymnasts not to have Open Scoring.

Joey made a motion for Sapphire to have Open Scoring for the current year's State Championships, and it would be allowed to communicate this change prior to the official approval of these minutes, so that it could be communicated to coaches more timely. **Dana** seconded the motion
