- (b) Any ordinance or resolution promising or guaranteeing the payment of money for the Village, or authorizing the issuance of any bonds of the Village or any evidence of the Village's indebtedness, or any contract or obligations assumed by the Village.
- (e) Administrative ordinances or resolutions of the Village Board not in conflict or inconsistent with the provisions of this revision.
- (d) Any right or franchise granted by any ordinance of the Village.
- (e) Any ordinance dedicating, naming, establishing, locating, relocating, opening, paving, widening, vacating, etc., any street or public way in the Village.
- (f) Any appropriation ordinances.
- (g) Any ordinance levying or imposing taxes.
- (h) Any ordinance establishing or prescribing grades in the Village.
- (i) Any ordinance providing for local improvements and assessing taxes therefor.
- (j) Any ordinance dedicating or accepting any plat or subdivision in the Village.
- (k) Any ordinance extending or contracting the boundaries of the Village.
- (1) Any ordinance prescribing the number, classification, or compensation of any village officers or employees not inconsistent herewith.
