Supervisor May opened with the Pledge of Allegiance; all were thanked for attending the meeting. [There were no questions or comments from the audience.]

Supervisor May introduced Lynne Conrad Swingle, she is the replacement for Mary Kehl. Mr. Suto explained to Ms. Swingle that we are not receiving information on what turbine will be worked on, when the cranes and big trucks are coming into Town, as they tend to dig up the roads at times and we would like to verify and check the roads before coming, during and after repair or maintenance.

Supervisor May discussed that she is working with our attorney and Chicago regarding community fund monies.

Cindy Goral discussed the trips and things that our planned with the Tri-Town Seniors. Bus prices have increased by 6% and restaurants are up by 1-3% cost from last year.

Supervisor May discussed with Mr. DiMatteo about looking at the decommissioning of the turbines. The Decommission Bond was completed 12 years ago, and it will cost about \$5,000 to hire an engineer to complete a review on the decommission bond that is in place.

There are 75,000 miles on the truck. The blue book for private individual is 27,900 – 30,000, with plow. The Board had a discussion on pros and cons of selling truck, at this time.
